Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Access Medical Acquisition, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

1. Plan Description

The following description of the Access Medical Acquisition, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2016 and is a defined contribution plan covering all eligible employees (as defined in the plan document) of Access Medical Acquisition, Inc. (the "Employer" or "Company"). An employee must be 21 years of age or older to participate in the Plan and have completed of 3 months or more of service. An employee is not eligible to participate in the Plan if they are: (1) included in a unit that is covered by a collective bargaining agreement; (2) a leased employee; or (3) a non-resident alien. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100% of their eligible annual compensation, in a pre-tax or Roth basis, as defined by the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from eligible compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution. For 2022, the discretionary matching contribution was 25% of a participant's elective deferrals that are not in excess of 6% of the participant's compensation as determined by the Plan Sponsor. The Company may also make non-elective discretionary contributions in an amount to be determined by the Company. Non-elective discretionary contributions, if any, will be allocated to participants' accounts in the ratio that eligible compensation bears to the total eligible compensation paid to all eligible participants that are employed on the last day of the year.

The Company may make discretionary non-elective contributions to the Plan. During the year ended December 31, 2023, the Company made a Qualified Nonelective Contribution ("QNEC") of \$90,074 to certain eligible participants to satisfy nondiscrimination testing requirements. QNECs are fully vested when contributed and are subject to the same distribution restrictions as elective deferrals.

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon.

Vesting (continued)

Vesting in the Employer's discretionary matching and non-elective discretionary contributions are based on years of continuous service with the Company as follows:

<u>Years of Service</u>	<u>Percentage</u>
Less than 2	0%
More than 2 but less than 3	20%
More than 3 but less than 4	40%
More than 4 but less than 5	60%
More than 5 but less than 6	80%
More than 6	100%

A participant is also 100% vested in Company contributions on the date a participant becomes disabled or on the date a participant dies.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loan plus interest is repaid through payroll deduction in equal payments over the term of the loan. The term of the loans is limited to five years unless it is used for the purchase of a participant's principal residence. Loan terms are limited to a period consistent with commercial home loan practices. The interest rate for the loan is comparable to the current interest rates charged by financial institutions for similar loans at the time of issuance. A participant may have no more than one outstanding loan from the Plan at any time. Upon termination of service, the principal balance and accrued interest shall be immediately due and payable.

Forfeitures

If a participant terminates employment and is less than 100% vested in their Employer contributions, the participant will forfeit the non-vested portion of their account. The Company can either use forfeited non-vested amounts to pay Plan expenses or to reduce Employer contributions. Forfeited non-vested accounts were \$25 and \$0 at December 31, 2023 and 2022. During 2023, \$6,090 of forfeitures were used to reduce administrative expenses and \$12,392 of forfeitures were used to reduce Employer contributions.

1. Plan Description (*continued*)

Payment of Benefits

Upon a participant's attainment of age 59 ½, termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the investment in the group annuity contract, which is valued at contract value. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, when a distributable event occurs.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan may be paid by the Company and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 6, 2026.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution.

5. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the "PFIGO") is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions, plus earnings, less participant withdrawals and administrative expenses.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant's account balances. The rate is reset on a semiannual basis.

5. Group Annuity Contract (*continued*)

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. An employer level liquidation or employer initiated transfer of the Plan's interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Employer chooses. Notification of a plan's intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the Employer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

6. Common/Collective Trusts

The Plan offers 12 common/collective trusts called the Principal LifeTime Hybrid Collective Investment Funds ("Funds"), which include: The Principal LifeTime Hybrid Inc. CIT Z85; the Principal LifeTime Hybrid 2015 CIT Z85; the Principal LifeTime Hybrid 2020 CIT Z85; the Principal LifeTime Hybrid 2025 CIT Z85; the Principal LifeTime Hybrid 2030 CIT Z85; the Principal LifeTime Hybrid 2035 CIT Z85; the Principal LifeTime Hybrid 2040 CIT Z85; the Principal LifeTime Hybrid 2045 CIT Z85; the Principal LifeTime Hybrid 2050 CIT Z85; the Principal LifeTime Hybrid 2055 CIT Z85; the Principal LifeTime Hybrid 2060 CIT Z85 and the Principal LifeTime Hybrid 2065 CIT Z85. The unit value of each of these Funds is determined on a daily basis. Units are issued and redeemed at their unit value and there are no restrictions on the withdrawals. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. There are no unfunded commitments.

7. Due to Plan Sponsor

During 2021, the Company over contributed \$9,057 to the Plan and is reflected as a Due to Plan Sponsor on the statements of net assets available for benefits as of December 31, 2022. During 2023, the amount was used to offset Company contributions.

8. Party-In-Interest Transactions

Certain investments of the Plan are managed by an affiliate of Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

9. Tax Status

The Company has adopted an approved volume submitter plan which received an IRS advisory opinion letter dated June 30, 2020, which indicated the form of the Plan satisfied the qualification requirements under Section 401(a) of the IRC. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

11. Prohibited Transactions

During the plan years 2020 through 2023, the Employer failed to remit to the Plan certain participants' contributions and loan repayments within the period prescribed by Department of Labor regulations. During 2023, pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and allocated to affected participants by the Employer for \$18,700 of the delinquent participants' contributions and loan repayments. For the remaining delinquent participants' contributions and loan repayments, lost earnings will be calculated and allocated to affected participants in the Plan by the Employer.

12. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
