Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Aluma-Weld, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended May 31, 2025 and 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial Statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to the Financial Statements
May 31, 2025 and 2024

(1) Description of the Plan

The Aluma-Weld, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) was established January 1, 1992.

The Plan is administered by Aluma-Weld, Inc. d/b/a Xpress Boats (the “Company”). Empower Annuity Insurance Company of America (the “Trustee”) served as trustee of the Plan for the years ended May 31, 2025 and 2024. The Trustee has been designated to hold and invest Plan assets for the benefit of the participants. The following is a description of the major provisions of the Plan.

General: The Plan is a defined contribution plan established by the Company under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company, who have completed three months of service, as defined by the Plan document, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Employee Contributions: Participants may elect to defer up to 50% of their annual compensation that does not exceed the dollar limit contained in Section 401(g) of the Internal Revenue Code. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the Internal Revenue Code.

Employer Contributions: The Company matches the first 3% of each participant’s salary reduction contribution at 100%. The Company matches the next 2% of each participant’s salary reduction contribution at 50%. Also, the Company may, at its discretion, make an employer profit sharing contribution to the Plan. Employees must have met the eligibility requirements to participate during the year to receive this contribution. In addition, the Company may, at its discretion, make a qualified non-elective contribution to the Plan. Employees are 100% vested in the qualified non-elective contribution.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and an allocation of Plan earnings or losses. Earnings or losses of the Plan are allocated based upon the percentage that each participant’s account for a particular investment option bears to the total of all participant accounts for that same investment option. Terminated participants’ non-vested account balances are used to reduce Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Automatic Enrollment and Automatic Increases: Employees who have not affirmatively elected to contribute, or not contribute, to the Plan are automatically enrolled at a contribution rate equal to 3% of compensation. Each year, in the absence of an alternative election, participant contributions will automatically increase annually by 1% up to a maximum rate of pre-tax or Roth contributions of 10% of compensation.

Vesting: Participants are always 100% vested in their salary deferral, employer matching, and employer qualified non-elective contributions plus earnings thereon. Vesting in the Company's profit sharing contributions is determined based on years of service under the following schedule. Participants are considered fully vested in all accounts upon retirement, death, or disability.

Investment Options: Participants are permitted to direct the Trustee as to the investment of all of the assets in their individual account balances in specific assets or other investments allowed under the Plan. Participants may request details of the investment options from the Plan Administrator. Participants can change their option elections prospectively at any time.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, an employee may elect to receive either a portion or total lump-sum amount equal to the value of his or her respective account, or rollover to another qualified plan. If the value of the vested account is more than \$5,000, the participant may elect to defer any payment before reaching normal retirement age. If the value of the vested account is less than \$5,000, a distribution of the vested balance will be either automatically rolled over to an Individual Retirement Account (for balances over \$1,000) or made directly to the participant as soon as administratively feasible. The Plan also allows various in-service distributions.

Forfeitures: The Plan may, at its discretion, use available forfeitures to reduce future employer contributions.

(2) **Summary of Significant Accounting Policies**

The following is a summary of the significant accounting policies used by the Plan in the preparation of the accompanying financial statements.

Basis of Accounting: The Plan prepares the financial statements on an Other Comprehensive Basis of Accounting (OCBOA). This OCBOA is a modified cash basis whereby additions and deductions to net assets available for benefits are recognized when received or paid for.

Valuation of Investments: Investments are reported at fair value. Fair value is the price received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Use of Estimates: The preparation of financial statements on a modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(3) **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan document to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participant account balances would become 100% vested.

(4) **Forfeited Accounts**

At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$9,734 and \$9,572, respectively. During 2025 and 2024, no forfeited non-vested accounts were used to reduce employer contributions.

(5) **Operating Expenses and Party-In-Interest Transactions**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. During the years ended May 31, 2025 and 2024, the Plan incurred and paid expenses totaling \$41,054 and \$35,464, respectively, to outside service providers for general administration, investment advisory, and record keeping services. Fees related to the administration of benefit payments are charged directly to the participant's account. Certain investment fund options are subject to investment-related

fees based on a percentage of invested assets, as disclosed in the applicable fund's prospectus and disclosed to participants through a participant disclosure notice. Such fees are charged directly against the fund's investment income and are not separately disclosed in the accompanying financial statements.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such employer or employer association, or relatives of such persons.

(6) Tax Status

The Plan obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan files an annual information return in the U.S. federal jurisdiction. The Plan is subject to U.S. tax examinations by tax authorities for three years after a return is filed. The Plan follows the provisions of FASB ASC 740, *Income Taxes*.

(7) Risk and Uncertainty

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(8) Information Certified by Trustee

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that was prepared by the Trustee and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee that such information is complete and accurate.

- Investments, at fair value and contract value
- Investment income
- Schedule of assets (held at year end)

(9) Fair Value Measurement

Under FASB ASC 820-10, three prioritized valuation inputs are used to determine the fair value at the measurement date: Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities; Level 2 – observable inputs other than the quoted prices included in Level 1; Level 3 – unobservable inputs. There have been no changes in the methodologies used during the periods under audit, therefore no recognition of gain or loss is required for these financial statements.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds are valued based on current market prices for identical assets.

Common/collective trust funds are valued based on their net asset value (NAV) reported by the investment advisor in the financial statements of the collective trust funds at year end. NAV is used as a practical expedient to estimate fair value.

(10) Collective Trust Funds

Certain investments measured at fair value using NAV per share practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the above tables are intended to permit reconciliation of the fair value of investments in the fair value hierarchy to the amounts presented in the statements of net assets available for benefits – modified cash basis. Participant transactions may occur daily. There were no unfunded commitments or relevant redemption restrictions on such investments held by the Plan for the years ended May 31, 2025 and 2024. The investment strategies for these funds are not presented as each fund files as a direct filing entity.

(11) Contract with Insurance Company

Effective December 15, 2021, the Plan entered into a fully benefit-responsive investment contract with Empower Life and Annuity Insurance Company (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The crediting interest rate is based on a formula established by the contract issuer but may not be less than 0%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (include complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.
