To Whom It May Concern:

This letter is submitted to provide a reasonable explanation for the late filing of Form 5500 for the above-referenced employee benefit plan.

The Plan Sponsor has a history of timely and accurate filings and takes its ERISA and IRS reporting obligations seriously. The delay in filing the Form 5500 for this plan year was not due to willful neglect but rather resulted from miscommunication with service providers, as explained below.

During the applicable filing period, the Plan Sponsor incorrectly believed that the plan's recordkeeper, Principal Financial Group, and its broker, 49 Financial, were filing the Form 5500 on Basesix's behalf.

Upon realization that the form had not been filed, the Plan Sponsor acted promptly and filed the Form 5500 as soon as practicable. At no time did the Plan Sponsor attempt to avoid its filing obligations, and there was no intent to delay or misreport plan information.

The Plan Sponsor respectfully requests that the IRS accept this explanation as reasonable cause for the late filing and grant relief from any penalties that may otherwise apply. Procedures have been reviewed and reinforced with service providers to help ensure timely filings going forward.
