Opinion

1. Description of the Plan

The following description of the International Alliance of Theatrical Stage Employees ("IATSE") Local Union #6 Health and Welfare Fund (the "Plan") provides only general information. Participants of the Plan should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer defined benefit health and welfare plan. The Plan was established and is maintained pursuant to a collective bargaining agreement ("CBA") between the IATSE Local Union #6 (the "Union") and participating employers (the "Employers") to provide medical, pharmacy, dental, long-term and short-term disability, vision, and life and accidental death and dismemberment benefits to eligible participants and their covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the "Trustees") and is governed by a joint board consisting of equal representation from the Employers and the Union.

Eligibility

Participants, and their eligible dependents, become eligible for benefits on September 1 following the immediately preceding twelve consecutive months, beginning June 1 and ending May 31, in which Employers have made the minimum amount of contributions to the Plan on their behalf as determined by the respective CBAs.

Generally, a participant will remain eligible if they are eligible for contributions from Employers to be made to the Plan on their behalf. Participants may also continue to remain eligible for certain benefits through the use of continuation coverage for times of unemployment and upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Retired employees are entitled to benefits if they are an eligible retired participant and had no break in continuous coverage. Once the eligibility requirements are met, certain eligible dependents are also covered under the Plan upon submission of the applicable enrollment form and supporting documents to the plan administrator.

Contributions

The Employers are required to make monthly contributions to the Plan as required by the applicable provisions of their respective CBAs for their Union employees. The Employers contribute a specified amount based upon a formula specified in the CBA. Participants or their dependents, under specified circumstances, are also allowed to make contributions to the Plan for a limited time to provide COBRA benefits.

The Plan has two levels of benefits, Plan A and Plan B. Participants become eligible for the benefits based on the amount of contributions made by Employers on the participants' behalf. Participants may be required to self-pay a portion of the premiums based on a formula determined by the Trustees.

Benefits

The Plan provides for medical, dental, pharmacy, short-term disability, long-term disability, vision, life, and accidental death and dismemberment benefits to eligible participants and beneficiaries. All of these benefits are provided under group insurance contracts. The premiums for all insured benefits are paid from assets of the Plan.

Retired employees are entitled to similar health benefits (in excess of Medicare coverage). Additionally, the Plan provides similar benefits during periods of unemployment, disability, or upon termination through COBRA.

Fund Management

Effective January 1, 2021, TIC International Corporation ("TIC"), an employee benefit fund management company, has been retained by the Trustees to administer the activities and operations of the Plan on a contractual basis, renewed annually. Under a management contract, all personnel costs and other normal administrative expenses related to bookkeeping and collection are borne by TIC. Administrative fees paid to TIC totaled \$63,000 and \$50,800 for the years ended May 31, 2025 and 2024, respectively.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared in accordance with the provisions of Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

Employer Contributions Receivable

Employer contributions receivable represent Employer contributions due to the Plan for hours worked prior to the end of the Plan year, but not yet received by the Plan's year-end. Employer contributions receivable are reported at their outstanding balances, net of an estimate made for credit losses. Management estimates the allowance for credit losses by regularly evaluating individual Employer receivables and considers the financial condition, payment history, current economic conditions and management's expectations of conditions in the future. Employer contributions receivable are written off when deemed uncollectible. Management is of the opinion that no allowance is necessary as of May 31, 2025 and 2024.

Benefit Obligations

Benefit obligations include amounts currently payable to or for participants, beneficiaries, and dependents, postemployment benefits, and other obligations for current benefit coverage. Amounts currently payable to or for participants, beneficiaries, and dependents represent insurance premiums for the three months ending August 31, 2025 and 2024 in which currently active participants are eligible for coverage. Postemployment benefit obligations are at estimated amounts and represent the estimated obligations of the Plan for the subsequent one-year periods ending August 31, 2026 and 2025, in which participants that have met the eligibility threshold at May 31, 2025 and 2024 are eligible for benefits, as well as premiums for the one-year periods ending May 31, 2026 and 2025, in which the Plan will reimburse retirees 50% of their Medicare Supplement premium.

Payment of Benefits

Premiums paid are recorded in the accompanying statements of changes in net assets available for benefits. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Administrative Expenses

The Plan permits the payment of Plan expenses from Plan assets.

Reclassifications

Certain amounts in the 2024 financial statements have been reclassified to conform to the current year presentation.

Subsequent Events

Management has evaluated subsequent events through March 4, 2026, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical instruments in active markets.
Level 2	Inputs to the valuation methodology to include quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the instrument, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The instruments' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for instruments measured at fair value.

Level 1 investments consist of money market funds, common stock, and U.S. treasury obligations. Money market funds are valued at cost plus accrued interest, which approximates fair value. Common stocks and U.S. treasury obligations are valued at the closing price reported on the active market on which the individual securities are traded.

4. Plan Amendments

In February 2024, the Trustees approved an amendment to the Plan to add a third Union and Employer Trustee.

In March 2025, the Trustees approved an updated 2025 summary plan description and Plan Document.

In March 2025, the Trustees approved the first amendment to the 2025 plan document which updated life insurance and accidental death coverage.

5. Related Party Transactions

The IATSE Local 6 Profit Sharing Plan (the "Profit Sharing Plan") collects Employer contributions on behalf of the Plan. As of May 31, 2025 and 2024, \$24,615 and \$185,184, respectively, was due from the Profit Sharing Plan for the Plan's share of Employer contributions received by the Profit Sharing Plan prior to the end of the Plan year, but not yet remitted to the Plan by year-end.

As of May 31, 2025 and 2024, \$15,891 and \$18,811, respectively, was due to the Profit Sharing Plan for reimbursement of incorrect transfers remitted.

6. Plan Termination

Although they have not expressed any intent to do so, the Trustees have the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, any assets remaining shall be used solely for purposes of providing benefits and defraying the reasonable cost of administering the Plan. No assets shall revert to the Employers.

7. Tax Status of Fund

The Internal Revenue Service has determined and informed the Trustees by a letter dated October 11, 1972, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. Management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

In accordance with GAAP, management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of May 31, 2025 and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. Management believes the Plan is no longer subject to income tax examinations for years prior to 2021. The Plan is also subject to routine audits by the Department of Labor, generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

Employer Contributions Receivable

The majority of receivables are from Employers concentrated in the theatrical industries. The Plan does not require collateral, but in some cases can require a performance bond.

Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
