INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Management of
SimCom Inc. 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SimCom Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 14, 2025 (in liquidation) and December 31, 2024 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to August 14, 2025 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 14, 2025 and December 31, 2024 and for the period from January 1, 2025 to August 14, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Basis of Accounting

As further discussed in Note 1 to the financial statements, in connection with the sale of the majority of its shares, the Board of Directors of SimCom, Inc., the Plan sponsor, voted to terminate the plan effective November 4, 2024. In accordance with the accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which the investments and net assets available for benefits information are stated, from the going concern basis to the liquidation basis for periods after November 4, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the liquidation basis of accounting described in Note 2, for determining that the liquidation basis of accounting is an acceptable basis for the preparation of the financial statements, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the SimCom Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all full-time employees of SimCom, Inc. and SimCom International, Inc. (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan termination: In November 2024, the shareholders of the Company entered into an agreement to sell the majority of their shares to an unrelated entity. As a result, on November 4, 2024, the Board of Directors voted to terminate the Plan. The participants became 100% vested in their accounts at that time, and the Company instructed the Trustee to distribute the remaining assets of the Plan as directed by the participants. All Plan assets were distributed during the period from January 1, 2025 through August 14, 2025.

Participant accounts: Each participant's account was credited with the participant's contribution and an allocation of (a) the Company's discretionary matching contributions, and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations were based on participant compensation or account balances as defined. The benefit to which a participant was entitled was the benefit that could be drawn from the participant's vested account.

Participant notes receivable: The Plan allowed participants to obtain loans from the Plan prior to the Plan termination on November 4, 2024. These loans were subject to the following general provisions: the maximum amount of loans outstanding was equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The term of any loan could not exceed five years unless the purpose of the loan was to purchase the participant's primary residence, and the loans were secured by the participant's account and bear interest at a rate equal to the prime rate (7.50% at December 31, 2024) at the beginning of each month plus 2%. Principal and interest were paid ratably through payroll deductions.

If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the plan document.

Payment of benefits: Upon termination of the Plan, all Plan participants became immediately vested in the Plan and the benefit to which they are entitled is equal to the balance in their account. A participant could elect to receive a total distribution of the participant's account balance as a lump-sum cash distribution, an eligible rollover to a qualified account, or a combination of a lump-sum cash distribution and an eligible rollover.

Forfeited accounts: Forfeitures of non-vested accounts were to be used to reduce future employer matching contributions or for payment of plan administrative expenses. At August 14, 2025 and December 31, 2024, forfeited non-vested accounts totaled \$0 and \$10,516 respectively. During 2025, the Plan paid fees of \$10,516 from forfeited accounts in 2025.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation: As a result of the termination of the Plan on November 4, 2024, the Plan's financial statements are presented using the liquidation basis of accounting.

Use of estimates: The preparation of the accompanying financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Participant notes receivable: Participant notes receivable were recorded at their unpaid principal balance plus any accrued but unpaid interest.

Investment valuation and income recognition: Investments were reported at liquidation value which approximates fair value. Fair value approximates the amount the Plan expects to collect at liquidation. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of investments, including gains or losses, were recorded on a trade-date basis. Interest income was recorded when earned, and dividends were recorded on the ex-dividend date. Capital gain distributions were included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Benefit payments: Benefit payments to participants were recorded when paid.

Administrative expenses: Substantially all administrative expenses are paid by the Plan, unless otherwise paid for by the Company, and are included in the statement of changes in net assets available for benefits.

Subsequent events: In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through March 9, 2026, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

1. Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively-traded.
2. Self-directed brokerage accounts: Accounts primarily consist of cash, mutual funds, and common stocks that are valued on the basis of readily determinable market prices.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

There were no Level 3 assets and no transfers between Levels 1 and 2 in 2024.

NOTE 4 – INCOME TAX STATUS

The trust established under the Plan, which held the Plan's assets, was qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income was exempt from income taxes. The Plan adopted an Internal Revenue Service pre-approved plan. The pre-approved plan received a favorable opinion letter from the IRS that it qualified under IRS Code section 401(a), provided all terms of the Plan were followed. The Plan was amended since adopting the pre-approved plan. However, the plan administrator believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the related trust was tax exempt. Therefore, no provision for income taxes was included in the Plan's financial statements.

NOTE 5 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator elected to restrict the scope of the auditors' examination with regard to the statements or information prepared and certified by Fidelity Management Trust Company. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Fidelity Management Trust Company, the trustee:

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan issued notes receivable to participants, which were secured by the balances in the participants' accounts. These transactions qualified as party-in-interest transactions.

Certain Plan investments were shares of mutual funds issued/managed by Fidelity Investments and related entities. Fidelity Management Trust Company, the trustee of the Plan, is a related entity, therefore, these transactions qualify as party-in-interest transactions. Usual and customary fees were paid by the mutual funds for the investment management services in 2025.
