### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ProBerco 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

#### NOTE 1 - DESCRIPTION OF THE PLAN

---

The following description of the Prospectus Associates, Inc. dba ProBerco 401(k) Plan effective as of April 14, 2025 (formerly named Prospectus/Berco 401(k) Plan) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan covering all full-time employees of Prospectus Associates, Inc. dba ProBerco (the “Company”). Employees are eligible to make elective deferrals who have been employed for 90 days and are eligible to receive the employer matching contributions who have been employed for at least one year and have 500 hours of credited service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrators are responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

##### **Contributions**

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan and limited by law. Participants may also contribute to the Roth option of the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company will match 50% of the first 8% of each participant’s elective deferral up to a maximum of 4% of compensation. During the years ended June 30, 2025 and 2024, the Company made matching contributions of \$341,856 and \$289,982, respectively. The Company may also make a discretionary profit sharing contribution at the option of the board of directors. The Company did not declare a discretionary profit sharing contribution for the year ended June 30, 2025. The prior year profit sharing receivable of \$500,000 was allocated to participants during the plan year ended June 30, 2025. The Plan was amended effective July 1, 2024 that participants must be employed on the last day of the Plan year and have completed 500 hours of service during the Plan year in order to receive an allocation of the discretionary profit sharing contribution (there was no year-end employment requirement for the plan year ending June 30, 2024). Participants who have been terminated due to death, disability, or retirement shall be eligible to share in the allocation regardless of hours of service or year-end employment. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, if applicable, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of continuous service. A participant is 100% vested in the Company match and profit sharing contributions after four years of credited service. Participants become 100% vested in all amounts upon death, disability, or retirement.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may receive their account balance in a lump-sum payment or partial installment withdrawals. Early retirement is permitted at the age of 60 years with 10 years of credited service. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account in the methods listed above. If a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it is made. The Plan provides that if a participant's vested account balance does not exceed \$5,000, a distribution of the vested account will be made to the participant as soon as administratively feasible following termination of employment. If the amount of the distribution exceeds \$1,000, and the participant does not elect to receive or roll the distribution, the distribution will be rolled directly over to an IRA.

Hardship distributions are permitted from a participant's fully vested elective deferral accounts, accounts attributable to employer matching contributions, and accounts attributable to employer nonelective contributions. In-service distributions are also permitted for participants from all contribution accounts that are fully vested if a participant has attained age 59 ½ or has incurred a disability.

##### **Forfeited Accounts**

At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$0 and \$73, respectively. Forfeitures may be used to pay plan administrative expenses or reduce any nonelective contribution or matching contribution. During the year ended June 30, 2025, forfeitures totaling \$7,501 were used to reduce other employer contributions.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

---

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrators determine the Plan's valuation policies utilizing information provided by the investment adviser, insurance company and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, as the Guaranteed Portfolio Fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Since the Plan cannot withdraw money until maturity, the contract is not considered fully benefit-responsive in accordance with Accounting Standards Codification (ASC) Topic 960-325. The contract is therefore considered non benefit-responsive and is included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

##### **Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. The discretionary profit sharing contribution is funded subsequent to the year end.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

##### **Subsequent Events**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through March 3, 2026, the date the financial statements were available to be issued. As of July 1, 2025, the Company changed custodian and trustee services of the Plan to Lincoln Financial Group Trust Company. As a result, plan assets were transferred from Empower Trust Company, LLC into Lincoln Financial Group Trust Company. Also, the plan was restated effective August 1, 2025.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets and liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investment contract with insurance company:* Valued at fair value using a discounted cash flow valuation methodology where the interest rate for the portfolio investment contract is reset at least as frequently as annually.

#### **NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

---

The Plan has a non-benefit-responsive investment contract with Empower Annuity Insurance Company of America, which maintains contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of these investments at contract value. Certain events limit the ability of the Plan to transact at contract value with the issuer, including: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

#### **NOTE 5 - PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE 6 - TAX STATUS**

---

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Empower Retirement LLC. The non-standardized pre-approved profit sharing plan received an opinion letter on November 14, 2022 that the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 7 - CERTIFIED INVESTMENTS

---

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at June 30, 2025 and 2024, and net appreciation in fair value of investments, and interest and dividends for the year ended June 30, 2025, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (qualified institutions).

#### NOTE 8 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

---

Recordkeeping services are performed and certain plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustee. Therefore, these transactions qualify as party-in-interest transactions. All other transactions which may be considered related party or parties-in-interest transactions relate to normal plan management and administrative services.

#### NOTE 9 - RISKS AND UNCERTAINTIES

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 10 - TRANSFER OF INVESTMENTS

---

For the year ended June 30, 2025, the Plan initiated a transfer of certain investment assets from Empower Trust Company, LLC, to Lincoln Financial Group Trust Company in the amount of \$11,116,694. Empower Trust Company, LLC released the assets prior to the Plan's year end; however, Lincoln Financial Group Trust Company did not record receipt of those assets until after year end due to normal processing and settlement timing.

As of June 30, 2025, the assets that had been transferred out of the Empower Trust Company, LLC but not yet recorded by Lincoln Financial Group Trust Company are reported as *"Receivable - Transfer of Investments"* in the accompanying statements of net assets available for benefits. The receivable is recorded at the fair value of the related investments as of the transfer date, consistent with the Plan's valuation policies and the fair value hierarchy described in Note 3.

**NOTE 10 - TRANSFER OF INVESTMENTS - CONTINUED**

---

The transfer fully settled subsequent to year end when Lincoln Financial Group Trust Company recorded the assets. No gain or loss is recognized related to the transfer other than changes in the fair value of the underlying investments, which continue to be reflected in net appreciation in fair value of investments.

**NOTE 11 - OTHER EMPLOYER CONTRIBUTIONS**

---

The Plan had an operational error related to participant vested percents and the resulting calculated forfeited amounts. There were discrepancies between vesting provisions of the plan document and forfeitures that were computed by the Plan's third party administrator. The Plan underwent self-correction procedures and as a result, recorded \$19,466 of other employer contributions as of June 30, 2025.
