INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
UA Local 190 Scholarship Plan
Ann Arbor, Michigan

Opinion

We have audited the accompanying financial statements of UA Local 190 Scholarship Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of UA Local 190 Scholarship Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UA Local 190 Scholarship Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UA Local 190 Scholarship Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the UA Local 190 Scholarship Plan (the Plan) provides general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan is intended to provide for the secondary education of children, grandchildren, and dependents of members and employees of the Union employed under the terms of the collective bargaining agreement with the various Associations (Employers). The Plan was formed under an agreement between the Greater Michigan Plumbing and Mechanical Contractors Association, Inc. (Mechanical Association), the Michigan Distribution Contractor's Association (Michigan Distribution Association) and the UA Local 190 Plumbers/Pipefitters/Service Technicians/Gas Distribution of the United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada (the Union). Effective January 1, 2011, the Distribution Association merged into the Michigan Infrastructure and Transportation Association, Inc. (Distribution Association). Effective May 1, 2012, the Distribution Association has no relationship with the Plan and certain members are entitled to contributions under the National Distribution Agreement in the State of Michigan or under the National Distribution Agreement in the State of Ohio.

Contributions and Benefits

Employers contribute to the Plan at the rates specified in the current collective bargaining agreement. Additional voluntary contributions may be received from employers, members, and the Union. In addition, contributions may be received from other terminating benefit plans of the Union. Scholarship benefits are awarded by a Committee appointed by the Trustees, in accordance with criteria and procedures established by the Trustees. Total grants may not exceed the amount authorized by the Trustees in any year.

Changes in Benefits

The Plan's board of trustees, as Sponsor, has the right under the Plan to modify the benefits provided under the Plan.

Plan Termination

If the Plan is terminated, the remaining assets shall be distributed in the form of continuing grants to eligible recipients.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses.

Employer Contributions and Contributions Receivable

Employer contributions and contributions receivable are based on amounts collected. Due to doubts about collectability, delinquent contributions and related liquidated damages are not recognized until collected.

Valuation of Investments

Investments are reported at fair value. Fair value is an estimate of the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Investments* note for discussion of fair value measurements.

Benefit Obligations

No benefits payments are required beyond that which are authorized by the Trustees in any year, except that the distributions of income shall always be sufficient to avoid tax on undistributed income under Section 4942 of the IRC. There were no approved but unpaid benefits at May 31, 2025 and 2024.

Subsequent Events

The Plan has evaluated subsequent events through March 2, 2026, the date the financial statements were available to be issued.

NOTE C - TAX STATUS

The Plan is intended to qualify as a “voluntary employee beneficiary association” under Internal Revenue Code (IRC) Section 501(c)(9). Voluntary contributions qualify for income tax deduction permitted by IRC Section 170 for educational organizations qualified under IRC Section 501(c)(3). The Plan has received a favorable tax determination letter dated August 31, 2006 from the Internal Revenue Service. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE D - INVESTMENTS

The Plan's investments consist of a money market mutual fund and an interest-bearing checking account.

Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The money market mutual fund is valued at the closing price reported in the active market in which the individual securities are traded and is considered a Level 1 asset.

The interest-bearing checking account is valued at cost, which approximates fair value, and is not classified in the fair value hierarchy.

NOTE E - RISKS AND UNCERTAINTIES

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and could materially affect the amounts reported in the statement of net assets available for benefits. The Plan’s investments are not covered by FDIC insurance.
