Note 1: The Plan and its significant accounting policies:

The following description of The Chronicle of Higher Education Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established in 1978 by The Chronicle of Higher Education, Inc. (the Company) to provide benefits to eligible employees. The Plan was amended on November 1, 2002 to adopt an IRC Section 401(k) provision, which allows participants to defer a portion of their salaries to the Plan, and provides for a fixed Company contribution of 3% of each eligible employee's salary. The Plan covers all employees of the Company who are 21 years of age or older, with the exception of interns and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Administration - Under the terms of the Plan, T. Rowe Price Trust Company acts as trustee, record keeper, and custodian. Substantially all expenses incurred for administering the Plan, excluding management time, are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the initiation and administration of loans are charged directly to the participants' accounts and are included in administrative expenses. Effective March 2019, quarterly recordkeeping fees per participant are charged to most participants' accounts and are included in administrative expenses. The quarterly recordkeeping fees were \$28 per participant through December 31, 2020. Effective January 1, 2021, these fees were reduced to \$25 per participant. Effective July 1, 2023, these fees were again reduced to \$22.25 per participant. The Company pays the recordkeeping fees for employee participants whose account balances are less than \$5,000.

Investment valuation and income recognition - Investments of the Plan are held by T. Rowe Price Trust Company and invested based solely upon instructions received from participants. Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment valuation and income recognition (continued) - The Plan is invested in a Stable Value Fund. This fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value, as reported to the Plan by T. Rowe Price Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2025 and 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. As of October 31, 2025 and 2024, the Plan administrator believes all notes receivable from participants are collectible.

Payment of benefits - Benefits are recorded when paid.

Income taxes - The Internal Revenue Service had determined and informed the Company by a letter dated October 1, 2003, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Effective November 1, 2015, January 1, 2021, and December 28, 2022, the Plan was restated by adopting a volume-submitter Plan sponsored by T. Rowe Price Trust Company. The provisions of the Plan remained substantially unchanged after each restatement. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, currency fluctuation, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have decreased in value since October 31, 2025 due to normal market fluctuations.

Adoption of a new accounting policy - On November 1, 2024, the Plan adopted ASU 2016-13 Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, total net assets available for benefits and change in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze their financial assets for expected credit loss under this new standard.

Note 2: Participation and benefits:

Participant contributions - Participants may elect to have the Company contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Effective November 1, 2018, the Plan implemented an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Effective December 28, 2022, participants may also elect to make Roth elective deferrals. Roth elective deferrals are made after taxes have been withheld. Participants may contribute a combination of pre-tax elective deferrals and Roth elective deferrals. Participants who have attained age 50 during a calendar year are eligible to make catch-up contributions during that calendar year. Effective August 27, 2025, participants who are ages 60 to 63 are eligible to make additional catch-up contributions during those calendar years. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions - The Company provides a quarterly safe harbor fixed contribution of 3% of each participant's eligible earnings. During the year ended October 31, 2025, the Company suspended this safe harbor contribution for the third and fourth quarters, however the Company intends to resume this safe harbor contribution beginning in the first quarter of the Plan year ending October 31, 2026. In addition, each year the Company may contribute to the Plan a discretionary amount as determined by the Company's Board of Directors. Employees are eligible for this contribution if they have completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year or have terminated employment during the year due to death, retirement, or permanent disability. The Company did not make a discretionary contribution for the years ended October 31, 2025 and 2024.

Participant accounts - Each participant's account is credited with the participant's contributions, Plan earnings or losses, administrative expenses, an allocation of the Company's contributions, and forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral, rollover contributions, safe harbor contributions and related earnings. Participants are vested in their discretionary profit sharing contributions based on years of continuous service. Prior to November 1, 2007, a participant became 10% vested for every year up to the fourth year of credited service, as defined, and continued to vest at the rate of 20% for each successive year of service until 100% vested after seven years of service. Effective November 1, 2007, participants become 10% vested after one year, 20% vested after two years and then continue to vest at a rate of 20% for each successive year of service until 100% vested after six years of service. Participants who had terminated prior to November 1, 2007 are still under the seven year vesting schedule.

Forfeited accounts - Funds forfeited by former participants may be used to reduce employer contributions, to restore the accounts of returning or previously unlocated participants, and to pay reasonable Plan administrative expenses. For the years ended October 31, 2025 and 2024, the Plan used forfeitures totaling \$-0- and \$16,000, respectively, for one or more of the reasons listed above. At October 31, 2025 and 2024, forfeited nonvested accounts totaled \$14,451 and \$19,416, respectively.

Payment of benefits - Upon termination, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account, or monthly, quarterly, semiannual or annual installments. The Plan allows for an automatic lump sum distribution of participant vested account balances which do not exceed \$5,000.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to 50 percent of their vested account balance not to exceed \$50,000. Loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus two percent at the date of the loan and must be repaid within a five-year period, unless the loan is used for the purchase of a primary residence. The specific terms and conditions of such loans are established by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Note 3: Certified information:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at October 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends for the years ended October 31, 2025 and 2024, was obtained and derived from information supplied to the Plan Administrator and certified as complete and accurate by T. Rowe Price Trust Company, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. In addition, the information in the Form 5500 Supplemental Attachment to Schedule H has been certified by T. Rowe Price Trust Company as of October 31, 2025.

Note 4: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at October 31, 2025 and 2024.

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Related party transactions and party in interest transactions:

Certain Plan investments are shares of mutual funds managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the custodian, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in administrative expenses on the statements of changes in net assets available for benefits. Additionally, the Plan issues loans to participants, which are secured by the participants' accounts. These transactions are considered party in interest transactions.

Note 6: Reconciliation of financial statements to Schedule H of Form 5500:

The differences between the information reported in the financial statements and the information reported in the Form 5500 are due to classification differences in investment income for the year ended October 31, 2025.

Note 7: Plan termination and/or modification:

The Company intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and assets would be distributed in accordance with the Plan's provisions.

Note 8: Other income:

Effective March 2019, credits from underlying investments are posted directly to participants' accounts, as are quarterly recordkeeping fees. The amount of excess fee credits paid by T. Rowe Price Trust Company to the Plan totaled \$125,643 and \$137,615 for the years ended October 31, 2025 and 2024, respectively.

Stale dated distribution checks totaling \$1,222 and \$1,175 were deposited into the Plan during the years ended October 31, 2025 and 2024, respectively.

Corrective payments funded by T. Rowe Price Trust Company to the Plan for missed earnings associated with the fee leveling reallocation totaled \$1,467 and \$-0- during the years ended October 31, 2025 and 2024, respectively.

Note 9: Subsequent events:

Subsequent events have been evaluated through February 20, 2026, which is the date the financial statements were available to be issued.
