We have performed an audit of the accompanying financial statements of Spider Company Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of May 31, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Spider Company Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTES TO THE FINANCIAL STATEMENTS

Note A - Description of the Plan

The following description of the Spider Company Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established effective June 1, 2020, as a defined contribution plan for the benefit of eligible employees of Spider Company Inc. (collectively the “Company”). The Plan is subject to the provisions of the Employee Income Security Act of 1974 (“ERISA”).

Administration

Voya Financial has been appointed custodian of the plan (the “custodian”) and administrator of the Plan.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after six (6) months of service. The entry date of the Plan for eligible participants is the first day of the month coinciding with or next following date requirements are met.

Contributions

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation as set forth in Section 402(g) of the Internal Revenue Code (“IRC”). Participants may make after-tax Roth contributions. Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax catch-up contributions that exceed the annual elective deferral limit. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

January 1, 2024, the Plan included an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Matching amounts may also be contributed at the discretion of the Plan Sponsor.

The Company may contribute a discretionary matching contribution. For the Plan years ended in 2025 and 2024, the Company made discretionary matching contributions of \$168,920 and \$157,229, respectively.

Note A - Description of the Plan, continued

The Plan also provides for discretionary Company profit sharing contributions. During 2025 and 2024, the Company did not discretionary employer profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Company's contributions into various investments offered by the Plan.

Vesting

Participants are vested immediately in their elective contributions and rollover contributions plus any earnings on such contributions. The vesting of discretionary Company contributions plus any earnings thereon is based on years of continuous service (as defined) accrued by the participant while in covered employment. Participants become 100% vested on a six-year graded vesting schedule.

Notes Receivable from Participants

Participants may borrow from their accounts on a pro-rata basis from all contribution sources a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms must not exceed five (5) years unless the loan is to be used in the financing of the participant's homestead in which case the loan may be payable in terms of similar length provided by conventional lending institutions. The loans are secured by the vested balance in the participant's account and bear interest rates ranging from 4.25% to 9.50%. Principal and interest payments are made by means of payroll withholdings according to the terms of the promissory note. A participant may have only one loan outstanding at any time.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Payment of Benefits

Upon termination of employment due to death, disability, attainment of age 59 ½ or retirement a participant (or his/her designated beneficiary in the event of death) may elect to receive a lump-sum amount. For termination of employment due to other reasons, the vested interest in his or her account may be

Note A - Description of the Plan, continued

distributed as rollover to another plan, a lump-sum distribution or it may be left in the Plan if the account balance is greater than \$5,000.

Forfeited Accounts

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to first reduce the Company's contributions and then to offset future employer contributions. As of May 31, 2025, there was \$1,549 in forfeitures not yet reallocated.

Administrative Expenses

In 2025 the plan was primarily responsible for payment of fees. Such expenses paid by the participants during the year ended May 31, 2025, were approximately \$12,952.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides various investment options. These investment options are exposed to market risk, which generally means the risk of loss in value to certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

Investments are stated at fair value, which is determined using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Investments in money market funds are valued at amortized cost, which approximates fair value. Net appreciation

Note B - Summary of Significant Accounting Policies, continued

(depreciation) in fair value of investments includes realized gains and losses on investments bought and sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

The Plan offers investments in pooled separate accounts, mutual funds, and guaranteed investments contracts (GIC's). Mutual funds are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Pooled separate accounts are valued at net asset value as a practical expedient. The net asset value is based on the fair value of the underlying assets owned by the fund. This practical expedient would not be used if it was determined to be probable that the fund would sell the investment for an amount different from reported net asset value.

The guaranteed investment contract is equal to participant deposits minus participant withdrawals plus credited interest. Interest credited is net of expenses. Contract value may be subject to market value adjustments in connection with contract holder directed withdrawals or under limited circumstances for certain in-service participant withdrawals. See Note C for a discussion of investments in fully-benefit responsive investment contracts.

Subsequent Events

The Plan has evaluated subsequent events through March 5, 2026, the date on which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

Contributions

Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant accounts.

Note C - Guaranteed Investment Contract with Voya Insurance

On May 31, 2025, the Plan had a traditional fully benefit-responsive guaranteed investment contract ("GIC"), that invests in traditional investment contracts, in the amount of \$47,914, with Voya Insurance ("Voya"). The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the Plan's ability to transact at contract value with Voya including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the

Note C - Guaranteed Investment Contract with Voya Insurance, continued

issuer are probable of occurring. The GIC does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Note D - Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on May 31, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

Pooled separate accounts: Valued at net asset value as a practical expedient. The net asset value is based on the fair value of the underlying assets owned by the fund. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from reported net asset value.

Note F – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note G– Tax Status

The IRS has determined and informed the custodian that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in

compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H – Party-in-Interest Transactions

The plan invests in participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments are funds managed by the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative fees related to the related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

Note I – Benefit Claims Payable

On May 31, 2025, there were no benefits for distributions to participants who requested a distribution from the Plan prior to the end of the Plan year.

Note J– Recent Accounting Pronouncements
