INDEPENDENT AUDITORS' REPORT

To the Jesuit High School Retirement Plan Trustees
and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Jesuit High School Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jesuit High School Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025 stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Jesuit High School Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jesuit High School Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that audits conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Jesuit High School Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is 401(a) noncontributory defined contribution pension plan covering all employees of Jesuit High School of Tampa, Inc. (the "School") who have attained 20.5 years of age and \$1,000 hours of service.

The Plan was effective July 1, 1989. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

2. Contributions

All employees who become participants in the Plan are eligible to receive employer contributions.

Employees become eligible in the month they gain full time employment with the School. The School contributes 7% of each participant's base salary.

No employee contributions are made to the Plan, and the Plan does allow for eligible participant rollover contributions.

3. Participant Accounts

Each participant elects various investment alternatives as provided by the Trustees and his/her account is credited with an allocation of the School's contribution plus Plan earnings.

Plan earnings are allocated by the Plan custodian based on the investment contained in each participant's account.

4. Vesting

Participants are fully vested in the employer contributions upon the first month of full-time employment.

5. Payment of Benefits

A participant who retires or becomes disabled will be paid the benefit to which they are entitled, in one lump sum, unless installment payments are elected. If the participant is deceased, their beneficiaries will be paid the entitled benefits in one lump sum, unless installment payments are elected. Benefits are recorded when paid.

NOTE A - DESCRIPTION OF THE PLAN - Continued

6. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Participant Distributions

No Plan participants have elected to have distributions as of June 30, 2025 that have not had their vested balances paid to them by year end.

8. Forfeitures

No amounts were forfeited during the Plan for the year ended June 30, 2025.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Investment Valuation and Income Recognition

Investments are reported at fair value. Units of insurance company general accounts are valued by the insurance company at deposits, plus credited interest, less withdrawals. Pooled separate accounts are valued at the per unit of the pooled assets divided by the number of units. Mutual funds are valued at quoted market prices at net asset value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statement of Changes in Net Assets Available for Benefits, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Plan Expenses

The employer incurs substantially all administrative expenses related to the Plan.

4. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosure. Actual results could differ from those estimates.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan adheres to the provisions of Financial Accounting Standards Board, *Accounting Standards Codification Topic 820* ("FASB ASC 820"). FASB ASC 820 establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement), a middle priority to quoted prices for similar assets or liabilities (level 2 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at June 30, 2025:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices and are considered Level 1.

Pooled separate accounts: Valued at the net asset value ("NAV") of units held by the Plan at year end. Investments in certain restricted mutual funds are valued at quoted market prices of the issuer and are considered Level 2.

Guaranteed interest accounts: Valued at contribution and transfers to the guaranteed interest accounts, plus interest, minus withdrawals, transfers out and deducted administrative fees and are considered Level 3.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified, pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax opinion letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and operate as designed. The Plan has not taken any tax positions that are subject to a significant degree of uncertainty. The plan administrator believes the Plan is no longer subject to income tax examination for the years prior to June 30, 2022.

NOTE F - INVESTMENT OPTIONS

A participant may direct all contributions in several investment options. See page 16.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amount reported in the Statement of Net Assets Available for Benefits.

NOTE H - ADMINISTRATION OF PLAN ASSETS / PARTY-IN-INTEREST TRANSACTIONS

TIAA-CREF holds the Plan's assets. As Plan custodian, TIAA-CREF provides recordkeeping for the Plan. TIAA-CREF invests cash received, interest and dividend income, and makes distributions to participants. Officers or employees of the School also perform administrative functions. No officer or employee received compensation from the Plan.

NOTE I - SUBSEQUENT EVENTS

The Plan's management has evaluated events and transactions occurring subsequent to June 30, 2025 as of February 27, 2026, which is the date the financial statements were available to be issued.
