1. Plan Description

The following description of the Cast-Crete USA LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Cast-Crete USA LLC (the "Company") who have completed ninety days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The original effective date of the Plan was June 1, 1997, with updates and amendments made through July 11, 2023.
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed ninety days of service. Once an eligible employee has satisfied the eligibility requirements the employee will become a participant in the Plan on the first day of the month after the requirements are met.
- c) *Employee Contributions* – Each year participants may contribute up to the maximum amount allowed by law, as defined by the Plan, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans. The Plan does not include an automatic deferral feature.
- d) *Employer Contributions* – Each pay period, the Company contributes a Safe Harbor Matching contribution of 100% on the first 3% of salary deferrals, and 50% on the next 2% of salary deferrals. The company may make an additional discretionary Match on up to 6% of participant contributions, with a maximum match of 4%. The company may also make a discretionary Profit Sharing contribution at the end of the year, which is available for participants that have been credited with 1,000 hours of service during the Plan year, and were employed at the end of the year. No discretionary contributions were made during 2024.
- e) *Investment Options* – Participants direct the investment of their contributions and the Company's contribution into various investment options offered by

the Plan. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

- f) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

- g) *Vesting* – Participants are vested immediately in their voluntary contributions and Safe Harbor contributions, plus earnings thereon. Employer Matching and Profit Sharing contributions are subject to a three year cliff schedule; participants become 100% vested after three years or upon the events of death, disability, or attaining age 65. The non-vested balance is forfeited upon termination of service.

- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested *accumulated* value of their account in a lump sum distribution or installment payment sufficient to satisfy required minimum distributions (RMD).

In-service withdrawals are allowed for those who have reached age 59 ½ or have experienced financial hardship. In-service withdrawals may only be taken from accounts that have 100% vesting.

- i) *Forfeited Accounts* – For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,927 and \$8,715, respectively. Forfeitures may be used to reduce future employer contributions or to pay Plan expenses. During 2024, no forfeitures were used to reduce future employer contributions or to pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions from 2023 to the applicable participants on May 13, 2025.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

3. Subsequent Events

The Plan has evaluated subsequent events through February 18, 2026 the date the financial statements were available to be issued.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts – Investments in participation units held in pooled separate accounts through John Hancock Life Insurance Company. The underlying securities in pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. These pooled separate accounts are classified in Level 2 in the fair value hierarchy.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Related Party Transactions and Party in Interest Transactions

During the year, Plan investments were managed by John Hancock Life Insurance Company. John Hancock provided administrative services to the Plan and also serves as the Plan's custodian, therefore qualifies as a party-in-interest to the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Ascensus LLC ("FuturePlan"). FuturePlan obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
