Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Standing Rock Community Grant School 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

(1) Nature of Business and Summary of Significant Accounting Policies

Nature of Business of Plan Sponsor

Standing Rock Community Grant School (the School) and Plan Sponsor operates an elementary and secondary school in Fort Yates, North Dakota.

Method of Accounting

The financial statements of the Standing Rock Community Grant School 401(k) Plan (the Plan) are prepared using the accrual method of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrators to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value on a recurring basis, as determined by Bravera Wealth, a chartered trust company (the Trustee) (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Net Change in Fair Value of Investments

The net appreciation in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

(1) Nature of Business and Summary of Significant Accounting Policies

Subsequent Events

Subsequent events have been evaluated through February 27, 2026, the date which the financial statements were available to be issued.

(2) Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all regular employees of the School. The Plan and the trust of which it is a part, are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

There is no minimum age requirement. Employees who have completed one hour of service are eligible for the Plan. Plan entry is offered quarterly.

Contributions

Participants may contribute a percentage of their pretax annual compensation, as defined by the Plan and subject to IRS limits. Participants may also contribute (rollover) amounts representing distributions from other qualified plans. The School contributes to the Plan a discretionary matching contribution of the participant's salary deferral up to 10 percent of pretax annual compensation. Matching contributions for the Plan totaled \$328,953 for the year ended June 30, 2025.

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and contributions to a Roth 401(k) account are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts and gains and losses attributable to such deferrals are accounted for separately.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the School's contributions and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participant's accounts attributable to the School's matching and discretionary contributions and earnings thereon are vested based on years of continuous service. The portion of the participant's accounts attributable to the School's matching and discretionary contributions become 100 percent vested after three years of service or if less than three years, upon reaching retirement, upon total disability or death, or upon termination of the plan.

(2) Description of Plan

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at average rates available on commercial loans, determined by the Trustee, at the time of application. Principal and interest are paid ratably through payroll deductions.

Investment Options

Participants may direct their account balance to selected investments as made available and determined by the Plan Administrators. Participants may change the investment allocation of employee contributions on a daily basis. Participants may elect to discontinue contributions at any time. Participants may change salary deferral rates as of each payroll period.

Payment of Benefits

Benefit payments are made as soon as administratively feasible following the date on which a distribution request is made or is otherwise payable. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Vested benefits less than \$1,000 are to be distributed as soon as administratively feasible after the participant's termination of employment. Vested benefits greater than \$1,000 but less than \$5,000 are rolled over into individual retirement accounts.

Forfeited Accounts

Non-vested account balances are forfeited upon termination. The Plan uses forfeitures to reduce employer contributions and administrative expenses. During the year ended June 30, 2025, \$9,290 of forfeitures were used to reduce plan expenses. The year end forfeiture balance of the Plan was \$143 and \$9,290 as of June 30, 2025 and 2024, respectively.

Hardship Withdrawals

Should a plan participant experience a hardship, they may elect to withdraw all or part of their vested account from the Plan. All cases of hardship must be presented in writing to and approved by the School's Plan Administrators. The School's Plan Administrators may request additional supporting documentation from plan participants to substantiate any case of hardship. The School's Plan Administrators may, at its discretion, approve all or part of the withdrawal request. Hardship withdrawals are recorded as distributions in the period in which they are paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the School. No such officer or employee receives compensation from the Plan. The Plan provides that trustee fees and other administrative expenses are paid by the School. If not paid by the School, these expenses become the responsibility of the Plan. Participant accounts are charged with an allocation of the distribution and loan fees that the participants incur.

(3) Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(4) Investments – Information Certified by the Trustee

Bravera Wealth (the Trustee) holds and performs all accounting functions associated with the Plan's investments. The Plan Administrators have obtained certifications from the Trustee that investments, assets, transactions, income and the schedule of assets held for investment purposes are complete and accurate. The fair value of investments at June 30, 2025 and 2024 is determined by the Trustee (Note 7).

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan Administrators have received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan. Information contained in the following has been certified by the Trustee:

The Plan invests in a money market account, mutual funds, and a common collective trust with underlying assets consisting of any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the levels of risk associated with certain investment securities, it is at least reasonably possible that changes in fair values of investment securities will occur in the near term and that such changes could materially affect participants; account balances and the amounts reported in the statements of net assets available and the statements of changes in net assets available for benefits.

(5) Income Tax Status

A determination letter was obtained for the prototype plan document, in which the Internal Revenue Service stated that the Plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the Plan Administrators believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes have been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Department of Labor or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Participant Withdrawals

As of June 30, 2025 and 2024, Plan assets include terminated participants with account balances totaling approximately \$2,973,000 and \$2,151,000, respectively. There were no amounts owed to participants who had elected to withdraw from the Plan but had not been paid as of June 30, 2025 and 2024, respectively.

(7) Recurring Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

(7) Recurring Fair Value Measurements

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level Two: inputs include:
 1. quoted prices for similar assets or liabilities in active markets;
 2. quoted prices for identical or similar assets or liabilities in inactive markets;
 3. inputs other than quoted prices that are observable for the asset or liability;
 4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(7) Recurring Fair Value Measurements

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value/Collective Trust Funds: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust fund, the issuer reserves the right to require 12 months notification in order to ensure the securities liquidations will be carried out in an orderly business manner.
