### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Millwright Union Individual Account Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements present fairly, in all material respects, the net assets available for benefits of Millwright Union Individual Account Retirement Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General**

This Plan was created for the purpose of providing annuity, severance, and retirement benefits for participants and their beneficiaries. Participants are immediately eligible upon employment with a participating employer. The Plan is subject to the provisions of ERISA, as amended, and Section 401(k) of the Internal Revenue Code (IRC). The Plan is funded by employer contributions and by elective deferrals from participants' earnings in accordance with the terms of the participating employers' collective bargaining or other written agreements between the Allied Construction Employers Association, Inc., the Eastern Wisconsin Erectors Association, Inc., and the North Central States Regional Council of Carpenters. Contributions are subject to certain limitations.

The Plan is administered by a Board of Trustees consisting of a union group and an employer group of representatives, each having equal voting power. The Board is responsible for oversight of the Plan and determines the appropriateness of the Plan's investments and monitors investment performance.

**Plan Administration**

The Standard is the custodian for the Plan. The Board of Trustees, as Plan administrator, have engaged the services of Wilson-McShane Corporation as the third-party administrator to handle the daily administration of the Plan.

**Contributions**

The Plan is financed by employer and participant contributions in accordance with the terms of collective bargaining agreements between the union and participating employers. The Millwright and Piledriver rates are as follows:

The Plan includes a 401(k) feature which allows employees of participating employers to make additional tax deferred contributions to the Plan. Participants can contribute any multiple of \$.50 per hour, up to \$10.00 per hour in each pay period, pre-tax, to be deposited into their individual account, subject to limits determined by the Internal Revenue Service (IRS). Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

**Contributions (Continued)**

The Plan allows for receipt of reciprocal contributions through reciprocal agreements with other local unions. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of temporary employees to and from the employees' participating local unions. Reciprocal contributions received and paid are recorded as employer contributions in the statement of changes in net assets available for benefits.

Participants direct the investment of contributions into various investment options offered by the Plan.

Effective May 1, 2025, the Plan was amended to create a Flex-Choice Allocation Program to allow for additional contributions to the Plan, which allows participants to choose how employer contributions are allocated between their retirement plan and health fund. Participants can either take no action (defaulting to current contribution rates), select the Glidepath Model (allocating more to retirement when younger and more to health as they age), or customize their allocation, all by submitting the required form during the enrollment period. Elections remain in effect until changed during a future enrollment period. If a participant's health fund balance falls below the required level, contributions revert to the default allocation.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the employer contributions, participant's deferrals, plan earnings (loss) and forfeitures, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Unallocated Plan assets were \$485,964 and \$222,755 as of May 31, 2025 and 2024, respectively.

**Vesting**

Participants are immediately fully vested in the balance of their account.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, participants may elect to receive their account balance in either a lump-sum amount or monthly payments. Withdrawals are permitted due to other circumstances as described in the Plan agreement and are subject to certain limitations. Terminated participants with a nonforfeitable interest in an account that has never exceeded \$1,000 will have their balance directly distributed to them in a lump-sum distribution. Certain withdrawals are permitted during employment for hardships, as defined in the Plan. All or any part of a participant's employer contribution account balance may be distributed as a hardship withdrawal.

**Payment of Benefits (Continued)**

Effective March 5, 2025, the Plan was amended to clarify distributions where no beneficiary has been designated and no estate currently exists. The Plan was also amended to change the period of time from which no contributions are paid to the Plan on behalf of a participant from 24 consecutive months to 12 consecutive months for one of the conditions of eligibility for payment.

**Forfeited Accounts**

Effective March 5, 2025, forfeitures from individual accounts of missing participants shall be used first to pay Plan expenses. Any amounts which remain after will be allocated to Plan participants in a proportionate amount, based on the amount in a participant's account balance. There were no forfeited accounts and no forfeitures used to pay administrative expenses or allocated to participant accounts as of or for the years ended May 31, 2025 and 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Concentration**

**Credit Risk** – The Plan maintains its cash balances in a high credit quality financial institution in Minnesota. Accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, such cash balances may be in excess of the insurance limit.

**Employer Contributions** – The Plan has two employers who accounted for approximately 37% of the employer contributions for the year ended May 31, 2025, and four employers who accounted approximately 61% of the employer contributions for the year ended May 31, 2024, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Contributions Receivable**

Contributions due but not paid prior to year-end are recorded as contributions receivable. Reciprocal contributions receivable is also included with employer contributions receivable. Contributions are due from employers as specified in the collective bargaining or participation agreement. In general, contributions are due on the 15th day of each month following the work month. Delinquent contributions and payroll audit findings are individually analyzed for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends.

As of May 31, 2025 and 2024, all outstanding contributions receivable amounts are reported net of contributions considered uncollectible by the Plan. As of May 31, 2025 and 2024, the allowance for credit losses was insignificant.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment consultant and custodian. See Note 3 for discussion of fair value measurements.

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits paid to participants and beneficiaries are recorded when paid.

**Administrative Expenses**

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of net assets available for benefits.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through March 6, 2026, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical or similar assets or liabilities in active markets,
- inputs other than quoted prices that are observable for the asset or liability,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at May 31, 2025 and 2024.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

*Pooled Separate Account:* Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 4 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by The Standard Insurance Company, the custodian; therefore, these transactions qualify as party-in-interest transactions. These are transactions for which a statutory exemption exists under ERISA.

**NOTE 5 TAX STATUS**

The IRS has determined and informed the Plan by letter dated June 23, 2015, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Board of Trustees and the Plan's legal counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PLAN TERMINATION**

Although they have not expressed intent to do so, the Board of Trustees has the right to suspend or terminate the Plan at any time. In the event of Plan termination, participant accounts will be distributed in such manner as otherwise provided by the Plan. The Plan provides that at no time will any of the assets of the Plan revert to any employer or the union or be used for any purpose other than for the exclusive benefit of the participants and their beneficiaries.

**NOTE 7 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
