Dear Sir or Madam,

I am writing to formally request a waiver of the Failure to File penalty assessed on my 2024 filing of Form 5500.

I believe this penalty should be waived due to reasonable cause, as I exercised ordinary business care and prudence but was unable to comply due to circumstances beyond my control.

On or about April 1<sup>st</sup>, 2025, as part of our business separating from a franchise, the email address that was on file for receiving notices was changed. Due to the email address being changed, I did not receive any notices telling me that a form was due, or that it was late. My history with the IRS and the Department of Labor shows that I have typically filed forms on time and take action when it is requested. This was a unique situation that kept me from completing the duties required.

Despite these circumstances, I took the following steps to meet my obligations:

- I filed as soon as I realized the Form 5500 was due on 1/22/2026. I received notice from ADP through the payroll updates board that the filing was late and needed my attention. Their notices are also done by email, and the email had been changed in the payroll account, but unbeknownst to me, had not also updated in the retirement account.

I have a history of compliance with IRS regulations and this was a one-time, unavoidable occurrence. I respectfully request that the penalties be abated based on the information provided above.
