#### **Note 1 - Description of the Plan**

The following description of the Apollo, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all regular full-time employees of Apollo, Inc. (the Company) who are age 21 or older except for union employees, leased employees, and nonresident aliens. All eligible employees become participants and may begin making elective deferrals to the Plan on completing one month of service. All participants are eligible to receive employer contributions on completing 1,000 hours of service. Employees enter the Plan on the first day of the month after meeting the eligibility requirements. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Through May 2024, the Plan engaged Charles Schwab Trust Bank to hold and invest these participant-directed Plan assets and execute Plan transactions. In May 2024, the Company changed custodians from Charles Schwab Trust Bank to Empower Trust Company, LLC. The Plan was amended and restated, effective May 2024.

##### Sponsors

The Plan has been adopted by the following companies and the assets available for benefits include those allocated to participants of the group:

- Apollo, Inc.
- Apollo Sheet Metal

The above employers are a control group and are treated as a single employer for the Department of Labor's reporting purposes.

##### Contributions

A participant may elect to contribute up to the maximum allowed under the IRC each year instead of receiving that amount in cash. Contributions include employee pretax deferral contributions, after-tax Roth deferral contributions, or a combination of both, and catch-up contributions for participants who have attained age 50. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants are automatically enrolled at a deferral rate of 3% of eligible wages. The automatic enrollment can be declined by the employee upon request by the employee to change the deferral percentage to zero. The Company matches a discretionary portion of participants' annual deferral.

The Plan also allows the Company to make discretionary nonelective contributions. To be eligible for the discretionary nonelective contribution, a participant must be eligible to receive employer matching contributions. Contributions are subject to certain limitations. For 2024, the Company made a matching contribution of 50% of employee contributions up to 10% of eligible compensation. In addition, the Company made a 2.5% profit-sharing contribution of eligible wages.

##### Investment Elections

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants have the opportunity to change their investment combinations on a daily basis.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Additionally, participants are 100% vested in their nonelective contributions. Vesting in the Company's discretionary match and profit-sharing contributions plus actual earnings thereon is based on years of continuous service and occurs gradually according to the following table:

A participant becomes fully vested in the entire balance of his or her account upon attainment of normal retirement age, permanent disability, death, or termination of the Plan. Any amount not vested upon a participant's separation from service is forfeited and may be used to reduce the Company's contribution or pay Plan expenses.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to 10 years for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by commercial lenders for loans made under similar circumstances. The interest rates were 5.25% to 10.50% for the year ended December 31, 2024.

##### Payment of Benefits

On termination of service due to any reason, participants with vested account balances of less than \$5,000 receive an automatic distribution to an Individual Retirement Account (IRA). Participants with vested account balances of \$5,000 or more may elect to receive a single lump-sum amount or choose to rollover their balance into another qualified retirement plan or IRA.

Upon termination of service due to retirement, disability, death, termination or other reasons, a participant or their beneficiary may elect to receive a distribution equal to the vested balance in his or her account. Benefits are paid under various options as defined in the Plan document.

Participants may also elect to take in-service or hardship withdrawals subject to the terms of the Plan document and IRS regulations.

##### Forfeitures

At December 31, 2024, forfeited nonvested accounts totaled \$276,305 and there were no forfeited nonvested accounts at December 31, 2023. During the year ended December 31, 2024, forfeitures of \$85 were used to reduce employer contributions and pay Plan expenses, respectively.

#### **Note 2 - Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

##### Payments of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### Subsequent Events

The Plan has evaluated subsequent events through March 6, 2026, the date the financial statements were available to be issued.

#### Note 3 - Information Certified by Custodians

The Plan's investments are held by Empower Trust Company, LLC and Charles Schwab Trust Bank, the Custodians of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Custodians. The Plan Administrator has obtained certifications from Charles Schwab Trust Bank for the period from December 31, 2023 to May 2024, and Empower Trust Company, LLC for the period May 2024 to December 31, 2024, that the following information provided to the Plan Administrator by the Custodians is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Net change in fair value of investments
- Interest and dividends
- Interest on notes receivable from participants

#### Note 4 - Fair Value Measurements

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds (CT):* CTs invest in a variety of guaranteed investment contracts, domestic stocks, international stocks, mutual funds, bonds, and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the net asset value (NAV) of each individual CT is not valued using publicly quoted prices.

#### Note 6 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan's volume submitter sponsor by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Randall & Hurley, Inc. which has been adopted by the Plan, is acceptable pursuant to Section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - Party-in-Interest Transactions

Randall & Hurley, Inc. provides third-party administration services to the Plan; HFG Trust, LLC provides investment advisory services to the Plan; and Empower Trust Company, LLC and Charles Schwab Trust Bank provide custodian services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.
