**A. Description of the Plan**

The United Food and Commercial Workers Local 360 Scholarship Fund (“The Organization”) was established in order to raise funds for and administer a scholarship program to provide partial scholarships to members, spouses of members, and dependent children of members of the United Food and Commercial Workers Union Local 360, who show outstanding academic potential. The Trustees shall set the amount of the scholarship award. The Scholarship Fund Committee reviews all applications and nominates recipients for approval. The Fund amended its by-laws to include charitable giving in addition to its scholarship program.

**B. Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements of the Organization have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America; consequently, revenue is recognized when earned and expenses when incurred.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*Contributions / Funding*

The Plan receives funding from the golf outing fundraiser they host every year. Fundraising Revenue is recognized when organizations and golfers sign up for the fundraiser, or when contributions are pledged.

*Payment of Scholarships*

Scholarships are recorded when awarded to the recipients.

*Income Taxes*

The Organization is a not-for-profit organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation.

FASB requires financial statement recognition of the impact of a tax position, if that position is more than likely than not to be sustained on examination, based on the technical merits of the position. The benefit is calculated as the larger amount that is more than 50% likely to be realized upon resolution of the benefit. The Organization has evaluated its tax positions and believes all could be sustained upon examination. The Organization is no longer subject to income tax examinations by the federal authorities before 2022.

**B. Summary of Significant Accounting Policies, continued**

*Date of Management Review*

Subsequent events were evaluated through March 5, 2026, which is the date the financial statements were available to be issued.

**C. Termination**

Upon dissolution and winding up of the organization, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code and which has established its tax-exempt status under that section.

**D. Concentrations**

The Organization maintains cash balances at a local bank where the accounts are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. As of December 31, 2025 and 2024 there were no uninsured balances.

**E. Related Party Transactions**

The Organization reimbursed trustees, officers, and employees of the plan sponsor for expenses and supplies that were bought for the golf outing fundraiser.
