(the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

1. Description of the Plan

The following description of 403(b) Thrift Plan of Community Nurse Home Care, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a tax-exempt, defined contribution plan that covers substantially all employees of Community Nurse Home Care, Inc. (the Company). The Plan was adopted on October 1, 2007 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Mutual of America Life Insurance Company, (MOA) is the recordkeeper and custodian of the Plan.

Eligibility

The Plan is available to all Company employees, except non-resident aliens with no U.S. source income. Employees of the Company who have attained 21 years of age are eligible to participate in employer based contributions after completing one year of service. There is no age or service requirement for employee contributions.

Contributions and Vesting

Participants may contribute up to 100% of eligible compensation, as defined in the plan document, to the Plan, subject to the limitations established by the Internal Revenue Code (the Code). In addition, participant contributions may also consist of rollovers from other qualified retirement plans.

Participants are always 100% vested in all employee elective deferrals. Participants are 100% vested in the employer contributions upon completion of three years of vesting service.

The Company may make discretionary non-elective contributions, as defined by the Plan. The Company made a 3% discretionary non-elective contribution on eligible compensation for the plan year 2025.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Loans

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years but may be longer if used for the purchase of a primary residence. The loans are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Plan loans taken by participants from MOA are issued directly from the funds owned by the custodian instead of being removed from the participant's account balance. These loans are collateralized by 100% of the participant's account, which is required to be maintained in the interest accumulation account. As loans are paid off, participants may reinvest their funds as they choose. As of June 30, 2025 and 2024, \$46,170 and \$32,738, respectively, was pledged as collateral for loans to participants.

Investments

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan offers investments in pooled separate accounts and an interest accumulation account.

Payment of Benefits

Participants shall become eligible to receive their account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive the benefit payments in a single lump sum payment or a monthly annuity. In addition, participants may withdraw their pretax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in Section 403(b) of the Code.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent asset and liabilities, at the date of the financial statements. Actual results could differ from those estimated.

Investments

The Plan's investments are stated at fair value, except for the interest accumulation account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses

Substantially all administrative expenses are paid by the Company on behalf of the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring through January 27, 2026, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Interest Accumulation Account

The interest accumulation account is an investment contract, between participants and MOA, which is held in the general account of MOA. The contract is a fully benefit-responsive contract. The contract is included in the financial statements at contract value as reported to the Plan by MOA. This account represents the original contributions made under the contract, plus cumulative interest earnings, less participant withdrawals and administrative expenses. This account becomes part of MOA's general assets, which supports MOA's insurance and annuity obligations. MOA bears the full investment risk of all amounts participants allocate to the interest accumulation account. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

4. Income Tax Status

The Plan is a prototype non-standardized 403(b) plan sponsored by MOA. The Internal Revenue Service has determined and informed MOA by a letter, dated March 31, 2017, that the form of the prototype non-standardized 403(b) is designed in accordance with applicable sections of the Code. The Plan has been amended since MOA received the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

5. Information Prepared and Certified by Custodian

The investments, investment transactions, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by MOA as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

6. Party-in-Interest Transactions

Certain Plan investments are shares of diversified investment funds managed by MOA; therefore, these transactions qualify as party-in-interest transactions. The administrative expenses paid by the Plan for 2025 were \$3,059, and qualify as party-in-interest transactions as they are related to recordkeeper fees incurred by the Plan.

7. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts are valued at the quoted market price of the underlying assets and adjusted for administrative charges of the separate account.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to terminate the Plan at any time subject to the provisions of ERISA.
