Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Mercyhurst University Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of May 31, 2025 and 2024, and for the year ended May 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 10 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of or for the year ended May 31, 2025, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the 2025 Financial Statements section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Mercyhurst University Defined Contribution Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Mercyhurst University (University) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the University. Students who are employed by the University are generally excluded from participation in the Plan. Participants are required to complete 12 consecutive months of service at the University and work at least 1,000 hours to qualify for employer contributions. The Plan credits participants who have been employed during the 12-month period prior to commencing employment with the University by another educational, non-profit, governmental or other institution sponsoring 403(b) plan for this service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Teachers Insurance and Annuity Association of America (TIAA) serves as the issuer of the TIAA Traditional Annuity and TIAA variable annuities, and College Retirement Equities Fund (CREF) serves as the issuer of the CREF variable annuities held by the Plan. The Variable Annuity Life Insurance Company (VALIC) serves as the issuer of the VALIC variable and fixed income annuities. TIAA and VALIC are the recordkeepers of the Plan. TIAA is the custodian of the annuity related assets. VALIC is the custodian of the variable and fixed income annuities issued by VALIC. TIAA Trust Company, FSB is another custodian of the Plan.

Contributions: The Plan permits eligible employees to have the University make annual contributions of up to 100% of eligible compensation through a salary deferral election. The Plan sponsor may also elect to provide a discretionary contribution to employees who are eligible to participate in the Plan and who have completed one year of service. In years when discretionary contributions are made, the allocation to the participant accounts is formula based on the eligible individual's compensation and years of service.

Contributions are subject to certain limitations. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant investment account options: Investment account options available include various annuity accounts, a pooled separate account and mutual funds. Each participant has the option of directing his or her contributions into any of the investment account options selected by the University and may change the allocation to the extent permitted by the individual agreements.

Participant accounts: Each participant's account is credited with the participant's contribution, the University's contribution and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions and any employer contributions, plus earnings thereon.

Payment of benefits: Upon termination of service due to death, disability or retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, an annuity contract (if assets are held in a custodial account) or convert to an income option (if assets are invested in an annuity contract). A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's interests in the pooled separate and variable annuity accounts are valued at the NAV of the units of the variable annuity accounts. The NAV is used as a practical expedient to estimate fair value of the pooled separate and variable annuity accounts.

The Plan is funded by individually controlled TIAA, CREF and VALIC investments. Contributions are allocated to the TIAA Traditional Annuity contract, CREF Variable Annuity accounts, mutual funds, TIAA Real Estate Pooled Separate Account, or the VALIC variable and fixed income annuity accounts.

Traditional annuity contracts that are not benefit-responsive are reported at estimated fair value as provided by TIAA, CREF and VALIC. Fully benefit-responsive traditional annuity contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably.

Note 2. Summary of Significant Accounting Policies (Continued)

Prior to May 1, 2019, the Plan did not allow for participant loans. TIAA and VALIC would issue loans to Plan participants outside the scope of the Plan. For such loans, participants pledge as security a portion of their balance in the TIAA Traditional Annuity or VALIC Fixed Account Plus, which represents 110% of the outstanding loan balance. The loan balance outstanding as of May 31, 2025 and 2024, was approximately \$93,000 and \$196,000, respectively. These disclosed loan balances include deemed distributed loans of approximately \$0 and \$47,000, respectively. Plan loan interest rates ranged from 4.25% to 9.50% as of May 31, 2025 and 2024. The Plan administrator has concluded that these loans are not Plan assets and that such arrangements are exempt transactions. In the event of default, such loans are reportable to participants as taxable income but remain outstanding and continue to accrue interest until repaid by the participant or the participant becomes eligible to receive a distribution under the terms of the Plan. During the years ended May 31, 2025 and 2024, no loans went into default.

Contributions: Participant contributions are recognized when earned. Employer matching contributions are recognized concurrently with participant contributions.

Payment of benefits: Benefit payments to participants are recorded upon distribution.

Administrative expenses: Administrative expenses may be paid by the employer or the Plan, at the University's discretion.

Note 3. Certification of Plan Custodians

The following is a summary of the Plan's asset and income information as of May 31, 2025 and 2024, and for the year ended May 31, 2025, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by TIAA and CREF and the custodians, and furnished to the Plan administrator. The Plan administrator has obtained certifications from TIAA and CREF and the custodians that information provided to the Plan administrator by TIAA and CREF and the custodians related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices in active markets for identical assets or liabilities.

There have been no significant changes in the valuation techniques during the year ended May 31, 2025. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Transfers between fair value hierarchy levels: For the years ended May 31, 2025 and 2024, there were no transfers in or out of Level 3.

Level 3 activity: During the year ended May 31, 2025, purchases and sales of Level 3 assets amounted to \$1,764,830 and \$2,370,855, respectively. During the year ended May 31, 2024, purchases and sales of Level 3 assets amounted to \$1,032,114 and \$2,810,037, respectively.

In estimating fair value of the investments in Level 3, the University has various processes and controls in place to ensure fair value is reasonably estimated. The Endowment and Investments Committee of the Board of Trustees, which reports to the University's Board of Trustees, sets valuation policies for Plan assets and is responsible for the determination of the fair value. The Endowment and Investments Committee of the Board of Trustees: (1) compares price changes between periods to current market conditions, (2) compares trade prices of securities to fair value estimates, (3) compares prices from multiple pricing sources and (4) performs ongoing due diligence to confirm that independent pricing services use market-based parameters for valuation. Valuation approaches are reviewed on an ongoing basis and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price.

Investments measured using the net asset value per share practical expedient: The following table summarizes the investments for which fair value is measured using the net asset value per share practical expedient as of May 31, 2025 and 2024. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5. Investment Contracts With Insurance Companies

The Plan has entered into traditional annuity contracts with TIAA, CREF and VALIC. TIAA, CREF and VALIC maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The traditional annuity contract issuers are contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

Some of the traditional annuity contracts are fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by TIAA, CREF and VALIC, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The traditional annuity contracts that are not fully benefit-responsive are reported at the estimated fair value as provided by TIAA and CREF.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The traditional annuity contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

Investment contracts that are non-fully benefit-responsive are included in the financial statements at fair value as reported by TIAA and CREF. TIAA and CREF indicate that contract value approximates fair value for these investments at May 31, 2025 and 2024.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are managed by TIAA, CREF and VALIC, the custodians of certain investments of the Plan and, therefore, these transactions qualify as party-in-interest. In addition, the University provides certain administrative services at no cost to the Plan. Administrative expenses paid to TIAA amounted to \$1,047 for the year ended May 31, 2025.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The fully benefit-responsive guaranteed annuity contracts have been certified at contract value, which approximates fair value, as reported to the Plan by TIAA and CREF. In subsequent periods, if market conditions change, such as the insurance companies' credit rating or interest rate environment, the difference between contract value and fair value could become significant causing the financial statements to become materially misstated.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

Note 9. Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code (IRC) of 1986, as amended. The Plan has not requested or obtained a determination letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and not subject to tax. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Excluded Contracts

The Plan administrator has elected to exclude from investments certain annuity and custodial accounts which may have been issued to current and former employees without the Plan administrator's knowledge prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to potential accounts have also been excluded from the statements of changes in net assets available for benefits. U.S. GAAP require that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan administrator is not able to determine the amount of these excluded annuity and custodial accounts and the related income and distributions because records relating to these are not available or do not exist.

Note 11. Subsequent Events

The Plan administrator has evaluated subsequent events for potential recognition and/or disclosure through January 6, 2026, the date the financial statements were available to be issued.
