Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Matterport, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 4, 2025 (in liquidation) and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to November 4, 2025 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Matterport, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 4, 2025 and December 31, 2024, and for the period from January 1, 2025 to November 4, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Baker Tilly Advisory Group, LP and Baker Tilly US, LLP, trading as Baker Tilly, are members of the global network of Baker Tilly International Ltd., the members of which are separate and independent legal entities. Baker Tilly US, LLP is a licensed CPA firm that provides assurance services to its clients. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Matterport, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, on February 25, 2025, the Board of Directors of Matterport, Inc., the Plan's sponsor, adopted a resolution to terminate Matterport, Inc. 401(k) Plan effective February 27, 2025. As a result, Matterport, Inc. 401(k) Plan has changed its basis of accounting from the ongoing basis used in presenting the 2024 financial statements to the liquidation basis of accounting used in presenting the 2025 financial statements. Our opinion is not affected with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Matterport, Inc. 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. NOTE 1 – DESCRIPTION OF PLAN

The following description of Matterport, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement (Plan Agreement), as amended, for a more complete description of the Plan's provisions.

General – The Plan was a 401(k) salary deferral and profit sharing plan covering substantially all employees of Matterport, Inc., and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Matterport, Inc. (the Company), was the Plan's sponsor and served as plan administrator.

On February 25, 2025, the Board of Directors of Matterport, Inc., the plan sponsor, approved the termination of the Plan with an effective date of February 27, 2025. All participants became fully vested in their account balances and were given the option of either receiving a distribution (less applicable penalties and taxes) or transferring their balance to another qualified plan. All plan assets were liquidated and distributed out of the Plan as of November 4, 2025.

Eligibility – Employees of the Company were eligible to participate in the Plan upon reaching age 21. Participants must have completed 500 hours of service in a 6-month period to be eligible to receive any employer paid profit sharing contributions.

Contributions

Participant contributions – Each year, participants could have contributed up to 100% of pretax annual compensation, as defined in the Plan. Participants could also have elected to make Roth contributions utilizing after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans in the form of rollover contributions.

Employer matching and profit sharing contributions – The Company was allowed to elect to make discretionary matching and profit sharing contributions to the Plan. Profit sharing contributions were allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no discretionary matching or profit sharing contributions for the period from January 1, 2025 to November 4, 2025.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Participants directed the investment of their account into various investment options offered by the Plan. Investment options included money market account and mutual funds, including a separately managed account by an investment manager specifically for the Plan.

Vesting – Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts was based on years of continuous service. Participants vested in the Company’s contributions based on the following schedule:

Less than 1	0%
1-2	50%
2 or more	100%

Notes receivable from participants – Participants were allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant’s account. All loans must have been repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan must have been repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan Agreement, plan loans bore a reasonable rate of interest determined by the plan administrator. Principal and interest were paid ratably through payroll deductions. There were no outstanding notes receivable at November 4, 2025.

Payment of benefits – On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan allowed for the automatic distribution of participant vested account balances that did not exceed \$5,000.

Forfeitures – Forfeitures were the nonvested portion of a participant’s account that was lost upon termination of employment. Forfeitures could be used to reduce future Company contributions or pay administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting. The Plan was terminated effective February 27, 2025, and as a result, the Plan changed its basis of accounting from the ongoing basis used in presenting the 2024 financial statements to the liquidation basis of accounting in presenting the 2025 financial statements.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments were reported at fair value. The Plan’s custodian, Charles Schwab Trust Bank (Charles Schwab), certified the fair market value of all investments. If available, quoted market prices were used to value investments.

Fair value was the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investments in interest-bearing cash were not valued at fair value, but instead were valued at face value.

Income recognition – Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. The net appreciation in fair value of investments consisted of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants were recorded in the year in which the participant contributions were withheld from compensation.

Notes receivable from participants – Notes receivable from participants were measured at amortized cost, which represented unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses had been recorded as of November 4, 2025 or December 31, 2024.

Payment of benefits – Benefits were recorded when paid.

Expenses – General plan administrative expenses could be paid out of the forfeiture account or paid by the Company. Investment management, distribution, and loan transaction fees were paid by the Plan participants.

Subsequent events – The Plan has evaluated subsequent events through March 3, 2026, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value at December 31, 2024.

Money market account and interest-bearing cash – Valued based on quoted market prices.

Mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission.

BrokerageLink account – This account primarily consists of mutual funds, and common stocks that are valued on the basis of readily determinable market prices, and interest-bearing cash.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – TAX STATUS

The Plan had adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since the date of the opinion letter, the plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – CERTIFIED INVESTMENT INFORMATION

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab, a qualified institution:

- Investments reflected on the accompanying statements of net assets available for benefits as of November 4, 2025 and December 31, 2024.
- Net appreciation in fair value of investments, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2025 to November 4, 2025.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by an affiliate of Charles Schwab, the custodian of the Plan, and, therefore, transactions with this entity qualified as exempt party-in-interest transactions.

NOTE 7 – RECONCILIATION TO FORM 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
