## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
Graphic Communications National  
Health & Welfare Fund

### Opinion

We have audited the accompanying financial statements of Graphic Communications National Health & Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits and of benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion

## NOTES TO FINANCIAL STATEMENTS

YEARS ENDED MAY 31, 2025 AND 2024

### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Graphic Communications National Health & Welfare Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General** - The Graphic Communications National Health and Welfare Plan (National Plan) is funded by the Plan, which is a Voluntary Employees' Beneficiary Association (VEBA), providing for health, life, and other welfare benefits. The Plan was established pursuant to an Agreement and Declaration of Trust, which was entered into on March 1, 1997, by the Board of Trustees (Trustees) of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - The Plan was established to fund benefit claims and administrative expenses of the National Plan. The benefits are financed through premium payments made on behalf of Plan participants by participating local union funds or individual participating employers. Premium rates are established by the Trustees based on their advisor's estimates of claims and administrative expenses to be incurred.

**Benefits** - The Plan provides Medicare supplemental coverage, dental, vision, disability income, life insurance and accidental death and dismemberment benefits to eligible participants and their dependents, according to the Plan document. Benefits are recorded when paid by the Plan.

**Eligibility** - An employee or former employee of an employer who has agreed, pursuant to the terms of a collective bargaining agreement or other agreement, to contribute to a participating local union fund or the National Plan, who has met the eligibility requirements of the participating local union fund or the National Plan is eligible to participate in the National Plan.

A participating local union fund is a Taft-Hartley, Graphic Communications Conference of International Brotherhood of Teamsters (IBT) Local Union Health and Welfare Benefit Fund that has been accepted for participation by the Board of Trustees in the National Plan. A participating group can be a Local Union Taft-Hartley Fund, an employer in the graphic communications industry, the Graphic Communications Conference of IBT, a Local Union or District Council of the Graphic Communications Conference, or a joint Graphic Communications Conference-employer entity, which has agreed to be bound by the terms of the Agreement and Declaration of Trust.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

**Investment Valuation and Income Recognition** - Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by its investment advisor and custodian. See Note 5 for a discussion of fair value measurements.

Income from investments is recognized on the accrual basis. Security transactions are accounted for on a trade date basis. Net appreciation in fair value of investments is reflected in the statements of changes in net assets available for benefits.

**Benefits Currently Payable** - Amounts currently payable to or for participants, beneficiaries and dependents represent actual and estimated amounts paid or payable after year end for all reported claims for benefits occurring during the respective accounting periods, days lost due to disabilities that began during those periods, payment to benefit providers for benefits in those respective periods, and other miscellaneous benefits related to services performed in those respective periods.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, incurred but not reported (IBNR), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Administrative Expenses** - Administrative expenses are paid by the Plan.

**Reclassifications** - When applicable, certain reclassifications may have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

## NOTE 3. POSTRETIREMENT BENEFITS

The amount reported as the postretirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan contributors.

### NOTE 3. POSTRETIREMENT BENEFITS (CONTINUED)

Postretirement benefits include future benefits expected to be paid to or for, 1) currently retired or terminated employees and their beneficiaries and dependents, and 2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by an actuary and is that amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

**Actuarial Cost Method** - Accrued liabilities have been determined using the unit credit over cost method. Postretirement benefits payable to an employee are assumed to accrue over the employee's expected working lifetime but not beyond earliest retirement eligibility.

The following were other significant assumptions used in the valuations as of May 31, 2025:

Measurement Date:	May 31, 2025.
Discount Rates:	5.50% per annum, compounded annually (Prior Year-5.50% for 2024).
Mortality:	MP-2021 Combined Health Mortality Table.

**Health Care Cost Trend Rate (HCCTR)** - Health care cost trend measures the anticipated overall rate at which health plan costs are expected to increase in future years. The rates shown below are applied to gross eligible charges and are applied to the per capita costs shown in the medical assumptions below. The trend shown for a particular plan year is the rate that must be applied to that year's cost to yield the next year's projected cost.

**Per Capita Costs** - This valuation assumes June 1, 2024 through May 31, 2025 annual per capita costs as defined below. These costs represent the average cost at the average age of the current covered population. Conduent Consultants-Xerox did not perform an audit on the claims but did check them for reasonability. For the pre 65 costs we considered only manual rates in determining the final per capita.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

### NOTE 4. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at May 31, 2025 for claims incurred by active participants but not reported at that date, for accumulated eligibility of participants, and for future disability payments to members considered permanently disabled at May 31, 2025 are estimated by the Plan's actuary in accordance with generally accepted actuarial principles. Such estimated amounts are reported in the accompanying statements of benefit obligations at a value of \$76,829. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

### NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.



## NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at May 31, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTE 6. INCOME TAX STATUS

The Internal Revenue Service (IRS) has made a favorable determination on the Plan's tax status and it is exempt from federal income taxes under Internal Revenue Code (IRC) Section 501(a) as a Section 501(c)(9) organization. The Plan sponsor believes that the Plan continues to qualify and to operate in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

## NOTE 7. LITIGATION

Based on advice of Fund Counsel, there is no litigation either pending or threatened which would have a material adverse effect on the Plan's financial position.

## NOTE 8. PLAN TERMINATION

*Local Union or Participating Employer Fund Termination:* In the event that a Participating Local Union Fund or Participating Employer elects to terminate its participation in the National Plan or any other line of coverage with the National Plan, written notice must be provided to the Trustees, or its authorized Agent, no less than six (6) months prior to the first of January, with termination effective December 31. In the event of termination of participation, any pending and unrevealed benefit claims of Plan participants from the terminating Local Union Fund or Participating Employer will be paid out of Plan assets. No refund of premiums or reserves will be due or owing to the terminating Local Union Fund from the Plan.

The Trustees intends to continue to administer the National Plan indefinitely and reserves the right to alter, amend or terminate the Plan and National Plan subject to the provisions of ERISA and the IRC of 1986, as amended. Upon such termination, expenses and claims for covered benefit expenses incurred before the date of such discontinuance will be paid by the Plan to the extent that there are assets to do so. In no event shall any Plan assets remaining at termination be used for or diverted to any purpose other than the purpose of the Plan as set forth in the governing Plan documents.

## **NOTE 11. PARTY-IN-INTEREST TRANSACTIONS**

As disclosed in Note 2, the Plan pays certain administrative, investment and professional fees to various service providers. These transactions are party-in-interest transactions under ERISA.

## **NOTE 12. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

## **NOTE 13. SIGNIFICANT PLAN AMENDMENTS**

For the years ended May 31, 2025 and 2024, there were no significant plan amendments.

## **NOTE 14. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through February 23, 2026, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.


