Independent Auditor's Report

To the Plan Administrator and Management of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 401(k) Plan for the Employees of El Centro Family Health (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1) Description of Plan

The following description of the 401(k) Plan for the Employees of El Centro Family Health (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a non-standardized pre-approved profit sharing plan with CODA covering substantially all employees (with some exceptions as noted in the Plan document) of El Centro Family Health, Inc. (the “Company”) who are age eighteen or older and have completed three months of service. Eligible employees can enter the Plan on the first day of the Plan year or the first date of the month following the date the employee satisfies the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan’s sponsor and serves as the Plan administrator.

Contributions

Each year, participants may contribute up to 100% pre-tax compensation as defined in the Plan, not to exceed annual limits set by the Internal Revenue Code. Participants who are age 50 or over at the end of the calendar year, are permitted to make additional “catch up” elective deferral contributions, not to exceed annual limits set by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor contributions in the amount of 4% of each participant’s eligible compensation to the Plan each year. Contributions are subject to regulatory limitations.

Participant Accounts

Each participant account is credited with the participant’s contributions, related matching contributions, Plan earnings or losses and are charged with an allocation of administrative expenses. Allocations of the Plan earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

1) Description of Plan — continued

Vesting

Participants are immediately vested in their contributions plus allocated earnings thereon. Participants are also immediately vested in safe-harbor employer contributions as well as rollover contributions. Vesting in the Company's non-elective contributions plus actual earnings and changes in value thereon is based on a period of 12 consecutive months beginning on the day the employee performs one hour of service for the employer (generally the date of hire). Employers are subject to vesting provisions in the schedule below and will be vested in increments of 20% per year until fully vested after five years of employment.

Participant Loans

Participants are currently not permitted to borrow from their fund accounts per the Plan agreement.

Forfeited Accounts

Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to pay reasonable Plan administrative expenses. Additionally, the employer can also use forfeitures to restore forfeited amounts of employees re-employed within a five-year period or reduce future Company contributions. If there is an insufficient balance in the forfeiture account to cover expenses of the Plan, the Company would pay the expenses. At June 30, 2025, there were no forfeited non-vested accounts. At June 30, 2024, forfeited non-vested accounts totaled approximately \$6,250. For the year ended June 30, 2025, approximately \$6,500 of forfeitures were used to reduce contributions. For the year ended June 30, 2024, forfeitures were not used to reduce contributions.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Administrative Expenses

The Plan permits, but does not require, the Company to pay costs of Plan administration.

Payment of Benefits

Benefit payments are recorded when paid.

Valuation of Investments

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. In accordance with valuing investments at fair value, the net unrealized appreciation is presented in the statements of changes in net assets available for benefits.

Date of Management's Review

Subsequent events were evaluated through February 25, 2026, which is the date the financial statements were available to be issued.

5) Tax Status

The Plan adopted a retirement plan and trust under the Pension Planning Consultants, Inc. non-standardized pre-approved profit sharing plan with CODA. The Plan has received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires that Plan management evaluate tax positions taken by the Plan and recognize tax assets (liabilities) for uncertain tax positions that more likely than not would be sustained upon examination by the IRS. The Plan has no uncertain tax positions taken or expected to be taken for the years ended June 30, 2025 or 2024. The Plan Administrator believes the Plan is no longer subject to potential income tax examinations for years prior to June 30, 2022.

The Plan recognizes interest accrual related to unrecognized tax benefits in interest expenses and penalties as operating expenses, when applicable. No provision for the effects of uncertain tax positions has been recorded for the years ended June 30, 2025 and 2024.

For the years ended June 30, 2025 and 2024, there were no liabilities related to unrecognized tax benefits.

6) Fair Value Measurement

The Plan's investments, except for investment contracts, which are reported at contract value, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6) Fair Value Measurement — continued

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements - The fair value of shares of registered investment companies are measured using quoted prices in an active market.

7) Party-in-Interest Transactions

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

8) Investment Contracts

The Plan offers a benefit-responsive investment contract through a rider to Standard insurance Company's group annuity contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under their terms of the Plan. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any.

The fully benefit-responsive contract held by the Plan is a fixed-rate annuity contract that is fully and unconditionally guaranteed and backed by the claims-paying ability of the issuer. The fixed rate guaranteed insurance contract provides a guarantee of principal, a guaranteed minimum rate of interest of at least 1% annually. Such interest rates are reviewed on a quarterly basis for resetting. The average yield as of June 30, 2025 and 2024 was 3.15% and 3.00%, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code;
- Plan termination;
- Premature termination of the contracts;
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. There are no known events that permit the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

9) Plan Termination

Although it has not expressed an intent to do so, the Company and the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
