As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**1. DESCRIPTION OF THE PLAN**

The following description of the Independent Options, Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Independent Options, Inc., ("Company") is the plan sponsor. The Plan is a defined contribution plan covering all full-time employees of the Company who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. Plan funds are held by John Hancock Life Insurance Company (Custodian).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 50% of participants' contributions not to exceed 6% of compensation. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. During the year ended June 30, 2025, the Company did not make any discretionary non-elective contributions to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may change their investment options at any time.

Vesting

Participants are vested immediately in their contributions, rollover contributions plus actual earnings thereon.

Payment of Benefits

Each participant's share of the net assets of the Plan is allocated to an individual account. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A participant may withdraw vested amounts from his or her account prior to termination of employment with the Company, in accordance with Plan rules. Participants may also take a financial hardship withdrawal under certain circumstances.

Forfeited Accounts

As of June 30, 2025 and 2024, forfeited nonvested accounts totaled \$4,575 and \$2,824 respectively. If a participant terminates prior to vesting 100% in Company contributions, these accounts may be used to provide a supplemental employer contribution or pay administrative expenses. For the fiscal year ended June 30, 2025, amounts used to pay administrative expenses was \$5,975.

2. **SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and

assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

The Plan currently maintains cash in a bank account at a financial institution. Cash balances are insured by the FDIC for up to \$250,000. The Company does not anticipate any losses thereon.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company (Note 3).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. **FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Pooled separate accounts:* Valued at the NAV of units held by the Plan at year end, which is considered by plan management to be the best approximation of fair value. The unit values are calculated based on the collective values of the underlying investments.

Funds held in pooled separate accounts may be redeemed daily without restriction.

*Guaranteed interest accounts:* Guaranteed interest accounts provide a guaranteed interest rate on the principal invested for a specified period of time. Guaranteed interest accounts are backed by the general assets of the insurance company.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All of the Plan's investments were measured at NAV per share (or its equivalent) and, therefore, have not been classified in the fair value hierarchy.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a group annuity contract whereby contributions are allocated to guaranteed interest accounts with John Hancock Life Insurance Company (JH). JH maintains the contributions in a general account. Guaranteed interest accounts guarantee the return of principal, plus compound interest earned over a defined 3-, 5-, or 10-year term, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guaranteed period.

Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed interest accounts in that month. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Management believes that the group annuity contract does not meet the fully benefit-responsive contract criteria based on information reported by JH. As such, the guaranteed interest account is reported at fair value in the statement of net assets available for benefits.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**5. FINANCIAL INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

The plan administrator obtained a certification from John Hancock Life Insurance Company (plan custodian) that the following Plan information furnished by them and included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as of June 30, 2025 and 2024
- Investment transactions, investment income and related transactions for the fiscal year ended June 30, 2025.

**6. NET APPRECIATION OF INVESTMENTS**

During the fiscal year ended June 30, 2025, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$730,564. Substantially all depreciation was related to pooled separate accounts.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**8. TAX STATUS**

The IRS has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The plan received its most-recent IRS opinion letter on December 17, 2021.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. SEPARATED PARTICIPANTS WITH VESTED BALANCES**

Upon termination of employment from the Company, plan participants are entitled to withdraw or roll over their vested amounts from the Plan. Vested amounts allocated to accounts of separated participants who have not yet been paid as of June 30, 2025 and 2024 amounted to \$235,280 and \$427,928, respectively.

**10. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

John Hancock Life Insurance Company (JH) is the custodian of the Plan and holds and manages investments. Transactions with John Hancock Life Insurance Company, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Asset charges paid by the Plan to JH for investment services amounted to \$19,563 for the fiscal year ended June 30, 2025.

**11. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of

investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**12. SUBSEQUENT EVENTS**

Date of Management's Review

Management has evaluated subsequent events through January 14, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
