INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of
California Ironworkers Field Welfare Plan:

Opinion

We have audited the financial statements of California Ironworkers Field Welfare Plan, which comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of California Ironworkers Field Welfare Plan as of May 31, 2025 and 2024, and the changes therein for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of California Ironworkers Field Welfare Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about California Ironworkers Field Welfare Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of California Ironworkers Field Welfare Plan (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment and Liabilities Valuation, Transactions and Income Recognition

General - Investments and liabilities are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments and liabilities in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes and liabilities are presented below.

Limited liability company: The fair value of this investment is estimated based on net asset value per unit of the investment. The net asset value is being used as a practical expedient to estimate fair value. The objective of the Octagon Senior Secured Credit Cayman Fund Ltd. is to provide, on an unleveraged basis, high current income consistent with preservation of capital and low duration. Redemptions may be issued with a 30-day notice period. There are no unfunded commitments for this investment at May 31, 2025.

Mutual funds: The fair value of mutual funds is generally based on quoted market prices in active markets (Level 1).

Money market funds: Money market funds are valued at cost, which approximates fair value (Level 2).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the trust's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions Receivable

Employer contributions due and not received prior to year-end are recorded as employer contributions receivable. Contributions due that are delinquent and contributions due as a result of employer payroll audits are recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, these contributions are recorded when received. Contributions are recorded net of reciprocity out. Contributions received on behalf of participants belonging to an alternate welfare plan, are transferred to their home welfare plan based on the terms of a reciprocity agreement.

Prescription Rebates Receivable

Prescription rebates earned but not received prior to year-end are recorded as receivables. These rebates are netted against prescription benefit payments on the statements of changes in net assets available for benefits.

Benefit Obligations

Claims incurred but not reported and premiums payable are based on claims and premiums experience data. The obligation for extended eligibility for prescription drugs, vision, life insurance and group insurance contracts was estimated based on actual amounts paid for June and July coverage, for hours worked in April and May. The obligation for the participants' hour bank is based on hours banked as of May 31 multiplied by an estimate of the average cost of benefits to the Plan. Post-retirement benefit obligations were actuarially determined by the Plan's actuarial consultant, based on claims experience, census data and other factors, and are presented at present value.

Payment of Benefits

Benefit payments on behalf of participants are recorded upon distribution.

Investment in Ironworker Employees' Benefit Corporation (IEBC)

The Plan and other related Ironworker trust funds (see Note 9) established the IEBC to provide the trusts with administrative services. The investment is valued at the book value of the trust's interest in IEBC.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. The significant estimates affecting the financial statements are the benefit obligations and changes in benefit obligations and the post-retirement benefit obligations and changes in post-retirement benefit obligations. Actual results may differ from those estimates.

Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The following brief description is provided for general information purposes only. Participants should refer to the Summary Plan Description for more specific information.

General

California Ironworkers Field Welfare Plan is a health and welfare plan established by labor and employers through collective bargaining. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The benefits provided to active eligible members include a fee-for-service hospital, medical, dental, prescription drug and vision program; and a plan of insurance for life, accidental death and dismemberment. Active eligible members may select hospital and medical coverage under Kaiser Foundation Health Plan, Health Plan of Nevada, Managed Health Network, and United Health Care, and dental coverage under United Concordia Dental Plans, Delta Dental Plan, United Dental Care of Arizona, Inc., and Health Net Dental. The benefits provided to retired eligible members include a fee-for-service hospital, medical, dental, prescription drug and vision program or coverage under Kaiser Foundation, Health Plan United Health Care or Health Net, and OptumRx.

Establishment and maintenance of eligibility -

- a) An active participant working for a contributing employer is eligible for benefits on the first day of the second month that follows the completion of not more than four consecutive calendar months during which the active employee has worked at least 300 hours for a contributing employer(s). Eligibility for benefits will not begin until the first day of the fifth month, even if the active participant works 300 hours in the first one or two months.
- b) An hour bank is established by the Plan for each active participant and is composed of hours worked for contributing employers by the active participant. The maximum number of hours in an active participant's hour bank at any time shall in no event exceed 600. One hundred hours are deducted from an active participant's hour bank on the first of each month for which the active participant is eligible for benefits.
- c) An active participant's dependent becomes eligible on the later of:
 1. The date the active participant's eligibility is effective; or
 2. The date the active participant acquires the dependent.

An active participant's eligibility will terminate on the last day of the month in which the active employee's hour bank totals less than 100 hours, after deduction for the current month's coverage.

Active participants, upon losing eligibility for failure to work sufficient hours, are permitted to continue their medical coverage, including eligible dependents, according to COBRA (Consolidated Omnibus Budget Reconciliation Act) provisions of the Plan.

Retired participants are entitled to medical coverage for himself/herself and eligible dependents by making self-payments to the Plan within the time required by the rules, at a monthly cost established by the Trustees. The cost of the post-retirement benefit obligations is shared by the Plan's participating employers and retirees. In addition to deductibles and co-payments, for the years ended May 31, 2025 and 2024, 45% and 50%, respectively, of the estimated cost of providing post-retirement benefit obligations in the current and prior year is through retiree contributions.

3. PRIORITIES UPON TERMINATION

The Plan and the related trust may be terminated by the employers and the Union by an instrument in writing executed by mutual consent at any time, subject to the provisions of the Plan. Upon termination of the related trust, any monies remaining after the payment of all expenses and obligations shall be paid or used for the continuance of one or more benefits of the type provided by the Health and Welfare Trust, until such monies have been exhausted.

4. TAX STATUS

The Plan is exempt from income tax under Section 501(c)(9) of the Internal Revenue Code and under Section 23701(i) of the Revenue and Taxation Code of the State of California and, accordingly, the Plan is exempt from income taxes. The Plan has a favorable determination letter, dated October 12, 2016, from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan continues to operate in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of May 31, 2025 and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. POST-RETIREMENT BENEFITS

The post-retirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to May 31, 2025 and 2024, net of the estimated contributions from retired participants. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to participant service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. Post-retirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

Certain actuarial assumptions were changed since the prior valuation to reflect updated or anticipated experience. These valuation assumption changes decreased obligations by approximately \$261,000. This decrease was primarily due to an increase in the discount rate from 5.40% to 5.65% decreasing the postretirement benefit obligation by approximately \$11,300,000; and health cost trends were updated to reflect the latest economic conditions, which increased the postretirement benefit obligation by approximately \$11,000,000.

The weighted average health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, the obligations would increase as of May 31, 2025 and 2024, by \$46,126,611 and \$46,596,070, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-retirement benefit obligations.

7. SUPPLEMENTAL RETIREMENT BENEFIT

On August 15, 1999, the Board of Trustees of the Plan adopted Amendment No. 3 for the purpose of providing Supplemental Retiree Benefits (the "SRB") to active employees under the Welfare Plan. Under the SRB plan, each participant has an individual contribution account for the sole purpose of defraying self-payment requirements or payments for non-covered medical and dental expenses incurred as a retiree. Active employees may only use the SRB for COBRA premiums for themselves and for their eligible dependents. Upon retirement, the retiree can elect to have their individual account charged for all or a portion of the self-payment requirements or non-covered medical expenses. Should the member decease prior to his account depletion, the surviving spouse may continue to use the account for self-payment premiums or have the remaining amount paid in the form of a death benefit. For a single retiree, the account balance is paid as a death benefit to the designated beneficiary. Effective January 1, 2015, contributions were suspended to the SRB account. All assets of the SRB plan have been segregated in a separate investment account for the benefit of the participants with account balances as of the date that contributions were suspended to the SRB plan.

8. FUNDING POLICY

The Plan is financed by contributions from employers, active participants, retirees and members electing COBRA coverage. The monthly employer contribution rate is specified in the collective bargaining agreements. Participant, retiree and COBRA contribution rates are established periodically by the Plan's Board of Trustees.

During the years ended May 31, 2025 and 2024, the Plan received contributions from employers at the following predominant rates for each hour worked by participants:

9. RELATED ORGANIZATIONS

The Plan enters into various transactions with related Ironworker Trust Funds in the normal course of operations. Administrative services to the Plan are provided by Ironworker Employees' Benefit Corporation ("IEBC"), a not-for-profit organization, which provides administrative services to a group of member trust funds collectively known as the California Field Ironworkers Trust Funds.

Expenses attributable to the Plan's claims department and other identifiable expenses are charged directly to the Plan. Common administrative expenses are allocated to the Plan on a percentage basis. IEBC initially pays investment, operating and administrative expenses related to the Ironworkers Trust Funds. In addition, IEBC leases its facilities from a subsidiary of a related member trust fund and a portion of those lease costs are allocated to the Plan. Amounts reimbursed to IEBC for these expenses for the years ended May 31, 2025 and 2024, totaled approximately \$6,346,000 and \$6,478,000, respectively.
