INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Local 298 Annuity Fund

Opinion on the 2024 Financial Statements

We have audited the financial statements of the Local 298 Annuity Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

2023 Financial Statements

The financial statements of the Plan for the year ended December 31, 2023, were audited by other auditors whose report, dated October 6, 2025, expressed an unmodified opinion on those statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The 2024 supplemental Schedule of Administrative Expenses, Schedule of Assets Held at End of Year, Schedule of Reportable Transactions and Schedule of Delinquent Participant Contribution, referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year, Schedule of Reportable Transactions and Schedule of Delinquent Participant Contribution represent supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan’s management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

General

The following description of the Local 298 Annuity Fund (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document for a complete description of the Plan's provisions, which is available from Plan management.

The Plan is a multiemployer defined contribution benefit plan, established under the provisions of an Agreement and Declaration of Trust, as amended made as of 2001, between the Amalgamated Local 298 (the Union), and contributing employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Funding is provided by employer contributions in accordance with the individual collective bargaining agreements between contributing employers and the Union. Employer contributions are accounted for as exchange transactions. Employee participants may contribute through a salary reduction contribution in an amount equal to 1% and up to 15% of pre-tax wages. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with employer contributions, the participant's contributions made on his/her behalf, including salary reduction contributions, allocations of Plan earnings based on account balances, and a flat fee for administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants do not direct their investments.

Vesting

Participants are immediately vested in their contributions and contributions made on their behalf by their contributing employer plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to 50% of the amount in his or her individual account not to exceed \$50,000. The loans are secured by the balance in the participant's account. In prior years, the loan interest was generally 4.25% per annum. In 2024, loan interest has been determined at a rate equal to the prime rate as published in the Wall Street Journal plus one percent (1%) compounded monthly. In general, loans must be repaid monthly over a period of five years.

NOTE 1. DESCRIPTION OF THE PLAN (continued)

Payment of Benefits

Participants or their beneficiaries may receive a distribution of the vested portion of their account in the Plan in the event of termination of employment, death or attainment of age 65.

Termination of employment means that you have not been employed for a period of twelve consecutive calendar months. All distributions from the Plan will be made in a single lump-sum payment. If the vested account balance exceeds \$5,000, the participant must consent to the distribution before it may be made.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Investments - Investments in mutual funds are carried at fair value, which generally represents quoted market prices or net asset value of the fund as of the last business day of the year as provided by the investment custodian. The investments in limited partnerships are carried estimated fair value as determined by the partnership. Short-term investments are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-Responsive Investment Contract - The guaranteed investment contract is carried at contract value which equals deposits made plus interest created under the terms of the contract less withdrawals.

Participant Loans Receivable - Loans to participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Employer Contributions Receivable - Employer contributions due and not paid prior to year-end are recorded as contributions receivable. Allowance for credit losses is considered unnecessary and is not provided.

Payment of Benefits - Benefit payments to participants are recorded when paid.

Administrative Expenses - The Plan pays administrative expenses that consist primarily of administrative fees paid for payroll and related expenses and professional fees. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Reclassifications - Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation. These reclassifications had no effect on changes in net assets available for benefits.

NOTE 3. TAX STATUS

The Plan obtained its latest determination letter on September 29, 2011, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) and was, therefore, exempt from Federal income taxes under the provisions of Section 501(a). The Plan has been amended since the last submission for determination. The Plan Trustees and Plan Counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 4. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 5. RELATED PARTY TRANSACTIONS

Administrative Expenses

The Plan shares office space with these related organizations and these entities reimburse the Eastern States Joint Board for their share of shared administrative expenses. Shared administrative expenses are allocated based on cost sharing agreements between the Plan and related organizations.

NOTE 5. RELATED PARTY TRANSACTIONS (continued)

The Plan reimbursed the Eastern States Joint Board for payroll and administrative expenses in the amounts of \$6,256 and \$7,574 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024, the Plan had a payable amount due to the Eastern State Joint Board for administrative expenses in the amount of \$30. At December 31, 2024, the Plan had a receivable amount due from the Eastern State Joint Board for payroll expenses in the amount of \$584.

Certain plan investments are managed by Vanguard and Empower. Vanguard and Empower are custodian's for the Plan and therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental Schedule of Assets Held at End of Year and the Schedule of Reportable Transactions.

The transactions identified above qualify as transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

- (a) Boyd Watterson GSA Fund LP: The Fund was formed to operate as a perpetual life, open-end, commingled collective investment fund and intends to invest primarily in real estate primarily leased to the U.S. federal government either through the General Services Administration ("GSA") or other federal government agencies. The Partners may request that the Fund redeem all or a portion of their units by delivering written notice to the Fund. Unless waived by the General Partner, partial redemptions of units are only permitted in increments of \$250,000. The General Partner will fulfill redemption requests based on the Fund's available cash, as determined by the General Partner. The Fund may defer redemptions if there is insufficient available cash to fulfill redemption requests. The General Partner assesses available cash on a quarterly basis and fulfills outstanding redemption requests based on the outcome of that assessment.

- (b) U.S. Real Estate Investment Fund, LLC: The Fund's investment objective is to primarily invest in a pool of real estate assets that are diversified by geography and property type, with a focus on yield-driven investments and on value-added investments. The Fund is a limited liability company organized under the laws of the State of Delaware pursuant to the Delaware Limited Liability Company Act. Investments are stated at fair value, which is based on appraisals performed at least annually by independent third party appraisers. The Fund has a quarterly liquidity with no notice required. Proceeds are transferred as funds become available.

NOTE 7. GUARANTEED INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive group annuity contract with Empower (formally Prudential). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for employer withdrawals and administrative expenses. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by employer if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Employer may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 7. GUARANTEED INVESTMENT CONTRACT (continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the employer.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 8. RISK AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, sector and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through March 5, 2026, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
