## **Independent Auditors' Report**

To the Plan Administrator

Jewish Family and Community Services, Inc.):

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed the audit of the financial statements of Gulf Coast JFCS 403(b) Plan (f/k/a 403(b) Thrift Plan of Gulf Coast Jewish Family and Community Services, Inc.) (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of June 30, 2024 and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental Schedule of Delinquent Participant Contributions for the year ended June 30, 2024 and the Schedule of Assets (Held at End of Year) as of June 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Predecessor auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated April 15, 2024, indicated that they did not express an opinion on the 2023 financial statements as they were unable to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion. Their report also indicated that because of the significance of the matters described in the Basis for Disclaimer of Opinion section of their report, it was inappropriate to and they did not express an opinion on the supplemental schedules.

**Notes to Financial Statements**

**June 30, 2024 and 2023**

**(1) Description of Plan**

The following description of the Gulf Coast JFCS 403(b) Plan (f/k/a 403(b) Thrift Plan of Gulf Coast Jewish Family and Community Services, Inc.) (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

**(a) General**

The Plan is a defined contribution plan sponsored by Gulf Cost Jewish Family and Community Services, Inc. (the “Organization”) for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective April 1, 2024, the Plan was amended and restated with the adoption of a new prototype 403(b) plan document sponsored by Principal Life Insurance Company (“PLIC”). All assets were transferred from Mutual of America Life Insurance Company (“MOA”) to Principal Trust Company (“PTC”) with the exception of an immaterial amount of assets that cannot be transferred due to certain contract restrictions. As of that date, PTC serves as the custodian and PLIC serves as the recordkeeper of the Plan. Through April 1, 2024, MOA served as custodian and recordkeeper of the Plan. Through January 31, 2024, certain assets were held by The Variable Annuity Life Insurance Company (“VALIC”) until being transferred to MOA. Therefore, VALIC served as custodian and recordkeeper of those assets through the date of transfer to MOA. MOA continues to serve as custodian of the immaterial assets that were not transferred to PTC.

In conjunction with the restatement of the Plan, the Plan’s name was changed to Gulf Coast JFCS 403(b) Plan.

**(b) Contributions**

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Organization contributes 25% of the first 8% of base compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

**(c) Participant Investment Account Options**

The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**(1) Description of Plan - Continued**

**(d) Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization matching contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(e) Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service. Regardless of the vesting schedule, a participant becomes 100% vested in the event the participant dies, becomes disabled or reaches early retirement age (defined as age 55) while employed with the Organization.

**(f) Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the loan administrators, as defined in the Plan. Principal and interest are paid ratably through payroll deductions.

As of June 30, 2023, participants borrowed directly from MOA using a portion of their plan account as security for the loan. The plan administrator concluded that these loans are not plan assets and that such arrangements are exempt transactions. Plan loans totaled \$131,548 at June 30, 2023. Under the borrowing terms, \$157,858 of plan assets served as collateral for the plan loans as of June 30, 2023.

**(g) Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the vested interest in his or her account. The Plan contains a mandatory distribution provision which states that if the value of a terminated participant's vested interest in his or her account does not exceed \$7,000, then the entire amount shall be automatically rolled over to an IRA in the participant's name in a lump sum if the participant does not make an alternative election. Further, if the value of a terminated participant's vested interest in his or her account is \$1,000 or less, the vested account balance will be automatically distributed to the participant in a lump sum, even if the participant does not consent. The Plan also provides for in-service withdrawals for those age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

**(h) Forfeited Accounts**

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$3,244 and \$0, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. Also, for the year ended June 30, 2024, \$6,989 of forfeited nonvested accounts were used to reduce employer contributions.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**(c) Investment Valuation and Income Recognition**

Investments are reported at fair value, except for one of the fully benefit-responsive guaranteed investment contracts which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**(d) Contributions**

Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which participant compensation is earned.

**(e) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

**(f) Payment of Benefits**

Benefits are recorded when paid.

**(g) Administrative Expenses**

Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**(3) Information Prepared and Certified by the Custodians**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. MOA held substantially all of the Plan's investment assets and executed substantially all investment transactions from July 1, 2023 through April 1, 2024. VALIC held the remainder of the Plan's investment assets and executed the remainder of the Plan's investment transactions from July 1, 2023 through January 31, 2024, at which point such assets were transferred to MOA. PTC held the Plan's investment assets and executed investment transactions from April 1, 2024 to June 30, 2024. Accordingly, the custodians of the Plan have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Mutual funds, at fair value
- Pooled separate accounts, at fair value
- Guaranteed investment contract, at fair value
- Guaranteed investment contract, at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest income on guaranteed investment contract
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**(4) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the daily closing price of the underlying actively traded mutual funds held by the pooled separate account less its liabilities as provided by the custodian of the pooled separate account.

*Guaranteed Investment Contract (Not Fully Benefit-Responsive):* Valued at fair value by the issuer by discounting the related cash flows based on current published yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

**(5) Fully Benefit-Responsive Investment Contract**

Prior to the transfer of assets to PTC, the Plan had a fully benefit-responsive guaranteed investment contract with MOA. MOA maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 3%.

The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by MOA, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. As of June 30, 2023, no events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants. The guaranteed investment contract was terminated with the transfer of assets from MOA to PTC.

**(6) Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Principal. Principal is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

Certain Plan investments are units of pooled separate accounts managed by MOA. MOA is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

**(7) Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**(8) Tax Status**

Effective April 1, 2024, the Plan has adopted a prototype 403(b) plan document provided by PLIC. The Internal Revenue Service ("IRS") has determined that the prototype plan document is designed in accordance with applicable sections of the IRC and informed PLIC of such in a letter dated March 31, 2017. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

From July 1, 2023 to April 1, 2024, the Plan adopted a prototype plan document provided by MOA. The IRS determined that the prototype plan document was designed in accordance with applicable sections of the IRC and informed MOA of such in a letter dated March 31, 2017. Although the Plan had been amended since receiving the opinion letter, the plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC.

**(8) Tax Status - Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(9) Risks and Uncertainties**

The Plan invests in various investment securities. Plan investments are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(10) Subsequent Events**

The Plan has evaluated subsequent events through August 4, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
