## INDEPENDENT AUDITORS' REPORT

**NOTE 1 - DESCRIPTION OF THE PLAN**

Nuckles Oil Co. Inc. DBA Merit Oil Co, And & Van Dyk Tank Lines Inc. DBA Cool Transport Retirement Plan (the Plan) is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The original Plan was effective July 1, 1998. The Plan was amended and restated effective May 1, 2019. The Plan is sponsored and administered by Nuckles Oil Co. Inc. DBA Merit Oil Co. (the Company). Van Dyk Tank Lines Inc. DBA Cool Transports is the participating employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants and other interested parties should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility

All of the employees of the Company and participating employer shall become eligible to participate in the deferral component of the Plan if they are at least 21 years old and have completed two months of service hours during the eligibility computation period. Participants are eligible for the discretionary employer match after completing a 12 consecutive month period of service and during which at least 1,000 hours of service are completed. A participant may enter the Plan for the purposes of the discretionary employer match on the 1st day of the 1st and 7th month of the plan year coinciding with or next following date requirements met.

Contributions

Participants may elect to defer salary in an amount not to exceed 90% of their total eligible compensation in pre-tax or Roth deferrals, as defined in the plan document; subject to Internal Revenue Service limitations. Participants may also roll over amounts representing distributions from other qualified plans. The Plan does not have the automatic enrollment feature. Participant who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company did not make a profit sharing contribution to the plan during the year ended June 30, 2025.

The Company has elected to make fixed matching contributions of 50% on the first 8% or \$4,000 of a participant's eligible compensation which is deferred as an elective deferral.

Participant Accounts

A participant's account is credited with the participant's contributions, allocations of (a) the Company's matching and profit sharing contributions and (b) plan earnings. A participant's account is debited with an allocation of plan losses and charged with administrative expenses; as applicable. Allocation of earnings or losses are based upon participant account balances. Allocation of the Company's matching contributions are based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon at all times. Participants vest in employer matching and profit sharing contributions based upon the following schedule:

<u>Years of Vested Services</u>	<u>Percentage Vested</u>
Less than 2 years	0%
At least 2, but less than 3	20%
At least 3, but less than 4	40%
At least 4, but less than 5	60%
At least 5, but less than 6	80%
6 or more	100%

The full amount credited to a participant's account shall be fully vested upon attaining normal retirement age, death, or by reason of permanent disability.

Notes Receivable from Participants

Effective May 1, 2019, loans are not permitted under the Plan.

Payments of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment. A participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution. For terminations due to death, the value of the vested interest may also be paid in installments. The Plan allows for in-service distributions once a participant reaches normal retirement age, defined as the attainment of age 62 of Plan participant. The Plan also allows for hardship distributions subject to Plan provisions.

If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment to be distributed to the participant directly, less any applicable taxes. If the balance is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participants name.

On December 29, 2022, the SECURE 2.0 Act was signed into law, resulting in significant changes to the required minimum distribution (RMD) rules applicable to retirement plans. Effective January 1, 2023, the age at which plan participants must begin taking RMDs increased from age 72 to age 73. In addition, beginning in 2024, Roth accounts in employer-sponsored retirement plans are no longer subject to RMDs during the participant's lifetime.

Forfeitures

As of June 30, 2025, forfeitures of non-vested accounts totaled \$130. Forfeitures of non-vested plan sponsor matching contributions are retained in the Plan and may be used to reduce employer contributions and pay plan expenses. For the years ending June 30, 2025 and 2024, employer contributions and plan expenses were reduced by \$16,336 and \$10,796, respectively, from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through February 23, 2026, the date the financial statements were available to be issued and concluded that there were no events that require recording or disclosure in the financial statements as of June 30, 2025.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*

Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of June 30, 2025 and 2024:

*Mutual funds* : Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective investment trusts*: Valued at the NAV of units held by the Plan at year-end, which is considered by plan management to be the best approximation of fair value. The unit values of these investments are calculated based on the collective fair values of the underlying investments. There are no notable restrictions on the redemption of investments held in the fund.

*Self-directed brokerage accounts*: Brokerage securities are composed of common stocks. Common stocks are valued at the closing price reported in the active market in which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan paid certain administrative fees in 2025. The Company paid certain administrative expenses of the Plan, including recordkeeping and audit fees. These transactions qualify as party-in-interest transactions for which a statutory exception exemption exists.

**NOTE 6 - PLAN TERMINATION**

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants will become 100% vested in all Company contributions.

**NOTE 7 - TAX STATUS**

The Company has adopted a prototype plan document subject to a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, and the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 - CORRECTIVE DISTRIBUTIONS**

During the year ended June 30, 2025, compliance testing conducted by the third-party administrator revealed that participants made elective deferrals to the Plan that exceeded IRS limits. A total corrective refund of \$19,470 was identified. The Plan sponsor is currently working with the third-party administrator to finalize the amount for processing.
