To the Board of Trustees:

**Opinion**

**Independent Auditor's Report**

To the Board of Trustees:

**Opinion**

We have audited the financial statements of Abatement Workers National Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years ended May 31, 2025 and 2024 and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and of benefit obligations of Abatement Workers National Health and Welfare Fund as of May 31, 2025 and 2024, and the changes in its net assets available for benefits and in benefit obligations for the years ended May 31, 2025 and 2024, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

### 1. Description of Plan

The following description of Abatement Workers National Health and Welfare Fund provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### General

The Plan is a multi-employer collectively bargained plan providing health and other benefits to eligible participants and covered dependents. Retired participants are entitled to similar benefits. The Plan was established August 1, 1991 as a result of collective bargaining between Local Union 207 of the International Association of Heat and Frost Insulators and Allied Workers (union) and the Abatement Contractors Association, Inc (employers). The Plan provides benefits for eligible participants and their dependents and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

The eligibility rules of the Plan provide for insurance coverage for participants who have worked a sufficient number of hours during a specified period. Participants who are unemployed may self-pay for lack of hours worked, providing they are first eligible for benefits through previous employer contributions and have satisfied the initial eligibility requirements for active employees or draw on their own hour bank. Additionally, full-time employees of the union or supervisory employees of a contributing employer who have elected to contribute on behalf of such employees approved by the board of trustees are eligible. Retirees and surviving spouses are provided coverage on a self-pay basis only.

#### Contributions

The Plan is funded through contributions from employers and participants. The employer rates are specified in the collective bargaining agreement. The agreement provides for employers to contribute to the Plan on the basis of participants' hours worked. Participants' self-pay contribution rates are determined by the Board of Trustees based on the participant's status as an active member, a retiree or a surviving spouse. The monthly self-pay contribution rates for active and retired members range from \$373 to \$1,549.

#### Benefits

The plan provides health benefits (medical, dental, vision and prescription drug), life insurance, short and long term disability benefits, and accidental death and dismemberment benefits. Retired employees are entitled to similar health benefits in excess of Medicare coverage. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

## Notes to Financial Statement

### 1. Description of Plan -continued

#### Self Insured Benefits

Disability, vision and dental benefits are self-insured and paid from the general assets of the Plan. Vision and dental benefits are processed by the Plan's third party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed from the general assets of the Plan. Despite the Plan's utilization of third party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

#### Insured Benefits

The plan fully insures medical, prescription, retiree medical supplemental insurance and life insurance benefits. The plan purchases annual insurance contracts for these insured benefits.

### 2. Summary of Accounting Policies

#### Basis of Accounting and Use of Estimates

The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Payment of Benefits

Premiums are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Dental, vision and disability payments are recorded when paid by the third party claims processor. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits. Amounts due to claims processors that have yet to be reimbursed by the plan are recorded as claims payable in the accompanying statements of plan's benefit obligations.

#### Employers' Contributions Receivables

Contributions receivable are reported at their outstanding balances due from employers. At May 31, 2025 and 2024 respectively all contributions receivable were deemed collectable.

### 2. Summary of Accounting Policies

- continued

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during year.

#### Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors report, the date the financial statements were available to be issued.

### 3. Postretirement and Post-Employment Benefit Obligations

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. In addition, a post-employment benefit obligation has been recognized for health and welfare benefits for individuals currently on short term disability. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from employers, participants and from existing assets of the Plan. Post-retirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following were other significant assumptions used in the valuation as of May 31, 2025 and 2024.

Weighted-average discount rate 5.50% in 2025 and 5.25% in 2024.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of May 31, 2025 and 2024 by \$167,673 and \$156,973 respectively.

Changes in actuarial assumptions from May 31, 2024 and incorporated into this valuation were as follows:

- The discount rate was increased from 5.25% to 5.50%.
- Non-Medicare, Medicare and Dental per capita health costs were updated.
- Retiree contribution rates were updated.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

#### 4. Claims Incurred But Not Reported and Accumulated Eligibility Reserve

Plan obligations at May 31 for claims incurred but not reported are estimated by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment. Plan obligations for accumulated eligibility are estimated and reported in the accompanying statement of Plan's Benefit Obligations at present value utilizing a 5.50% discount rate. There is no plan obligation for claims incurred but not reported at May 31, 2025 and 2024, since the plan became fully insured.

#### 5. Fair Value Measurements

##### Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

### 5. Fair Value Measurements - continued

#### Money Market Funds

Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

#### U.S. Government Securities and Federal Agency Obligations:

Valued using pricing models maximizing the use of observable inputs for similar securities.

### 6. Administrative Expenses

The Plan pays for all administrative expenses. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

### 7. Reciprocity

The plan has entered into reciprocity agreements with various local unions. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of employees to and from the employees' participation local unions.

For the year ended May 31, 2025, the amount received was under reciprocity agreements was \$284,423 and the amount paid out was \$1,063. These amounts are netted against employer contributions in the statement of changes in net assets available for benefits.

**8. Plan  
Amendment**

The Trustees adopted changes to the Plan which changed contribution hours from 150 to 145 in order to continue eligibility, to reduce maximum bank from 600 to 580 and initial eligibility from 450 to 435. Dental coverage max increased from \$1,800 to \$2,300 per plan year. Allow \$150 reimbursement every 12 months for low dose CAT scan. Adopt the 14<sup>th</sup> amendment regarding USERRA continuing coverage. Approve the termination of the hour bank when a member declines employment.

**9. Tax Status**

The Plan received an exemption letter from the Internal Revenue Service stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, State or Local taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**10. Priorities Upon  
Termination  
of the Plan**

Although it has not expressed any intention to do so, the Board of Trustees, as sponsor, has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and non-discriminatory manner toward the provision of benefits for or on account of the participants. No assets of the plan may revert to any employer or be used for purposes other than for the exclusive benefit of the plan's participants.

As described in Note 6, the Plan paid certain expenses related to plan operations to various service providers. These transactions are considered exempt party in interest transactions under ERISA.

### 13. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Cash consists of monies held in non-interest-bearing transaction accounts. The plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At May 31, 2025 and 2024, the plan's cash exceeded federally insured limits by approximately \$1,795,402 and \$2,433,000.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
