1. Description of Plan

The following description of the Constellis Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

Constellis, LLC (the "Company") established the Plan effective January 1, 2017. The Plan is a defined contribution plan covering certain employees of the Company that are covered under collective bargaining agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Company has entered into an agreement whereby, Reliance Trust Company (the "Trustee") has been appointed the Trustee of the Plan's assets. Under the terms of the agreement, the Trustee holds and invests the funds of the Plan.

Plan merger:

Effective January 1, 2019, the Plan was merged into the Constellis 401(k) Plan, a defined contribution plan sponsored by Constellis, LLC. In connection with the merger, all participant account balances, rights, and obligations under the Plan were transferred to the Constellis 401(k) Plan in accordance with the terms of the merger agreement and applicable regulations. The merger did not result in any reduction of accrued benefits to participants. The total net assets transferred as of the merger date were \$5,155,955 and are reflected as Transfer out on the accompanying Statement of changes in net assets available for benefits. Following the merger, no additional contributions are made to the Plan, and all ongoing plan activity related to participants is reflected in the Constellis 401(k) Plan.

Contributions:

There are no elective participant contributions made to the Plan. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes contributions to the Plan according to terms that are outlined in the respective collective bargaining agreements. Those collective bargaining agreements assign employees an hourly health and welfare benefit rate. Each pay period, a total health and welfare contribution is calculated based on the number of hours worked. The amount of the contribution is reduced by elected insurance and other benefits, with the net amount remitted to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. There were no contributions made to the Plan during the period ended March 14, 2019.

Participant accounts:

Each participant's account is credited with the Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Hardship withdrawals and in-service withdrawals at age 59.5 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time.

1. Description of Plan (continued)

Forfeited accounts:

The Plan provides for immediate vesting of all participant accounts; therefore, forfeitures do not arise from ongoing plan operations. As of December 31, 2018, the Plan held a forfeiture account balance of \$25, which was attributable solely to a transfer in from a prior year plan conversion. During the year ended March 14, 2019, the entire forfeiture account balance was transferred out to the Constellis 401(k) Plan in connection with the plan merger effective January 1, 2019.

2. Summary of Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements. All Plan assets were transferred to the Constellis 401(k) Plan before close of business on March 14, 2019.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through March 3, 2026, the date the financial statements were available to be issued. See Note 10 for discussion of subsequent events.

3. Information Certified by Trustee

The March 14, 2019, and December 31, 2018, Statements of net assets available for benefits, the investment activities included on the Statement of changes in net assets available for benefits for the period ended March 14, 2019, and the accompanying notes to the financial statements were prepared in part or entirely from information certified as complete and accurate by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and

Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$4,919,491 at March 14, 2019, and December 31, 2018, respectively, and the net appreciation in fair value of investments and dividends and interest income of \$78,754 for the period ended March 14, 2019.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2018.

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts – Common collective trusts are valued based on the information reported by the investment advisor using the audited financial statements of the common collective trust at year-end. The Plan's investments in collective interest trusts are valued based upon the net asset value of units owned by the Plan at year-end. The fair value of the Plan's investments is based on the net asset values of the underlying open-end mutual funds.

5. Transamerica Stable Value Fund

The Financial Life Insurance Company Stable Value Option investment is available through a contract issued by Transamerica Life Insurance Company ("TLIC") held in an Expense Benefit Account. The group annuity contract is considered fully benefit-responsive, with the Trustee as the contract holder and no participant investment. The contract is valued at contract value, which represents contributions plus earnings, less benefits and expenses. The assets in the general account are supported by the financial stability of TLIC which is contractually obligated to repay principal and a specified interest rate to the Plan. No events limiting transactions at contract value are considered probable. As of March 14, 2019, there were no plan assets held in the Financial Life Insurance Company Stable Value Option investment and the contract between the Plan and TLIC was discontinued.

6. Related Party Transactions

Certain Plan investments and related transactions were in investment funds managed by the Plan's Trustee and, therefore, these investments and transactions qualify as party-in-interest transactions. These transactions are not considered prohibited by statutory exemptions under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. As described in Note 1, the Plan was merged into the Constellis 401(k) Plan, effective January 1, 2019. Consequently, all employees eligible under the Plan became eligible to participate in and make contributions to the Constellis 401(k) Plan. All assets were transferred as of March 14, 2019 and Plan management believes it has structured the transfer in a manner that does not constitute a plan termination. Participant account activity subsequent to the effective date of the merger will be transacted under the Constellis 401(k) Plan.

8. Tax Status

The volume submitter profit sharing plan received a favorable tax determination letter dated March 31, 2014 from the IRS. Although the Plan itself has not received a determination letter and the volume submitter profit sharing plan has been amended since receiving that determination letter, Company management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and is tax-exempt.

8. Tax Status (continued)

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of net assets available for benefits.

10. Subsequent Events

On December 29, 2022, the Setting Every Community Up for Retirement Act ("SECURE") 2.0 Act of 2023 was signed into law as part of the Consolidated Appropriations Act, 2024. The SECURE 2.0 Act includes numerous reforms to existing retirement law intended to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and simplify and clarify retirement plan rules, with provision effective dates ranging from immediate to 2024 and beyond. All provisions of SECURE 2.0 will be evaluated and implemented in accordance with future regulations and guidance, and the Constellis 401(k) Plan will be amended as needed.
