Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The IBEW Local 234 Health and Welfare Trust (the "Fund") is a multiemployer welfare benefit plan that provides medical, vision, dental, prescription, life insurance and accidental death and dismemberment benefits to its eligible participants. The Fund exists under an Amended Agreement and Declaration of Trust between the International Brotherhood of Electrical Workers Local Union No. 234 and the Monterey Bay California Chapter - NECA, dated December 11, 1975. The Fund includes San Benito, Santa Cruz and Monterey Counties. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Fund are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year at hourly contribution rates agreed to in the collective bargaining agreements. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

D. Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

E. Tax-Exempt Status

The Fund has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. The Fund's administrator and legal counsel believe that the Fund is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for federal or state income tax is made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Postretirement Benefits

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to May 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligations are the portion of the expected postretirement benefit obligations attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations was determined by actuaries from Rael & Letson and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used in 2025 (2024): (a) Discount Rate: 5.75% (5.50%), (b) Participation Rate for future retirees: 75%, (c) Mortality: 95% of RP-2014 Blue Collar table and 105% of RP-2014 Disabled Table, (d) Medical and drug trend rates of 7.00% at year 1 graded to 4% by 2037 and dental and vision trends at 4% in all years, and (e) other assumptions and methods for retirement rates, mix of types of retiree coverage, trend rates and per capita cost assumptions.

The following changes in actuarial assumptions had the net effect of increasing the liability: (a) Discount rate increased from 5.50% to 5.75%, and (b) increased medical/drug and self-pay trend rates.

The health care cost trend rate has a significant effect on the postretirement benefit obligation. A 1% increase in the health care cost trend rate would increase the net postretirement benefit obligation as of May 31, 2025 and 2024 by \$4,996,400 and \$4,649,500, respectively.

The foregoing assumptions are based on the presumption that the Fund will continue. Were the Fund to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

NOTE 3 - INVESTMENT VALUATION AND INCOME RECOGNITION

FASB ASC 820 provides the framework for measuring fair value that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

NOTE 3 - INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Level 1 investments consist of mutual funds and an exchange traded fund recorded at fair value based on quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Realized and unrealized gains and losses are computed using investments' costs for financial statement purposes. For Form 5500 reporting, realized and unrealized gains and losses are computed using investments' market values as of the beginning of the year.

NOTE 4 - RISKS AND UNCERTAINTIES

Fund investments are exposed to various investment risks such as interest rate, market fluctuations and credit risk. Due to the level of risk associated with investments and level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

Estimates for premiums and claims payable, claims incurred but not reported, accumulated eligibility and postretirement benefit obligations are based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements

NOTE 6 - PLAN TERMINATION

Upon termination of the Fund, the Fund shall pay any and all obligations and apply the remaining assets in such manner as will best effectuate the purposes of the Fund.

NOTE 7 - CONCENTRATION OF CREDIT RISK

During the year ended May 31, 2025, the Fund maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Fund has not incurred any losses on the uninsured balances.

NOTE 8 - MEDICARE PART D SUBSIDY REFUNDS

The effect to the Medicare Prescription Drug, Improvement, and Modernization Act on the Fund was determined based on the actuary's interpretation of the current regulations and guidance. The benefits provided under the Fund are at least actuarially equivalent to Medicare Part D benefits. Thus, the Fund was eligible for the Medicare Prescription Drug subsidy beginning 2006. The Medicare subsidy received by the Fund for the years ended May 31, 2025 and 2024 was \$70,935 and \$34,473, respectively.

NOTE 9 - HEALTH REIMBURSEMENT ACCOUNTS

Effective January 1, 2017, the Fund implemented Health Reimbursement Accounts (HRA) to permit active participants to obtain reimbursement of specified insurance benefits on a non-taxable basis. The following reflects activity in the HRA program:
