Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and to certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 **DESCRIPTION OF PLAN**

The following brief description of the TENAX Technologies 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is an employer defined contribution plan, covering all employees of TENAX Technologies, LLC (Company). Employees are automatically enrolled into the Plan upon completion of one hour of service unless they affirmatively elect otherwise. Nonresident aliens are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code (IRC) including catch-up contributions if applicable. Participants who are 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may designate some or all of their own contributions as Roth 401(k) contributions. Participants may also rollover distributions received from other qualified plans.

The Company makes safe harbor matching contributions for non-union and certain union active participants in the plan equal to 100% of a participant's elective deferrals that do not exceed 1% of compensation, plus 50% of the amount of the participant's elective deferrals that exceed 1% of the participant's eligible compensation but that do not exceed 6% of the participant's eligible compensation. Additionally, the Company may elect, at its sole discretion, to make an additional discretionary matching contribution. The Company did not make discretionary matching contributions during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor and discretionary matching, and an allocation of any Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

(See Independent Auditors' Report)

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan terms may not exceed five years unless the proceeds are used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. Loans bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Loans are repaid through payroll deductions and may be repaid in full at any time. Participants may have a maximum of one outstanding loan at any one time.

Vesting

Participants are immediately vested in their voluntary and rollover contributions, plus actual earnings thereon. Vesting in the Company's safe harbor and discretionary matching contributions, plus earnings thereon, is based on years of service. A participant becomes fully vested in the employer safe harbor and discretionary matching and profit-sharing contributions after one year of service.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's interest in the participant's account with certain exceptions allowed. Benefits from the Plan for terminated participants whose vested account balances are less than \$5,000 and who do not make payment elections shall be rolled over to individual retirement accounts designated by the Plan Administrator.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,624 and \$13,884, respectively. These accounts may be used to pay Plan expenses, reduce employer contributions, or be used as additional employer contributions. During the year ended December 31, 2024, \$10,565 from forfeited non-vested accounts was used to pay Plan expenses.

Administrative Expenses

The Plan's administrative expenses are paid by the Company as provided by the Plan Agreement. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in the net change in investments.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Valuation of Investments

Investments are reported at fair value, except for fully benefit responsive investment contracts which are reported at contract value. See Note 4 for a discussion of fair value measurements.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through March 5, 2026, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan's investments were held by the Custodian, John Hancock Life Insurance Company, at December 31, 2024. Financial information related to those investments is included in the accompanying financial statements based on information certified by the Custodian as complete and accurate. The information was not audited by the Plan's independent auditors. As of December 31, 2024, certified investment information consisted of the following:

NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

(See Independent Auditors' Report)

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan obtained its latest determination letter on November 30, 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator has concluded that there were no uncertain tax positions taken as of December 31, 2024.

NOTE 6 **PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Custodian of the Plan. The Plan paid approximately \$6,000 to parties in interest for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
