NOTES TO FINANCIAL STATEMENTS

As of March 31, 2025 and 2024

NOTE 1: DESCRIPTION OF PLAN

The following description of the Metro West Ambulance Service Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees who have completed one year of service and 1,000 or more hours of service with Metro West Ambulance Service, Inc. and subsidiaries (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute a percentage of their annual compensation, as defined in the Plan, not to exceed the limits set forth by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a matching contribution equal to 100% of the first 5% of the participant's compensation per pay period which is deferred and contributed to the Plan by the participant. Matching contributions are made on an annual basis. Additional amounts may be contributed to the Plan at the option of the Company's board of directors and are invested at the participant's direction. Contributions are subject to certain limitations.

Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer non-elective contributions and related earnings are based on participants' years of continuous service with full vesting after six years. Vesting in the Company's matching contribution portion of their account plus actual earnings thereon is also determined based on years of continuous service. Amounts subject to the graduated vesting schedule are vested on a three-year cliff with full vesting after completion of three years of credited service.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits:

Following termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or applied to the purchase of an annuity contract. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. There were no amounts allocated to accounts of persons who, at the financial statement date, had elected to withdraw from the Plan but have not been paid as of March 31, 2025 and 2024, respectively.

Forfeited accounts:

As of March 31, 2025 and 2024, forfeited non-vested accounts totaled \$13,646 and \$16,497, respectively. These accounts are used to reduce employer contributions. The amount of forfeitures applied to the employer match for the years ended March 31, 2025 and 2024 was \$0. Employer contribution expense for the years ended March 31, 2025 and 2024 before application of forfeitures was \$1,104,644 and \$1,150,447, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of managements review:

The Plan has evaluated subsequent events through February 5, 2026, the date the financial statements were available to be issued.

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for loan losses has been recorded as of March 31, 2025.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not distribute the March 31, 2025 and 2024 excess contributions to the applicable participants prior to regulated deadlines.

Investment valuation and income recognition:

All Plan investments as of March 31, 2025 and 2024 are held by The Standard, the Plan custodian. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3: FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3: FAIR VALUE MEASUREMENTS (Continued)

FASB ASC 820-10, Fair Value Measurement and Disclosure, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are derived principally from, or corroborated by, observable market data by correlation or other means, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. As of March 31, 2025 and 2024, the Plan did not hold any investments measured by the inputs in the fair value hierarchy.

NOTE 4: INVESTMENTS

For the plan year ending March 31, 2025, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$1,787,764, which was all attributable to pooled separate accounts.

NOTE 5: RELATED PARTY AND PARTY-IN-INTEREST

ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are investment contracts managed by The Standard. The Standard is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, however they are exempt from the prohibited transaction rules under ERISA. The Standard receives revenue from mutual fund service providers for services The Standard provides to the funds. This revenue is used to offset certain amounts owed to The Standard for its administrative services to the Plan.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7: TAX STATUS

The Company has adopted a prototype plan document and is relying on the prototype sponsor's determination letter from the Internal Revenue Service dated March 31, 2008. The letter states that the prototype and related trust, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the prototype plan has been amended since receiving the determination letter, the prototype sponsor and the plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: NONEXEMPT TRANSACTIONS

As reported on Form 5500, Schedule H, Line 4a, Schedule of Delinquent Participant Contributions, certain participant contributions were not remitted to the Plan within the period specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company. Late remittances amounted to \$1,848,975 and \$1,135,635 for the March 31, 2025 and 2024 plan years, respectively, and they have been corrected as of the date of issuance of this financial statement.
