Note 1 - Description of the Plan

The Central Management Company, LLC Employee Benefit Plan is a defined benefit plan, established September 1, 2016. It is a contributory health care plan that provides hospitalization, medical, dental, vision, short-term disability, long-term disability and death benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Only full-time employees (employees regularly scheduled to work an average of 30 hours per week) of the Company are eligible for enrollment in the Plan. There are eleven separate classes of employees, who consist of owners, registered nurses, administrators, licensed practical nurses and office administrative staff. The waiting period is a period of 60 consecutive days as an active employee beginning on the first day of employment in an eligible class. Enrolled employees may select individual or tiered family coverage. The plan also provides continuation coverage as required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for qualified beneficiaries who would otherwise have lost coverage under the plan.

The Plan provides benefits through a funding arrangement that includes a trust, which is funded by the plan sponsor and/or the participating employees, and with insurance to protect the Plan against unpredictable excess claims. Contributions to the Plan are made both by enrolled employees and by the employer. The trustee of the Plan determines the amount of employee contributions, and the employer contributes the balance necessary to adequately fund the benefits paid to participants and administrative expenses of the Plan. Former plan participants covered under COBRA make contributions to the plan for continuation of health coverage.

The Plan is self-insured for medical benefits up to a stop-loss limit of \$200,000 per individual per year. The stop-loss insurance contracts also include aggregate loss provisions that cover the combined claims for all participants of the plan when the qualified claims for the plan year exceed the stated amount. The stated amount under the aggregate loss provisions was approximately \$6,765,946 as of August 31, 2025.

An outside administrator, IMA, Inc. (IMA), processes the claims for medical benefits and, on behalf of the trustee, disburses claim payments due in accordance with the provisions of the Plan to the participant or assignee entitled thereto. The Plan offers self-insured dental and vision benefits also administered by IMA, Inc. on behalf of the trustee.

Note 1 - Description of the Plan (continued)

The Company believes the Plan will continue without interruption but reserves the right to terminate the Plan at any time. Upon termination of the Plan, priorities of distributions have been established in accordance with the requirements of ERISA. If applicable, all previous contributions to the trust shall continue to be used for payment of benefits under the Plan until such contributions are exhausted.

The Plan trustee is the fiduciary of the Plan, with full authority to control and manage the operation and administration of the Plan.

Although it has not expressed the intent to do so, the Plan Sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Funds contributed to the Plan are irrevocably restricted for the use and provision of benefits to company employees.

The foregoing description of the Plan provides only general information. Employees should refer to the Summary Plan Description & Plan Document for a more complete description of the Plan's provisions.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition – Investments, if any, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the plan's valuation policies utilizing information provided by the investment custodians. See Note 7 for discussion of fair value measurements.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein; claims incurred but not reported; eligibility credits; claims payable; and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual Results could differ from those estimates.

Payment of benefits – Health claims and insurance premiums are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Cash – Cash in the Plan consists of cash held in a noninterest-bearing bank account. Checks issued in excess of available balances are included in accounts payable and accrued liabilities. Claims of the Plan are handled by its third-party administrator, IMA. IMA pays all of the claims through an account held on behalf of the Plan.

Benefit obligations – Benefit claims currently payable include the Plan's liability for claims incurred and processed before August 31, 2025. The Plan's liability for claims incurred but not reported (IBNR) included claims incurred before August 31, 2025 but processed after August 31, 2025. Additional IBNR is estimated based on prior claims experience and the expected time period from the date claims are incurred to the date that the related claims are submitted and paid.

Note 3 - Tax Status

The Plan and trust is not pursuing tax exempt status. However, taxable income to the trust is defined in such a way that yields no tax liability for the current year. Accordingly, no tax liability or expense is reflected in the financial statements. The plan is current with all tax filings and is no longer subject to federal income tax examinations by taxing authorities before August 31, 2022.

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, the Plan may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. There were no unrecognized tax benefits identified or recorded as liabilities for the year ended August 31, 2025.

Note 6 - Fidelity Bonding Requirement

ERISA requires every fiduciary of an employee benefit plan and every person who handles funds of the plan to maintain fidelity bond coverage equal to 10% of the amount of plan assets. The trustee (fiduciary) does maintain such a bond.

Note 7 - Fair Value Measurements

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the trust has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other meansIf the asset or liability has a specified (contractual) term, the level 2 must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of financial instruments, including cash, approximate the carrying value, principally because of the short maturity of those items and are considered Level 1 or Level 2.

Note 8 - Cash

The Plan maintains a bank balance at one financial institution located in Central Louisiana. The account is insured by the Federal Deposit Insurance Corporation up to \$250,000. At August 31, 2025, the Plan's uninsured bank balance totals \$184,963.

Note 9 - Administrative Expenses

The plan pays administrative expenses that consist primarily of administrative fees paid to its third-party administrator, IMA, Inc. These expenses encompass professional fees and miscellaneous healthcare fees. The administrative expenses are reported on the statement of changes in benefit obligations and net assets available for benefits.

Note 10 - Related Party Transactions

The plan paid IMA, Inc., its third-party administrator, administrative fees of \$181,327 and \$186,017 for the years ended August 31, 2025 and 2024, respectively. The plan also receives certain administrative services and office usage at no charge from Central Management Company, LLC. These transactions qualify as party-in-interest transactions. However, these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 11 - Risks and Uncertainties

Benefit obligations is reported based on certain assumptions and estimates that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements
