Note 1: Description of Plan

The following description of the Blain Supply and Farm & Fleet Profit Sharing/401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees over the age of 21 of Blain Supply, Inc. and the Farm & Fleet Corporations (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Trustee of the Plan is Matrix Trust Company. The recordkeeper of the Plan is OneAmerica Retirement Services LLC ("OneAmerica").

All employees, whether full-time or part-time, are eligible to make deferral contributions and receive Company safe harbor matching contributions once they have completed one hour of service during the first three months of employment. All employees who have been continuously employed for 12 months, have completed at least 1,000 hours during the Plan year and remain employed on the last day of the Plan year are eligible for Company profit sharing contributions.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Contributions

Participants may contribute up to 50% of eligible pretax or after-tax compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollovers from other qualified plans, which do not count against the Internal Revenue Code ("IRC") maximum contribution per year. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target fund until changed by the participant.

The Company contributes safe harbor matching contributions equal to 100% of the participant's elective deferrals that do not exceed 5% of the participant's compensation. The Company also traditionally makes a profit sharing contribution to the Plan based on a discretionary percentage of the compensation of all eligible employees. This contribution is subject to the approval of the respective boards of directors. A profit sharing contribution of 1% of eligible compensation was made for the 2025 Plan year. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's profit sharing contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are vested immediately in their contributions and Company safe harbor matching contributions plus actual earnings (losses) thereon. Vesting in Company profit sharing contributions is based on years of service. A year of service means any Plan year in which an employee completes more than 1,000 hours of service. Company profit sharing contributions and earnings (losses) thereon vest in accordance with provisions of the Plan as follows:

At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$261,786 and \$341,084, respectively. These accounts may be used to reduce Company contributions. During the Plan year ended June 30, 2025, \$343,275 of nonvested forfeitures were used to reduce the 2024 Company contributions. Forfeited nonvested amounts of \$262,714 will be used to reduce the 2025 Company profit sharing contribution following the Plan year ended June 30, 2025.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance for financial hardships or the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 2.75% to 8.50%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined by the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of the participant's account balance is distributed in the form of a lump-sum payment or installments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account and are included in administrative expenses. All other expenses related to maintaining the Plan are included in administrative expenses.

Subsequent Events

Subsequent to June 30, 2025, the Plan changed its trustee and recordkeeper from Matrix Trust Company and OneAmerica to Voya Financial. The transition of the Plan's accounts previously serviced by OneAmerica to Voya Financial occurred as a result of Voya Financial's acquisition of OneAmerica's retirement plan business. The transfer of the Plan's assets to Voya Financial was completed in December 2025. The custodian change did not result in any changes to participant account balances or Plan benefits.

The Plan has evaluated subsequent events through February 16, 2026, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

Common collective trust fund: An investment in a common collective trust fund is valued using a readily determinable fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on this investment.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company.

Note 5: Party-in-Interest Transactions

The Plan holds investments in funds and accounts managed by the recordkeeper of the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company profit sharing contributions.

Note 7: Tax Status

The Plan adopted a pre-approved plan offered by OneAmerica Financial Partners, Inc. The pre-approved plan received an IRS Opinion Letter dated August 19, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
