# UTICA UNIVERSITY DEFINED CONTRIBUTION RETIREMENT PLAN

## NOTES TO FINANCIAL STATEMENTS

MAY 31, 2025 AND 2024

---

### 1. DESCRIPTION OF PLAN

The following brief description of the Utica University Defined Contribution Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan available to all employees of Utica University (the University) who meet certain eligibility requirements. The Plan is administered by the University. Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) are the insurance companies of the Plan and the recordkeepers of the Plan's assets. TIAA, FSB is a directed custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

#### **Eligibility**

Benefit eligible employees of the University are eligible to begin salary deferrals immediately, unless they are students enrolled and attending classes offered by the University. An employee is enrolled into the Plan upon completion of a properly completed and valid salary deferral agreement.

Employees are eligible to receive employer contributions after reaching age 21 and have an annual work expectation of 1,000 or more hours.

#### **Contributions**

Active participants may make voluntary pre-tax contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 403(b). As of December 1, 2023, the plan was amended to allow active participants to elect to make voluntary post-tax contributions in the form of salary reductions.

Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC. Eligible participants, who have attained 15 years of service before the end of the Plan year, are also eligible to make catch-up contributions, subject to certain limitations of the IRC.

The University makes contributions to the Plan based on date of hire and years of service. All participants hired on or before May 31, 2004 receive contributions from the University equal to 6% of the employee's eligible earnings prior to completing 9 years of service and 8% of the employee's eligible earnings after the completion of 9 years of service.

Contributions from the University were suspended from June 1, 2024 through May 31, 2025 for participants who were not members of the bargaining unit represented by the American Association of University Professors and contributions resumed effective June 1, 2025. Contributions from the University were suspended effective October 1, 2025 for these employees. Additionally, contributions from the University were suspended from January 1, 2025 through June 30, 2025 for participants who were members of the bargaining unit represented by the American Association of University Professors and contributions resumed effective July 1, 2025. Contributions from the University for these employees were suspended effective January 1, 2026.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the University's contribution, and an allocation of Plan earnings/losses on all contributions less administrative expenses. Allocations of Plan earnings/losses and administrative expenses are based on account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### **Transfers**

The Plan does not permit plan-to-plan transfers or contract exchanges with any annuity contract or custodial account that is not a vendor specifically approved by the Plan Administrator for use under the Plan.

### **Vesting**

Participants are immediately vested in their voluntary contributions, the University's contributions, and actual earnings/losses thereon.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's account balance, subject to certain conditions as defined in the Plan agreement. The loan and interest thereon shall be repaid over a period not to exceed five years (except for certain residential loans which can extend for a longer term). The loans are secured by the balance in the participant's account and bear a fixed market rate of interest. A participant is allowed a maximum of three outstanding loans at one time.

### **Payment of Benefits**

Vested funds may be paid to participants when the participant attains age 59½, incurs a disability, or terminates employment with the University. Benefits will be paid directly to the participant or his or her beneficiary, as the case may be, in the form designated by the recipient.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America.

### **Investments**

The Plan invests in pooled separate accounts, registered investment companies, and fixed annuity contracts. Pooled separate accounts, registered investment companies, and non-benefit responsive fixed annuity contracts are reported at fair value. Fully benefit responsive fixed annuity contracts are stated at contract value, as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value**

Accounting Standards Codification (ASC) Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts and registered investment companies are valued using closing quoted prices in active markets.

Non-benefit responsive fixed annuity contracts are valued at accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

There were no changes in the valuation methodologies used during 2025 and 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the financial statements.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by Plan participants. Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earnings on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

During the years ended May 31, 2025 and 2024, investments classified as Level 3 within the fair value hierarchy totaling \$3,208,013 and \$2,448,451 respectively, were purchased and investments totaling \$4,581,760 and \$3,384,740, respectively, were sold.

#### 5. FIXED ANNUITY CONTRACTS

The TIAA Traditional Annuity is a fixed-rate annuity contract. Contributions buy a contractual or guaranteed amount of future benefits for the investing participant. The contracts guarantee principal and a minimum interest rate and provide the opportunity for additional amounts in excess of the guaranteed rate. TIAA maintains Plan contributions in separate accounts.

The Plan utilizes Retirement Annuity (RA) and Retirement Choice (RC) contracts, which totaled \$21,530,855 and \$22,160,561 at May 31, 2025 and 2024, respectively, and are included as the non-benefit responsive fixed annuity contracts on the statements of net assets available for benefits. Under RA contracts, withdrawals and transfers must be spread over a period of 10 annual installments (or five annual installments for withdrawals after termination of employment through election of a five-year fixed-period annuity). Under RC contracts, withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from the account must be paid in 84 monthly installments (7 years).

The Plan also has fully benefit-responsive fixed annuity contracts with TIAA. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a rate of 3%.

The fixed annuity contracts guaranteed minimum returns are supported by the TIAA general account portfolio, which invests primarily in U.S. debt instruments and investment grade corporate bonds; however, is also permitted to invest in higher risk securities, including but not limited to, sub-investment grade corporate bonds, common stock and real estate. The assets and earnings from this portfolio are used to pay the guaranteed interest rate associated with the annuity contracts, as well as future annuity payments.

The Plan Administrator assesses the fair value measurements applied by TIAA, including those for level 3 measurements, on a continuing basis. Periodically, the Plan Administrator, together with TIAA, determines if the current valuation techniques used in the fair value measurements are still appropriate.

## 6. TAX STATUS

The Plan is exempt from federal and state income tax under section 403(b) of the IRC. The Plan is required to operate in conformity with the IRC to maintain its tax-exempt status for Plan participants. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

## 7. PARTY-IN-INTEREST TRANSACTIONS

TIAA and CREF are the insurance companies of the Plan and recordkeepers of the Plan assets. TIAA, FSB, is a directed custodian of certain assets of the Plan. Therefore, transactions between TIAA, CREF, TIAA, FSB, and the Plan qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

## 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the University has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their accounts.

**9. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and IRS Form 5500, *Annual Return/Report of Employee Benefit Plan*. The Plan's net assets available for benefits and its change in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended May 31, 2025 and 2024.

**10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through March 4, 2026, which is the date the financial statements were available to be issued.
