**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the CWM (C. W. Matthews, the Company, or Employer) Employee Benefit Trust (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General

The Plan provides health and other benefits to eligible employees of the Company (regular full-time employees who are scheduled to work at least 30 hours per week and variable hour employees who have met the requirements to be categorized as a full-time employee under a measurement and stability period utilization) and covered dependents after a waiting period of 90 consecutive days as an active employee beginning on the first day of employment in an eligible class.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the Employee Retirement Security Act of 1974, as amended (ERISA).

Benefits

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the assets of the Plan's trust. Under the terms of the contract with the carrier, the insurer has received premium payments and has a legal obligation to make all benefit payments. As such, these insurance contracts are excluded from Plan assets.

Self-insured Benefits

All other Plan benefits are self-insured. The Plan is a plan which contains multiple networks. A point of service (POS) network is similar to a preferred provider organization (PPO) network in that Covered Persons, as defined by the Plan, are not restricted to using the in-network providers. Benefits from the Plan for medical services rendered or for hospitalizations will be higher if the Covered Person uses in-network providers. However, a Covered Person does have the option to choose any physician or provider facility and receive benefits defined by and from the Plan. Benefits for providers who do not participate in the POS or PPO network are generally reimbursable at a lesser benefit payment.

Self-insured Benefits (continued)

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims for self-insured benefits are processed by the Plan's third-party claims processors on behalf of participants and are then reimbursed by the Plan's trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of vision, dental, basic life insurance, supplemental life insurance, and basic accidental death and dismemberment insurance based on the current group rate premium cost. The Company pays the full cost of stop loss insurance.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contribution from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Premiums paid by the Plan's trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits (Continued)

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. Short-term disability payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss Insurance

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$612,649 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits. As of April 30, 2025 and 2024, \$844,208 and \$844,208 in stop loss reimbursement payments were due for claims incurred during fiscal years 2025 and 2024, respectively, and are netted against health claims included on the statement of changes in plan benefit obligations and statements of net assets available for benefits.

Refunds

Refunds due from the Plan's pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$187,955 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended April 30, 2025.

Subsequent Events

Management has evaluated subsequent events for the Plan through March 5, 2026, the date the financial statements were available to be issued.

**NOTE 3 – CLAIMS INCURRED BUT NOT REPORTED**

Plan obligations at April 30, 2025 and 2024 for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

**NOTE 4 – ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

**NOTE 5 – TAX STATUS**

The VEBA trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). Although the Plan has been amended subsequent to the trust receiving notification of its exempt status (January 1985), the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – TERMINATION OF PLAN**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 7 – RISKS AND UNCERTAINTIES**

Plan contributions are made and the estimated liabilities for claims incurred but not reported are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
