**NOTE 1 - DESCRIPTION OF THE PLAN**

General: The following description of the ADP TotalSource, Inc. Health and Welfare Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan’s provisions.

The Plan provides health, disability, and death benefits to worksite employees of ADP TotalSource, Inc. (the “Company” or “Plan sponsor”), a professional employer organization, for whom the Company’s clients have agreed to allow participation. The Plan also offers participants the opportunity to contribute to a flexible spending account (FSA) whereby dollars can be set aside by participants on a pretax basis to cover plan deductibles and other medical expenses not covered under the fully insured group insurance contracts.

The Plan was established on January 1, 1989 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. On January 1, 2007, a Voluntary Employee Beneficiary Association Trust (the “Trust”) was established to hold certain assets of the Plan.

Health, Disability, and Death Benefits: The Plan offers health benefits (medical, hospital, surgical, major medical, vision and dental), disability, and death benefits to regular full-time or part-time worksite employees of ADP TotalSource (and their eligible dependents) residing or working in the United States, scheduled to work an average of 30 hours per week that have satisfied the specified waiting period, as applicable. Current health, disability, and death benefits of active participants and their dependents and beneficiaries are provided under fully insured group insurance contracts with various independent carriers.

Flexible Spending Accounts (FSA): All regular full-time or part-time worksite employees of ADP TotalSource that are eligible for health benefits are eligible to enroll in a health care FSA. Contributions to the FSA are on a pretax payroll deduction basis. The Plan has a carryover feature so that amounts up to \$640 that were unused as of the Plan year end will be carried forward and credited to participants’ accounts to be used for reimbursement in the following year, provided that the participant remains an active worksite employee. Those amounts greater than \$640 are forfeited by the participant and held by the Plan sponsor for the purpose of offsetting future health care FSA plan expenses. The FSAs are non-interest bearing cash on deposit with JPMorgan Chase Bank, N.A. Optum Health Financial Services, Inc. is the primary third party administrator of the FSA account. As of May 31, 2025 and 2024, \$14,132,426 and \$12,211,134, respectively, are reflected as FSA funds in the accompanying statements of net assets available for benefits. Included in the FSA funds as of May 31, 2025 and 2024 are approximately \$1,320,018 and \$2,490,910, respectively, of forfeitures available for future use by the Plan sponsor to cover health care FSA plan expenses.

Contributions and Premium Payments: The Plan sponsor’s policy is to pay, on a monthly basis, the insurance premiums to the carriers. The level of contribution that each Participant is responsible for is determined by each of the Plan sponsor’s co-employers. The Plan sponsor makes contributions to the Plan on a monthly basis to cover the premium payments in excess of the participants’ contributions. Participants are allowed to contribute a maximum of \$3,200 and \$3,050 for the Plan years ended May 31, 2025 and 2024, respectively, to their health care FSA.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Premium Payments to Insurance Carriers: Premiums paid by the Plan sponsor are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

FSA Reimbursements: FSA reimbursements to participants for eligible expenses are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Administrative Expenses: The Plan sponsor absorbs some of the administrative costs of the Plan. However, certain costs incurred in the administration of the Plan that are paid by the Plan sponsor may be reimbursed by the Plan. As of May 31, 2025 and 2024, there was \$1,320,018 and \$2,490,910 pending reimbursement to the Plan sponsor. Administrative expenses incurred in administration of the FSAs were paid by the Plan sponsor for the year ended May 31, 2025.

Insurance Carrier Rebates: Under a provision of the Patient Protection and Affordable Care Act (PPACA), enacted on March 23, 2010, health insurance carriers are required to provide rebates to policyholders when their spending of premiums collected is less than the newly established medical loss ratio (MLR). For large groups, as defined, a rebate is required if the incurred claims and expenses used by the insurance carrier to improve health care quality is less than 85% of the earned premiums minus federal and state taxes, and other various adjustments. The provision became effective January 1, 2011.

The portion of the rebate that is attributable to participant contributions, as determined under an allocation method chosen by the Plan sponsor as a reasonable, fair and objective allocation method under ERISA, is considered a Plan asset. For the insurance policy years ended December 31, 2025 and 2024, the Plan's portion of premium rebates received approximated \$1,839,290 and \$3,076,971, respectively. The amounts related to the insurance policy years are received after the Plan's year end and have been recorded as an insurance rebates receivable and reduction of premium expenses and as a corresponding rebates payable to participants and reduction of participant contributions.

No premium rebates applicable to the PPACA for the period from January 1, 2025 to May 31, 2025 have been recorded by the Plan as of May 31, 2025, as the amount to be received, if any, is not reasonably determinable.

**NOTE 3 - TAX STATUS**

The Trust established under the Plan to hold the Plan's assets is intended to qualify as a tax-exempt entity pursuant to Section 501(c)(9) of the Internal Revenue Code ("IRC"). The Trust has obtained an exemption letter dated May 28, 2008, and effective January 1, 2007, from the Internal Revenue Service. The Plan sponsor believes that the Trust continues to qualify and operate in accordance with the applicable requirements of the IRC. Any unrelated business income generated by the Trust is subject to tax under the IRC.

**NOTE 3 - TAX STATUS** (Continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. In February 2021, the Plan received notice from the U.S. Department of Labor (DOL) that the Plan was being reviewed for compliance with certain provisions of ERISA. The plan administrator received a DOL closing letter on September 17, 2024 with no findings. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan sponsor has the right under the Plan to modify the benefits provided to participants, discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

**NOTE 5 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Some administrative expenses of the Plan are paid directly by the Company and may be reimbursable from Plan assets. The Plan paid \$12,997,661 to the Plan Sponsor during 2025 for costs associated with the administration of the Plan. The Plan pays fees to parties-in-interest for FSA administrative costs, legal and audit services. The payments are covered by statutory or administrative exemptions in IRC and ERISA's rules on prohibited transactions.

**NOTE 6 - SUBSEQUENT EVENT**

Plan management has evaluated subsequent events for recognition and disclosure through March 10, 2026, which is the date the financial statements were available to be issued.
