

For Participants who are projected to have earned less than twenty-five (25) Years of Credited Service as of the end of the Plan Year in which they attain Normal Retirement Age, the percentage above shall be reduced by one-twenty fifth for each such Year of Credited Service less than twenty-five (25).

Years of Credited Service for benefit accrual purposes equal years of participation service with 500 hours of service. Years of Service for vesting purposes equal years of service from hire with 1000 hours of service.

However, the maximum monthly benefit shall not exceed \$30,000.

**Vesting**

100% vested upon completion of 6 years of vesting service. Years of service prior to the initial effective date of the plan are included.

**Other Benefits:**

Early retirement: The plan does not provide for an early retirement benefit.

Death before retirement: Present value of a participant's accrued benefit.

Disability before retirement: No separate benefit provided; treated the same as termination of employment.

Termination of employment before retirement: Present value of a participant's vested accrued benefit.

**Plan Amendments**

Effective July 1, 2025, the Plan was amended to (1) increase the cap on the monthly retirement benefit from \$22,000 to \$30,000, and (2) change the mortality table in the definition of actuarial equivalence from Rev. Rul. 2001-62 to the 417(e) Applicable Table.
