## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

## Notes to Financial Statements

June 30, 2025 and 2024

---

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Section 403(b) Retirement Plan for Optimus Health Care, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a contributory defined contribution retirement plan established under Internal Revenue Code (the “Code”) Section 403(b) covering all eligible employees of Optimus Health Care, Inc. (the “Employer”). Employees are eligible to make salary deferral contributions to the Plan immediately following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Employer’s Board of Directors is responsible for the oversight of the Plan.

Contributions - Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, up to the limits prescribed by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions up to the limits prescribed by the IRS. The Plan allows participating employees to designate all or a portion of their deferrals as Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a fixed annuity contract as investment options for participants.

The Plan also contains a provision for the Employer, each year, to make a discretionary Employer contribution in an amount to be determined by its Board of Directors. In order to receive discretionary Employer contributions, eligible participants are required to have completed two years of service (with a minimum of 1,000 hours). For the year ended June 30, 2025, the Employer elected to make a discretionary Employer contribution equal to 4% of a participant’s eligible compensation, as defined by the Plan. Participants also direct the investment of the Employer’s contributions. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, and the Employer’s discretionary contributions, as well as an allocation of Plan earnings. Allocations are based on the participant earnings, account balances or specific participant transactions, as defined by the Plan the benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are vested immediately in their salary deferral contributions, Employer discretionary contributions, and rollover contributions, plus actual earnings thereon.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant’s account. The loan interest rate, determined annually by Empower Trust Company, LLC (“Empower”), is set at a rate commensurate with local prevailing rates. Principal and interest payments are made directly by participants to Empower.

Payment of Benefits - On termination of service for any reason, participants with a vested account balance less than \$5,000 will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date. Participants may also request distributions in the form of installment payments for a specified period under the terms of the Plan.

## NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Withdrawals - Withdrawals from a participant's vested account may also be made in the event of a financial hardship, in accordance with the provisions specified by the Plan. In-service withdrawals from a participant's salary deferral portion of their account may also be made for participants who have reached aged 59 ½ or are disabled, or for childbirth and adoption expenses. A participant may not receive an in-service distribution in any amount which is less than \$500. Participants may also withdraw their rollover contributions at any time prior to termination.

Forfeited Accounts - When a participant is terminated, nonvested Employer contributions are forfeited by the participant. Forfeited nonvested Employer contributions may either be used to pay Plan expenses, reduce future Employer contributions or reallocated to participant account balances. Forfeited nonvested Employer contributions as of June 30, 2025 and 2024 were \$293 and \$264, respectively. During the year ended June 30, 2025, forfeitures of \$-0-, were used to reduce Employer contributions.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Plan Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of the Plan are included in administrative expenses. Any fees related to notes receivable from participants are charged directly to the participant's account and are also included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

Use of Estimates - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Subsequent Events - The Plan has evaluated subsequent events through March 4, 2026, the date the financial statements were available to be issued.

### **NOTE 3 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at June 30, 2025 and 2024.

*Level 1 Fair Value Measurements* - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds totaling \$21,751,040 and \$18,936,535 at June 30, 2025 and 2024, respectively, are considered Level 1 within the fair value hierarchy.

### **NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has entered into a group annuity contract with Empower, the General Account, with a balance of \$6,299,899 and \$6,232,141 at June 30, 2025 and 2024, respectively. The contract is a traditional investment contract. Under the contract, the participant principal and interest are fully guaranteed by the general account assets of Empower. The investment strategy employed seeks to achieve consistent returns to support a competitive credited rate. Bonds invested in the general account segment have an average maturity between three and seven years; are investment-grade in quality; and are diversified across a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgages, private equity, etc.

This contract meets the fully-benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully-benefit responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. Each quarter an interest rate is established for new deposits received in that quarter and that interest rate is guaranteed for the remainder of the current calendar year. A renewal interest rate is then established each subsequent calendar year and is guaranteed for one calendar year. The contract does not have a maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include but are not limited to the Plan’s failure to qualify under Section 401(a) of the Code or failure of the trust to be tax-exempt under section 501(a) of the Code; premature termination of the contract; Plan terminations or merger; changes to the Plan’s prohibition or competing investment options; and bankruptcy of the Company or other events of the Company, such as divestitures, that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer as that would limit the ability of the Plan to transact at contract value with the participants.

#### **NOTE 5 - TAX STATUS**

The IRS has informed the volume submitter plan sponsor, by an opinion letter dated April 7, 2021, that the Plan is designed to constitute as a qualified tax-exempt plan under Section 403(b) of the Code. As such, the Plan is exempt from federal income tax, and amounts contributed by the Employer will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The Employer believes that the Plan is operating in accordance with the applicable sections of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax years in progress.

#### **NOTE 6 - CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, the Custodian of the Plan.

#### **NOTE 7 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include a variety of mutual funds and a fixed annuity contract managed by Empower. Empower is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. The Plan allows for notes receivable from participants, which are also considered party-in-interest transactions.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options, in any combination, of specified registered investment companies and funds. The underlying investments held by the registered investment companies may include stocks, bonds, fixed income securities, and other investment securities. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near-term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.
