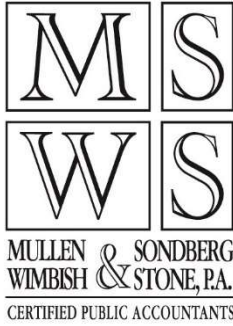

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arc Carroll County 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Arc Carroll County 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to *29 CFR 2520.103-8* of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Note 1 - Description of Plan

The following description of The Arc Carroll County 403(b) Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Arc Carroll County 403(b) Plan (the Plan), was established January 1, 1995 and restated thereafter. The Plan is a 403(b) defined contribution plan. Under the provisions of the Plan, an employee is eligible for participation in the Plan upon date of hire. Elective deferrals may begin on date of hire and the employee is eligible for the employer match and discretionary contributions after completing one year of service and achieving 1,000 hours of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan includes an automatic contribution arrangement whereby all employees who became participants on or after July 1, 2019 shall be deemed to have directed the Employer to make salary reduction contributions on their behalf on 1% of compensation. Participants may elect to defer any portion of their compensation into the Plan up to the annual Internal Revenue Code limits as adjusted each year. Participants may also elect to opt-out of participation in the Plan. The Arc of Carroll County, Inc. (the Employer) contributes a matching contribution of up to 5% of the participant's compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total contributions made by the Employer for the years ended June 30, 2025 and 2024 amounted to \$194,115 and \$168,084, respectively.

Participant Accounts

Each participant's account is credited with (a) the participant's salary deferrals, (b) the employer's match of salary deferrals, (c) an allocation of Plan earnings, and (d) an allocation of administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into the various investment options offered by the Plan.

Vesting

Participants are immediately fully vested in their elective contributions plus actual earnings thereon. Participants are also fully vested immediately in the employer matching and discretionary contributions.

Note 1 - Description of Plan (Cont.)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum distribution amount equal to the value of the participant's vested interest in his or her account, or annual installments that do not exceed the life expectancy of the participant or beneficiary. Eligible distributions may also be rolled over to another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Notes Receivable from Participants

The Plan allows loans of up to 50% of vested account balance or \$50,000, whichever is less. The minimum loan amount is \$1,000. Interest rates are to be determined at the time of the loan and the loan is to be repaid within a 5 year period. These loans are secured by the vested portion of the participants account and bear interest at 5.85% to 8.50% and 4.60% to 5.85%, for the years ended June 30, 2025 and 2024, respectively. Repayment of loans is provided through automatic payroll deduction.

Forfeitures

All employer and employee contributions are fully vested immediately. Therefore, there were no forfeitures.

Administrative Expenses

The administrative expenses related to the Plan's Custodian are paid by the Plan. The Organization pays all other administrative expenses of the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Accounting Policies (Cont.)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. The outstanding notes receivable balance due from participants as of June 30, 2025 and 2024 was \$101,977 and \$120,052, respectively. The plan administrator has determined all notes receivable are fully collectible from the participants' vested account balances; consequently, no amount has been recorded as an allowance for credit loss.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the guaranteed investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note 3 for explanation of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants for the years ended June 30, 2025 and 2024 amounted to \$547,712 and \$1,806,103, respectively.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS or plan document are recorded as a liability with a corresponding reduction to contributions.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. The Employer matching contributions and the Employer discretionary contributions are recorded in the year in which the Employer designated the contributions. All participant and employer contributions are participant-directed. Management of the Plan evaluates employer contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. The plan administrator has determined that all participant and employer contributions receivable are fully collectible; consequently, no amount has been recorded as an allowance for doubtful accounts in the accompanying statements of net assets available for benefits.

At June 30, 2025 and 2024, the balance in employer matching receivables was \$-0- and \$6,487, respectively, and the balance in employee receivables was \$-0- and \$15,857, respectively.

Note 3 - Fair Value Measurements

Certain Plan investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 - Fair Value Measurements (Cont.)

ASC 820-10 "Fair Value Measurements" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Note 3 - Fair Value Measurements (Cont.)

Following is a description of the valuation methodologies used for assets measured at fair value as of June 30, 2025 and 2024:

Pooled separate accounts: Valued at the net asset value of the pooled separate accounts, as reported by the Custodian and calculated in a manner consistent with Generally Accepted Accounting Principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by variable annuity contracts. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy. The total fair value of the Plan's pooled separate accounts as of June 30, 2025 and 2024 was \$6,174,206 and \$5,016,706, respectively.

Note 4 - Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Mutual of America Life Insurance Company. Mutual of America Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Mutual of America Life Insurance Company.

The guaranteed investment contract is fully benefit-responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Mutual of America Life Insurance Company, which approximates fair value, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value.

Note 4 - Investment Contract with Insurance Company (Cont.)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at June 30, 2025 and 2024 was \$-0- and \$366,773, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Under the terms of the contract, the guaranteed minimum rate is 1.00%.

The value shown, is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value of a withdrawal request.

Note 5 - Information Prepared and Certified by Custodian

Investment Data

Mutual of America Life Insurance Company was the Custodian of the Plan for the years ended June 30, 2025 and 2024. Principal Trust Company was the Custodian of the Plan for the year ended June 30, 2025. All data contained in the statements of net assets available for benefits, statement of changes in net assets available for benefits, and the Schedule H, Line 4i – Schedule of assets (held at end of year) as of June 30, 2025 was summarized from information supplied and certified as complete and accurate by the Custodians of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, Line 4i – Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of June 30, 2025.

Note 6 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the beginning of the year. During the Plan years ended June 30, 2025 and 2024, there were no reportable transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net value of each participant's account would be distributed in accordance with the Plan's provisions.

Note 8 - Tax Status

The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Note 8 - Tax Status (Cont.)

Effective April 1, 2025, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on November 29, 2024 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letters have been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - Party-In-Interest Transactions

In the beginning of the year Mutual of America Life Insurance Company was the Custodian of the Plan. In April 2025, Principal Trust Company became the Plan Custodian and administrator. Transactions with these entities qualify as party-in-interest transactions. For the years ended June 30, 2025 and 2024, fees paid by the Plan for the investment management services amounted to \$14,120 and \$1,875, respectively.

The Plan's auditor who audits the Plan's financial statements and third-party administrator who provides accounting and administrative services are paid directly by the plan sponsor. These fees are not reflected in these financial statements.

Note 11 - Subsequent Events

Subsequent events and transactions have been evaluated for potential recognition in the financial statements. There have been no subsequent events that require recognition or disclosure through February 11, 2026, the day the financial statements were available to be issued.
