## NOTES TO FINANCIAL STATEMENTS

### Note 1 - Description of Plan

The following description of the International Brotherhood of Electrical Workers, Local Union #81 - Annuity Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

International Brotherhood of Electrical Workers Local Union #81 - Annuity Fund, operating from offices in Scranton, Pennsylvania, provides retirement, death, disability and termination benefits to its eligible members.

The Plan is a defined contribution plan covering all members who work for a participating employer of the Union. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan participates in a Master Service Agreement with Empower Annuity Insurance Company (Empower). Empower serves as Trustee for the Plan, and also serves as an agent to the Plan Administrator, Fabian & Byrn, LLC.

The Plan is under the control of the Board of Trustees comprised of union members and employers and is administered by the firm of Fabian & Byrn, LLC. The duties of the administrator are to receive all payments from participating contractors and make subsequent disbursements to the trust fund and payment of other operating expenses.

#### Contributions

Each month, the participating employer is required to contribute an amount to the Plan, which is based on the number of hours worked by each employee multiplied by the applicable rates. The applicable rates for the Plan years ended May 31, 2025 and 2024 were \$8.45 and \$8.35, respectively.

#### Participant Accounts

Each participant's account is credited with the employer's contribution and an allocation of the Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on account balances within each of the participant-directed funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Vesting

Participants are immediately vested in employer contributions plus actual earnings thereon.

## Note 1 - Description of Plan - (Continued)

### Investment Options

Upon enrollment in the Plan, a participant must direct the amount in the participant's account to selected investments as made available and determined by the Plan Administrator.

Participants may change their investment options daily.

### Payment of Benefits

Upon retirement, disability, or termination, the participant may apply for distribution in the form of an annuity purchased from the insurance company under contract provisions, a lump sum payment in the amount of the participant's account value, a monthly payment amount as specified by the participant, or a combination lump sum amount and monthly payments. Payments under these options will be paid until the value of the account at the time of application for payment, plus earnings, has been exhausted.

## Note 2 - Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 - Summary of Significant Accounting Policies - (Continued)

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through March 12, 2026, the date the financial statements were available to be issued.

## Note 6 - Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## Note 6 - Fair Value Measurements - (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at net asset value (NAV) as determined by the issuer. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Note 7 - Contract with Insurance Company

The Plan has a Guaranteed Interest Account with Empower. Empower maintains the Plan's deposits in an allocated fund, to which it adds interest at the net interest crediting rate, which was 2.75% at May 31, 2025. Deposits into this contract are guaranteed the contract minimum rate of return. Withdrawals are permitted at any time without penalty.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting.

Generally there are not any events that could limit the ability of the Plan to transact at Contract Value paid within 90 days or in rare circumstances, Contract Value paid over time. There are not any events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than Contract Value paid either within 90 days or over time.

The guaranteed investment contract is a traditional investment contract and does not have a scheduled maturity date.

## Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the net assets will be distributed among the participants. Each participant will receive a lump-sum payment equal to the amount credited in their account.

#### Note 9 - Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Empower. Empower is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to an Administrative Services Agreement (Agreement) between the Plan and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the Agreement, Empower remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended May 31, 2025, the excess amounts of \$40,337 are recorded net with investment expenses. The Plan may make a payment to Empower for administrative expenses not covered by revenue sharing.

#### Note 10 - Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated May 7, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2022.

#### Note 11 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Cash consists of monies held in noninterest bearing accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000.
