## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Garrison Management Group, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Garrison Management Group, LLC and participating employers (the Company). All employees of the Company, excluding nonresident aliens and residents of Puerto Rico, those covered by collective bargaining agreements, and part-time, seasonal, and temporary employees, are eligible to participate in the Plan provided they have 6 months of service and have attained age 18. Employees may enter the Plan on the first day of each month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Paychex, Inc. provided recordkeeping services to the Plan and Mid Atlantic Trust Company provided custodian services through December 17, 2023. Since that date, Fidelity Workplace Services LLC provides recordkeeping services to the Plan, and Fidelity Management Trust Company (FMTC) is the custodian for the Plan and serves as trustee. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective December 18, 2023, the plan document was restated in its entirety due to the change in service providers described above. With this change, effective January 1, 2024, part-time, seasonal, and temporary employees were added as an excluded class of employees, and the eligible age requirement decreased from 21 to 18.

The following companies are participating employers:

- Row Management Group Inc.
- Strategy Insights LLC
- WPAI Holdings LLC

**Contributions**

Participants may contribute up to 92% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). In addition, participants are permitted to transfer the vested portion of their accounts to an in-plan Roth transfer account subject to the Plan's provisions.

The Plan provides a safe harbor matching contribution equal to 100% of employee deferrals up to 4% of eligible compensation.

**Contributions (Continued)**

The Company may also make discretionary additional matching contributions or profit sharing contributions as determined annually by the Board of Directors. Profit sharing contributions are allocated to each participant based upon a formula determined by the Company as each participant is in his or her own allocation group. Participants must be employed on the last day of the Plan year in order to receive a profit sharing contribution. There were no additional matching contributions or profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, Company matching contributions, allocation of the Company's profit-sharing contribution, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Loans**

Participants are not permitted to borrow from their accounts.

**Vesting**

Participants are vested immediately in their contributions and Company matching contributions, plus earnings thereon. Vesting in the Company's discretionary profit sharing contribution is based on years of service. After two years of service, a participant becomes 20% vested in the Plan; the vesting increases by 20% each year. A participant is 100% vested after six years of credited services. A participant is 100% vested in all contributions upon reaching plan retirement age of sixty-five, death, or disability.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from all vested accounts, must be a minimum of \$500, and are subject to specific statutory and regulatory requirements.

**Payment of Benefits (Continued)**

In-service distributions are permitted from all vested accounts when a participant has attained age 59½. Distributions from rollover accounts are permitted at any time.

**Forfeitures**

Forfeited nonvested accounts relate to participants terminated who were not fully vested in the Plan. Forfeitures may be used to reduce Company contributions. For the year ended December 31, 2024, \$33,441 of forfeitures were used to reduce Company contributions. There were no unallocated forfeitures at December 31, 2024 or 2023.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions and Contributions Receivable**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of administration fees. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through February 19, 2026, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024, and net appreciation in fair value of investments, dividends, and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all Company contributions.

**NOTE 6 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer’s plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by FMTC. Mercado Asset Company is the investment advisor of the Plan. Total fees paid from the Plan to these entities for the year ended December 31, 2024 were \$26,999. These transactions qualify as party-in-interest transactions.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 — DELINQUENT CONTRIBUTIONS**

During the year ended December 31, 2024, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$499,109 within the period prescribed by the Department of Labor's regulations. The Company intends to correct these prohibited transactions by restoring the affected participants' accounts for potential lost income due to the delayed remittances.

During the year ended December 31, 2023, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$81,902 within the period prescribed by the Department of Labor's regulations. The Company corrected part of this prohibited transaction in the amount of \$38,088 by making contributions in 2024 in the amount of \$1,841 to the affected participants' accounts for lost income due to the delays. The Company intends to correct the remaining prohibited transactions in the amount of \$43,814 by restoring the affected participants' accounts for potential lost income due to the delayed remittances.

**NOTE 10 — SUBSEQUENT EVENTS**

The Plan was amended effective September 29, 2025, to add Chester White LLC, as a participating employer.
