NOTE A - PLAN DESCRIPTION

The following description of the Badger Plug Company Retirement and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Badger Plug Company (the Company). Employees are eligible to participate on the first of the month following completion of one month of service and are automatically enrolled at 4% unless another election is made. The Plan also provides for auto escalation whereby participant deferrals are increased 1% annually up to 10%, unless another election is made.

For purposes of receiving employer contributions, employees are eligible on the first day of the Plan quarter following completion of one year of service. In order to be eligible to receive employer contributions to the Plan, Plan participants must be employed by the Company on the last day of the Plan year and have completed at least 1,000 hours of service in the Plan year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is qualified under Internal Revenue Code (IRC) Section 401(a), which permits an employee to contribute to the Plan with pre-tax and/or after-tax dollars.

OneAmerica Retirement Services (OneAmerica) is the recordkeeper. Matrix Trust Company (Matrix) serves as the Plan's trustee and custodian.

Contributions

Participants may contribute up to 75% of their compensation, not to exceed the limits of the IRC. The Company will match 50% of 401(k) contributions up to the first 4% of each employee's contributions.

The Plan includes an annual safe harbor profit-sharing contribution of 3% of eligible employee compensation. Employees may receive safe harbor profit-sharing contributions regardless of their hours of service during the Plan year. The Company may also make additional discretionary profit-sharing contributions to the Plan at the option of the Company's board of directors. The discretionary profit-sharing contributions for the years ended September 30, 2025 and 2024 were 2% of eligible employees' eligible wages.

Matching contributions amounted to \$202,187 and \$200,923 for the years ended September 30, 2025 and 2024, respectively. Total safe harbor and discretionary profit-sharing contributions amounted to \$616,021 and \$594,915 for the years ended September 30, 2025 and 2024, respectively.

Participants' Accounts

Each participant's account is credited with the participant's contribution, Company match and profit-sharing contributions, and allocations of Plan appreciation and forfeitures. Participants' accounts are also charged with an allocation of administrative expenses. The allocations are based on participants' earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon enrollment in the Plan, a participant may direct investments consisting of their employee contributions and employer contributions plus actual earnings thereon in 1% increments in any of the investment options offered by the Plan. Participants may change their investment options daily.

Vesting

Participants' contributions are 100% vested at all times. The Company's matching and discretionary profit-sharing contributions vest at 10% for the first two years and increase by 20% per year thereafter until 100% is reached at year six. The Company's safe harbor profit-sharing contributions vest after two years.

Payment of Benefits

On termination of service due to death or disability, the participant or beneficiary is entitled to receive as benefits the entire amount credited to their account as of that date. Upon a participant's termination from employment with the Company for a reason other than death or disability, the participant is entitled to the vested balance in their account.

The method of distribution is determined by an election made by the participant. The methods available are lump sum, installment payments (annual, quarterly or monthly) or direct transfer to another eligible plan. Participants experiencing financial hardship may withdraw from their participant-contribution balance, as defined by the Plan.

Forfeitures

Forfeited non-vested accounts are used to pay Plan expenses or employer contributions. Forfeitures of \$21,698 and \$57,129 were used to pay Plan expenses or employer contributions in 2025 and 2024, respectively. Unallocated forfeitures at September 30, 2025 and 2024 were \$29,061 and \$5,057, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain Plan administrative expenses are paid by the Plan and are expensed when incurred.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE C - FAIR VALUE MEASUREMENTS

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2025 and 2024.

Collective trust fund - Valued based on information reported by the investment advisor using the audited financial statements and net asset value (NAV) of the collective trust fund at year end.

Mutual funds - Valued at the NAV of shares held by the Plan at year end, as determined by reference to quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - TAX STATUS

The Plan was amended and restated July 1, 2022, using the OneAmerica Financial Partners, Inc. defined contribution pre-approved plan. The pre-approved plan obtained its latest opinion letter on August 19, 2020 in which the Internal Revenue Service (IRS) stated the pre-approved plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F - RELATED-PARTY TRANSACTIONS

Certain administrative costs of the Plan are paid by the Company.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by OneAmerica, the recordkeeper as defined by the Plan and, therefore, transactions with the recordkeeper qualify as party-in-interest transactions.

NOTE H - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix, the trustee of the Plan, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of September 30, 2025 and 2024.
- Investment income, as shown in the statements of changes in net assets available for benefits for the years ended September 30, 2025 and 2024.
- Schedule H, line 4i - schedule of assets (held at end of year), September 30, 2025.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE I - SUBSEQUENT EVENTS

The Plan Administrator evaluated the Plan's September 30, 2025 financial statements for subsequent events through March 10, 2026, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the Plan's financial statements, except as described below.

In early 2025, OneAmerica was acquired by Voya Financial. OneAmerica continued to provide information and services to Voya Financial through a transition services agreement. The Plan was transitioned to Voya Financial's recordkeeping platform in October 2025.
