Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Northwest Florida Christian Education Association, Inc. 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2025 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of and for the year ended June 30, 2025, stating that the certified investments information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying 2025 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- The information in the accompanying 2025 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Northwest Florida Christian Education Association, Inc. 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1—Description of the Plan

The following brief description of the Northwest Florida Christian Education Association, Inc. 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution plan established by Northwest Florida Christian Education Association, Inc. (NFCEA) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the requirements of Section 403(b) of the Internal Revenue Code. NFCEA is a sponsor and administrator of the Plan. Ascensus Trust, Inc. (Ascensus) serves as the Plan custodian and provides recordkeeping services for the Plan and Merrill Lynch, Pierce, Fenner and Smith, Inc. (Merrill Lynch) serves as the investment advisor for Plan participants.

Administration—The Plan is administered by NFCEA, which serves without compensation. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions—Each year, participants may contribute up to 100% of pretax annual compensation (salary reduction contributions), as defined in the Plan up to the maximum percentage allowable under the provisions of the Internal Revenue Code (for years ending June 30, 2025, and 2024, that maximum was \$23,000 and \$22,500, respectively). Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). NFCEA has discretion within the Plan to match employee contributions on an annual basis. For the years ended June 30, 2025, and 2024, the Plan matched employee contributions up to 4% and 3%, respectively, of employee compensation.

Catch-Up Contributions for Employees Aged 50 or Older—For the years ended June 30, 2025, and 2024, if a participant is eligible to make salary deferral contributions and reaches age 50 before the end of the calendar year, the participant may defer an additional \$7,500 and \$7,500, respectively, into the Plan as a pre-tax contribution subject to certain IRC limitations. Catch-up contributions are not eligible for matching contributions made by NFCEA.

Catch-Up Contributions for Employees with 15 Years of Service—For the years ended June 30, 2025 and 2024, if a participant is eligible to make salary deferral contributions and has at least 15 years of service with an educational organization, hospital, home health service agency, health and welfare service agency, church, or convention or association of churches, the limit on elective salary deferral contributions to the 403(b) account is increased by the lesser of \$3,000 or one of the following two options:

- \$15,000, reduced by the sum of the additional pre-tax elective salary deferral contributions made in prior years because of this rule, plus the aggregate amount of designated Roth contributions permitted for prior years because of this rule.
- \$5,000 times the number of years of service for the organization, minus the total elective contributions made by the employer on the participant’s behalf for earlier years.

Eligibility—Employees are eligible to participate in the salary deferral portion of the Plan upon hire. To participate in the employer contribution portion of the Plan, employees must have completed at least one (1) year of service with NFCEA, including 1,000 hours of service as defined in the Plan, and be at least 21 years old. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options offered by the Plan.

Investment Options—Upon enrollment in the Plan, participants may direct their allocation of basic and matching contributions with Merrill Lynch, Pierce, Fenner & Smith, Inc. Participants may select between several investment options as more fully described in the Plan’s literature. Participants may change their investment options at any time.

Participant Accounts—Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s contributions, related NFCEA matching contributions, and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The participant’s vested account balance determines the benefit amount to which they are entitled to.

Vesting Requirements—Participants are immediately fully vested in their voluntary contributions, including catch-up contributions, rollover contributions from other plans, and earnings thereon under the 403(b) option of the Plan. Matching contributions provided by NFCEA are subject to a vesting period and participants must provide at least 2 years of service for entitlement. Participants must be employed as of the last day of the year for that year’s matching contributions to vest. Employer contributions and nonelective contributions plus or minus actual earnings or losses thereon vest according to the following schedule:

Plan Loans—The Plan does not allow for participant loans.

Benefits Paid to Participants—Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount, equal to the value of the participant’s vested interest in his or her account, or an annuity. For termination of service for other reasons, distribution of the value of the participant’s vested interest in his or her account will begin as soon as possible after the participant’s request.

Forfeitures—Forfeited non-vested employer contributions totaled \$2,822 and \$3,616 for the years ending June 30, 2025, and 2024, respectively. These forfeited amounts were used to fund administrative expenses. The balance in the forfeiture accounts was \$176 and \$8,156 for the years ending June 30, 2025, and 2024, respectively.

Termination of Plan—Although it has not expressed any intent to do so, the NFCEA has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Administrative Expenses— Plan administrative expenses, such as legal fees and administrative costs, have generally been paid from the assets of the Plan to the extent permitted by the participant’s individual agreements. These expenses may be allocated to all plan participants, or for expenses specific to the participant’s investment selections, charged against that participant’s account balance. NFCEA may, at its discretion, pay a portion or all of these expenses. Administrative expenses of the Plan totaled \$24,220 and \$20,286 for the years ending June 30, 2025, and 2024, respectively. NFCEA paid \$10,000 and \$9,000 in administrative expenses on behalf of the Plan for the years ending June 30, 2025, and 2024, respectively. Amounts paid by NFCEA are not included in these financial statements.

Plan Restatement – The Plan was restated as of August 1, 2019, to be compliant with the *Pension Protection Act of 2006* which requires all employers who have adopted a pre-approved retirement plan to restate their plans once every six years to reflect changes in the Internal Revenue Code and IRS regulations. There were no significant changes to the eligibility requirements or benefits of the Plan.

Note 2—Summary of significant accounting policies

Basis of Accounting—The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investments, Investment Valuation, and Income Recognition—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Three levels of inputs that may be used to measure fair value:

- Level 1- Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
- Level 2- Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date; and
- Level 3- Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual and money market funds—These investments are public investment vehicles values using the Net Asset Value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Self-directed brokerage accounts—These Merrill Lynch investments allow participants to direct purchases and sales within their account. This holds participants responsible for controlling their investments. Investment options are generally limited to items in actively traded markets with readily determinable values. Self-directed brokerage accounts are classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

There have been no changes in the methodologies used for assets measured at fair value for the years ended June 30, 2025, and 2024.

Risks and uncertainties—Investment securities, in general, are subject to various risks, such as interest rate, credit and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Benefits Paid to Participants—Benefits paid to participants are recorded when paid.

Expenses—Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Administrative expenses paid by the Plan may include distribution fees charged to participants' accounts and administrative Plan fees. Investment-related expenses are included in net appreciation in fair value of investments.

Note 3— Investments (unaudited)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by the custodian of the Plan (Ascensus), except for comparing such information to the information included in the Plan's financial statements and supplemental schedule as of June 30, 2025, and 2024, and for the years ended June 30, 2025, and 2024.

- Investments as shown in the Statements of Net Assets Available for Benefits as of June 30, 2025, and 2024.

Note 5 – Information Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting Disclosure under ERISA. Accordingly, Ascensus LLC and Ascensus Trust Company, the custodians of the investments of the Plan, have certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statement of net assets available for benefits as of June 30, 2025, and 2024.
- Net appreciation in fair value of investments, dividends and interest as reflected on the accompanying statements of changes in net assets available for benefits for the years ended June 30, 2025, and 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 6—Related Party and Party-in-Interest Transactions

Northwest Florida Christian Education Association, Inc. (NFCEA) is the Plan sponsor and only employer that contributes to the Plan and is therefore a related party and party-in-interest. Contributions from NFCEA, as the sole employer contributing to the Plan, totaled \$133,474 and \$95,980 for the years ended June 30, 2025, and 2024, respectively.

The Plan’s investments are managed by Merrill Lynch, the investment advisor company of the plan, and therefore, the transactions qualify as party in interest transactions. Fees paid to Merrill Lynch for the years ended June 30, 2025, and 2024 totaled \$10,995 and \$8,411, respectively.

Ascensus serves as the Plan custodian. Fees incurred by the Plan for the custodial services are paid directly by the Plan and through non-vested forfeited match contributions of those participants not employed at year end. Fees paid to Ascensus for the year ended June 30, 2025, and 2024 totaled \$14,235 and \$12,676, respectively.

Note 7—Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The plan administrator believes the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and therefore believes the Plan is qualified and the related custodial accounts are tax-exempt.

The Plan previously obtained a private letter ruling, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the private letter ruling. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and currently being operated in compliance with

the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8— Plan Termination

NFCEA believes that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. Distribution of participant account balances will occur as soon as administratively feasible upon termination of the Plan.
