Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TOC-Woodworkers, IAM Defined Contribution Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The TOC-Woodworkers, IAM Defined Contribution Plan and Trust (the “Plan”) is a defined contribution multiemployer plan with a §401(k) feature covering all eligible employees under the collective bargaining agreement or special agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN DOCUMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are recorded on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Participants may also contribute to the Plan through tax-deferred salary deductions of eligible compensation, as defined in the Plan, up to the statutory maximum as determined by the Internal Revenue Code. Rollover and catch-up contributions are permitted. Contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts. Participants are immediately 100% vested.

D. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Such investments are not required to be categorized within the fair value hierarchy. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Mutual fund capital gains distributions are included in the dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

E. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risk. Due to the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the various risk factors, could materially affect participants' account balances and the amounts reported in the financial statements.

F. Tax-Exempt Status

No provision for federal income tax is made. The Plan received its most recent favorable Internal Revenue Service determination letter dated January 6, 2017. The Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Forfeitures

There were no forfeitures during the years ended May 31, 2025 and 2024.

NOTE 3 - FUNDING POLICY

The Board of Trustees has established a funding policy and method in order to promote the purpose of the Plan and to ensure compliance with ERISA. Each employer contributes to the Plan such amounts and at such times as are required by the applicable provisions of the collective bargaining agreement, or such other agreements as are approved by the Board of Trustees. Employer contributions are based on hourly contribution rates and are made on a monthly basis.

NOTE 4 - PLAN TERMINATION

Upon the termination of the Plan, per the agreement and declaration of Trust, any and all monies remaining in the Plan after payment of all expenses and obligations of the Plan shall be distributed among the participants.

NOTE 5 - ADMINISTRATION

The Plan is administered by BeneSys for \$11,299 per month effective November 1, 2022, increased to \$11,638 effective September 1, 2024. Participants are allocated a portion of administrative expenses based on their account balances. Milliman provides recordkeeping and daily valuation services for \$4.17 per month, per participant, effective January 2023.

NOTE 6 - HEDGED RESERVE - TIMBER OPERATORS, INC. - I.W.A. DEFINED BENEFIT PLAN

Included in the net assets available for benefits is a hedged reserve account funded with assets from the terminated Timber Operators Council, Inc. - I.W.A. Defined Benefit Plan ("DB Plan"). The reserve is available to fund pension benefits for former participants and beneficiaries of the terminated defined benefit plan who come out of the "woodwork" and establish a right to benefits. Excess assets in the account may be allocated, on an agreed upon formula approved by the Board of Trustees, to former participants or their specified beneficiaries of the defined benefit plan.

NOTE 7 - RELATED PARTY TRANSACTIONS

On January 1, 2018, the Plan entered into a contract with Vigilant Services, Inc. (“VSI”) for services of a VSI representative as an employer trustee and co-chair of the Board of Trustees of the Plan, representing those contributing employers not represented by any other trustee. The Plan agreed to pay \$2,500 per month.

NOTE 8 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at May 31, 2025 and 2024 and investment income for the years then ended that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the custodian of the Plan.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through March 9, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
