Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Scoular Company Retirement Savings Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended May 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agree to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of the Plan

The following description of The Scoular Company Retirement Savings Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering substantially all employees of The Scoular Company and its United States based subsidiaries (the Company) who have completed 30 days of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Contributions

Each year, participants may contribute up to 50% of their eligible compensation, as defined by the Plan. Participants have the option to make pre-tax and after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and their portion of the Company contributions into various investment options offered by the Plan, which may include a self-directed brokerage account limited to 50% of each participants total account balance. Contributions are subject to applicable Internal Revenue Code (IRC) limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a target date fund based on an anticipated retirement date until changed by the participant. Unless the participant affirmatively elects out, participants contributing less than 10% of eligible compensation on January 2nd and who have not changed their contribution rate in the preceding 6 months, will have their contribution rate automatically increased by 1% annually up to a maximum contribution rate of 10%. Automatic increases shall occur each February 1st. If a participant is making both pre-tax and after-tax Roth contributions, the automatic increase will be applied to the pre-tax contribution rate only.

B. Contributions – Continued

Each year, the Company is required to contribute a safe harbor amount equal to 3% of eligible compensation, as defined under the Plan, to each eligible participant. Additional discretionary matching or profit-sharing contributions may be made at the option of the Company's board of directors. During 2025, the Company made an additional discretionary match equal to the participant's deferral percentage up to 3% of eligible compensation. The Company can also make a discretionary profit-sharing contribution. Eligible participants for the profit-sharing contribution cannot be terminated on or before May 31, 2025 unless the participant is of retirement age or has terminated due to death or disability. In 2025, the Company did not make a discretionary profit-sharing contribution.

C. Participant Accounts

Each participant's account is credited with the participant's contribution, Company safe harbor and discretionary matching contributions, and allocations of a) Company discretionary profit-sharing contributions, if any, b) Plan earnings, and charged with an allocation of administrative expenses. Company discretionary profit-sharing contributions are allocated to participants employed on the last day of the Plan year based on the participant's compensation to the total of all Plan compensation. Plan earnings and administrative expenses are allocated to participants based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

D. Vesting

Participants are immediately 100% vested in their account balance, including Company safe harbor, discretionary matching and discretionary profit-sharing contributions, and investment earnings or losses thereon.

E. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, or 100% of the sum of the participant's pre-tax account, Roth account, and rollover account, whichever is less. Loan interest and principal repayments are credited directly to the borrower's account and are repaid in installments through payroll deductions. Loan terms range from one to ten years. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is 1% over the prime rate of interest charged by large United States money center commercial banks on the date the participant secures their loan.

F. Payment of Benefits

The payment of benefits can be made upon disability, termination of the Plan, death, termination of employment, financial hardship, childbirth or adoption. The participant or beneficiary may choose to receive either a lump-sum payment in cash equal to the value of the participant's account, or payment can be made under several installment options, as defined in the Plan agreement. Accounts less than \$5,000 are paid in a lump-sum distribution upon separation of service.

2. Summary of Significant Accounting Policies

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

B. Plan Administration and Expenses

The Plan provides for the appointment of an administrative committee by the Company who is responsible for the investment options and administration of the Plan. At May 31, 2025, those serving jointly on the administrative committee were Angie Gallagher, Andrew Kenny, Kelli Eickhoff, and Kari O'Neill Potts. Bank of America, N.A. serves as the trustee. The Plan's expenses are paid either by the Plan or the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included within the net appreciation in fair value of investments.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Estimates and Assumptions

The Plan administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”). Estimates and assumptions affect the reported amounts of assets, liabilities, net asset additions and deductions, and related disclosures. The most significant estimate in the accompanying statements is the valuation of investments at fair value by Bank of America, N.A. Because of the inherent uncertainties in this process, it is likely actual results, including the realization of fair value of the investments, will vary from the estimates.

E. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

F. Payment of Benefits

Benefits are recorded when paid.

G. Risks and Uncertainties

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for plan benefits.

H. Subsequent Period

Management evaluated transactions and events occurring subsequent to May 31, 2025, and through March 6, 2026 the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements – Continued

The measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at May 31, 2025 and 2024.

Common/Collective Trust Fund: Valued at the net asset value (NAV) of the common/collective trust (CCT). The NAV, as provided by the fund's trustee, Bank of America, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment adviser reserves the right to temporarily delay withdrawal from the trust to ensure securities liquidations will be carried out in an orderly business manner.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Valued at the daily closing price on the active market on which the underlying individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest Transactions

The Plan engages the services of Bank of America, N.A., whose responsibilities include investing assets, paying benefits to participants under the direction of the administrative committee, and performing the recordkeeping of the Plan. Some of the fees incurred by the Plan for the investment management services are included within net appreciation in fair value of investments.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

7. Tax Status

The Plan has adopted a pre-approved plan document sponsored by Merrill Lynch, Pierce, Fenner & Smith Inc. On June 30, 2020, the Internal Revenue Service stated the prototype document adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since the opinion letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified, and the related trust is tax-exempt. The Plan has not received a determination letter specific to the Plan.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the plan, and concluded that as of May 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
