## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hood & Strong LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Hood & Strong LLP 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established in 1984 by Hood & Strong LLP (the “Firm”) to provide benefits to eligible employees as defined in the Plan document. The plan administrator believes the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**B. Administration**

An Administrative Committee (the “Committee”) manages the operation and administration of the Plan. The Committee designated Fidelity Management Trust Company (“Fidelity”) to serve as trustee and to provide record keeping and administration services. Investment fund management fees and operating expenses are charged directly to the fund and thereby factored into each fund as a reduction of investment return. Other costs of administering the Plan are paid by the Firm. In cases where record keeping revenue received in connection with Plan services exceeds agree-upon compensation, Fidelity can allocate excess revenue amounts to accounts of eligible participants.

**C. Eligibility**

Substantially all employees of the Firm who have attained age 21 may enter the Plan. Participants become eligible for employee deferral, qualified non-elective and employer matching contributions on the first day of the month following their date of employment. Eligible participants are eligible for employer non-elective contributions on the first day of the Plan year or the first day of the fourth, seventh and tenth months of the Plan year following their date of employment.

**D. Contributions**

Participants may elect to make pre-tax contributions of up to 60% of eligible pre-tax compensation and/or Roth after-tax compensation as defined in the Plan. Participants who elect to have the Firm contribute a portion of their pre-tax compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants age 50 or older are permitted to make additional catch-up contributions as allowed under Code regulations. Participant contributions are subject to maximum annual additions permitted under provisions of the Code.

Newly hired eligible employees, except those who elect not to defer compensation to the Plan, are auto-enrolled at a pre-tax deferral rate of 3% of compensation on the first day of the next calendar quarter following their date of hire. The deferral percentage for auto-enrolled participants will automatically increase 1% annually in successive years to an annual maximum of 5% of eligible compensation.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s investment directions.

**D. Contributions (Continued)**

The Firm is allowed to make a discretionary matching contribution as defined in the Plan and as approved by the Committee. For the Plan year ended May 31, 2025 the Firm made a matching contribution to all eligible firm members employed on the last day of the Plan year equal to the lesser of 30% of pre-tax contributions or 3% of eligible compensation.

The Firm is allowed to make a discretionary non-elective contribution as defined in the Plan and as approved by the Committee. For the Plan year ended May 31, 2025 the Firm made non-elective contributions to all eligible firm members employed on the last day of the Plan year who have completed 1,000 hours of service.

**E. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Firm matching contributions, Firm discretionary non-elective contributions, an allocation of investment earnings or losses, and expenses. The majority of Plan assets are invested based solely on instructions received from participants. The contributions of participants who decline to make an investment election are invested in the Fidelity Freedom Fund appropriate for the individual's age and projected date of retirement.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their contributions and related earnings. A participant vests 25% annually in the portion of his or her account attributable to Firm matching contributions and attains full vesting after four years of service. A participant vests 20% annually in the portion of his or her account attributable to Firm non-elective contributions after two years of service and attains full vesting after six years of service. A participant hired prior to December 1, 2015, vests 25% annually and attains full vesting in his or her Firm non-elective contribution account after four years. Forfeitures of terminated participants' non-vested accounts are applied to reduce Firm contributions or to pay Plan administrative expenses. Available forfeitures of approximately \$55,000 and \$43,350 were applied to reduce the Firm's 2025 and 2024 matching and non-elective contributions, respectively. The balance of unapplied forfeitures was immaterial at May 31, 2025 and 2024.

**G. Payment of Benefits**

Normal retirement age under the Plan is age 60. Upon termination of service, death, disability or retirement, a participant or beneficiary may choose to maintain his or her account in the Plan or to receive benefits payable in a lump sum or installment payments. Hardship withdrawals are permitted under limited circumstances as provided in the Plan. The accounts of terminated participants valued at \$7,000, or less may be distributed by the plan administrator subject to applicable provisions of the Code. Benefits are recorded when paid.

**H. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years

unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. The plan administrator establishes the specific terms and conditions of participant loans. Notes receivable from participants at May 31, 2025 carry interest rates ranging from 3.25% to 9.50% with various maturities through May 2042.

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**I. Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**B. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**C. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - INCOME TAX STATUS**

The Firm adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Firm believes that the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by an affiliate of the trustee. Purchases and sales of shares of these funds are performed in the open market at fair value. Such transactions, as well as payments of direct and indirect administrative fees to Plan service providers, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at May 31, 2025 and 2024, net appreciation of investments, and interest and dividends for the year ended May 31, 2025 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at closing market prices for shares held by the Plan at year end. The following table sets forth Plan investments measured at fair value based on the inputs used to value them:

**NOTE 7 - FAIR VALUE OF INVESTMENTS THAT CALCULATE NET ASSET VALUE PER SHARE**

The Putnam Stable Value Fund is a common/collective trust for which fair value is measured using net asset value per share as a practical expedient. Its investment objective is to provide income while maintaining a stable net asset value primarily investing in guaranteed investment contracts issued by insurance companies and other financial institutions. Shares may be redeemed by Plan participants at any time at net asset value. The redemption notice period in the following table applies to Plan-level redemptions. The following table summarizes the Plan's investment in the fund.
