## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of Rogers Jewelry Company 401(k) and Profit Sharing Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Rogers Jewelry Company 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of May 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rogers Jewelry Company 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Voya Financial, as of May 31, 2025 and 2024, and for the year ended May 31, 2025, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTES TO FINANCIAL STATEMENTS

Year Ended May 31, 2025 and 2024

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Rogers Jewelry Company 401(k) and Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering all employees of the Company who have six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### CONTRIBUTIONS

The IRS limits the maximum amount that a participant can contribute as a salary deferral to the Plan. For 2025, the IRS limit is \$23,500. Participants who have attained the age 50 before the end of the Plan year are additionally eligible to contribute catch-up contributions. For 2025, the IRS annual catch-up limit is \$7,500.

Each year, the Company will contribute up to 75% of the participant elective contribution but not to exceed 3% of the participant compensation. On August 1, 2006, the Plan was amended to add an automatic deferral election to the Plan, which provides that the employer will automatically withhold 2% from each eligible employee's compensation and contribute that amount to the Plan on his or her behalf unless the employee elects a different percentage under his or her salary deferral agreement. In 2014, the plan was amended to provide automatic enrollment at 4%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of the Sponsor's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### VESTING

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

#### FORFEITED ACCOUNTS

At May 31, 2025, forfeited non-vested accounts totaled \$39,772. These accounts will be used to pay expenses of the Plan. In 2025, \$8,500 was paid from the forfeiture account to the Plan auditor for the May 31, 2024, audit fees.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, the participant is to receive an amount equal to the value of the participant's vested interest in his or her account.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions each pay period.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared using the accrual method of accounting.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Loans to participants are reported at their unpaid principal balances plus accrued but unpaid interest.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**PLAN EXPENSES**

Expenses of maintaining the Plan are paid by the Plan. The Plan paid \$40,577 in administrative expenses in 2025.

**INCOME RECOGNITION**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

INVESTMENT VALUATION

Investment contracts held by a defined contribution plan are reported at fair value (Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – FAIR VALUE MEASUREMENTS

The plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than the quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurement:* The fair value is based on quoted prices for identical assets in active markets that are held by the Plan at year end.

*Level 2 Fair Value Measurements:* The fair value is based on quoted prices of similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and inputs other than quoted prices that are observable for the asset.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended May 31, 2025, are reported in net appreciation or depreciation in fair value of investments.

The Plan’s policy is to recognize transfers between Level 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended May 31, 2025, transfers between Levels 1 and 2 occurred between mutual funds and collective investment trusts and there were no transfers into or out of Level 3.

**NOTE 4 – INVESTMENTS**

During the year 2025, the Plan’s investments (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$808,498.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 6 – TAX STATUS**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and although the Plan has been amended, the Plan sponsor believes that the Plan continues to qualify and to operate in compliance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.
