1 Description of the Plan

General

Boulay Retirement Plan and Trust (the "Plan") is a salary deferral 401(k) defined contribution, savings and profit-sharing plan which was established for employees of Boulay PLLP, Boulay Financial Advisors, LLC, and BFA Holdings, LLC (the "Company"). The Plan became effective January 1, 1984. The following is not a comprehensive description of the Plan and, therefore, does not include all provisions and limitations covered by the Plan. Participants should refer to the plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan operations

The Company is the plan sponsor and administrator of the Plan. The Custodian holds the plan investments in individual accounts, executes investment transactions, and collects and allocates the related investment activity based on participant elections. Fidelity Management Trust Company is the custodian of the plan.

Eligibility

Employees become eligible to participate in the Plan on the first day of employment.

Contributions

Participants may make salary deferral contributions of their compensation, subject to certain Internal Revenue Code (IRC) limits. Participants can elect pretax or Roth deferrals, or a combination of both. The Company may match a discretionary percentage of each participant's salary deferral contributions, but no such contributions were made in 2025. Profit sharing contributions are made under a cross-tested formula which provides separate contributions for employees, participating partners, and general partners. The amounts contributed under this formula in 2025 were 3% for employees, 6.78% for participating partners, and 9% for general partners. Employees and partners who are actively employed on the last day of the Plan year are eligible to share in the employer contributions. Participants may invest both their contributions and the employer contributions into over 50 different investment options maintained and held by the Custodian.

Participants may change their investment options at any time by logging in to a secure website. The changes are effective on the following day. Participants may change their deferral percentage at any time also.

Participant accounts

Each participant's account is credited with the participant's salary deferral contribution and allocations of the employer contributions and plan earnings. Allocations are based on participant compensation and participant investment elections balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting is generally based on the number of years for which an employee is credited with 1,000 hours or more of service subject, however, to certain other provisions of the Plan. A participant vests in employer contributions according to the following schedule:

3	100%

Employee salary deferral contributions are fully vested and non-forfeitable at all times.

Participant distributions

Participant distributions represent the amounts paid to withdrawing participants. Upon the participant's death, retirement or termination of employment, a participant may request either a lump-sum payment or benefits in the form of an annuity. In addition, a participant may obtain a hardship distribution as defined in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to either a common/collective trust (Stable Value Fund) or a variety of mutual funds maintained through Fidelity Management Trust Company. The investment options range from low risk income funds to high-risk international growth funds.

Forfeited Accounts

At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$74,760 and \$48,670, respectively. These forfeitures can be used to reduce future employer contributions to the Plan.

Administration

Certain members of the Company serve as Plan Trustees. Certain Plan expenses are absorbed by the Company at the Company's discretion.

2 Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Assets Available for Benefits in future periods.

Subsequent Events

The Plan has evaluated all subsequent events through **March 9, 2026**, which is the date the financial statements were available to be issued.

3 Information certified by the custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at May 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends for the year ended May 31, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the custodian of the Plan.

4 Tax status

The Plan's document provider has obtained an opinion letter in which the Internal Revenue Service stated that the plan as designed is in compliance with the applicable requirements of the Internal Revenue Code. The plan is relying on this opinion letter.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of May 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

5 Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6 Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
