Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Treetops Resort 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Responsibilities of Management

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Treetops Resort 401 (K) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a salary reduction plan, commonly referred to as a "401(K) Plan" and was adopted by Treetops Resort, Inc. (the Plan sponsor) effective January 1, 2018. The Plan benefits are available to all employees who meet eligibility requirements as defined in the Plan documents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In 2018, the participant account balances of current Plan participants who were previously part of the Vensure Employer Services pension plan were transferred into the Plan.

Contributions - Each year participants may elect to contribute a percentage of their compensation to the Plan however their maximum contribution may not exceed limits established by the Internal Revenue Code. Participants who were age 50 or older are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant.

A discretionary amount may be contributed at the option of the plan sponsor. No discretionary contributions were made in 2023.

Participant Accounts - Each participant's account is credited with the participant's elected salary reduction and an allocation of earnings or losses net of administrative expenses, and the sponsor's discretionary contribution, if any. Allocations of earnings or losses are based on the ratio that each participant account balance bears to the total account balances of all participants in the same investment.

NOTE A – DESCRIPTION OF PLAN - CONTINUED

Vesting - Participants are immediately vested in their contributions and actual earnings thereon. As far as discretionary sponsor contributions, if any, participants are 0% vested until they have more than 3 years of service after which they are fully vested. Participants also become 100% vested in the event of disability or death

Payment of Benefits - On termination of service due to death, disability or normal retirement, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of his or her account, or partial withdrawals or installments but only with respect to required minimum distributions. In service distributions of the fully vested portion of their accounts are available to participants at age 59 and a half. Upon termination vested amounts are payable and account balances of less than \$5,000 may be distributed as a lump sum payment. All benefits are recorded when paid.

Hardship withdrawals – Hardship withdrawals from the Plan are allowed.

Forfeited Accounts - Forfeitures can be used to reduce future sponsor contributions or pay Plan administrative expenses. There were no expenses paid with forfeitures during 2023 nor any unallocated forfeitures at December 31, 2023.

Administrative Expenses – Administrative expenses are paid both by the Plan sponsor and from participant accounts, depending on the type of expense.

Participant Loans – Under the terms of the Plan, participant loans are not allowed.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting -The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for a discussion of fair value and net asset value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES-CONTINUED

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures of Plan assets and liabilities. Accordingly, actual results may differ from these estimates.

Date of Managements Review of Subsequent Events - The Plan Trustees have evaluated events and transactions for potential recognition or disclosures through January 6, 2025, which is the same date these financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. From highest priority which is unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The Plan's investment assets at fair value, within the fair value hierarchy, as of December 31, 2023 and 2022 are as follows:

NOTE D – CERTIFICATION OF CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial N.A.(custodian of the Plan).

NOTE E - TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan adopted the Alerus Volume Submitter 401(k) prototype plan although the Plan has not obtained a favorable tax determination letter from the Internal Revenue Service, the Plan sponsor believes that the Plan is qualified and operating, as designed. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would be sustained upon examination by the IRS. The Plan had no uncertain tax positions at, December 31, 2023.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

The plan sponsor also provided certain accounting, administrative, and investment management services to the Plan for which no fees are charged. Alerus Financial, N.A. is the investment custodian as defined by the Plan and Chesme Capital Management is the investment advisor, and therefore they are a party-in-interest. Total fees for Alerus and Chesme Management for the year ended December 31, 2023, were \$16,122 and 2,456 respectively.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions
