### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

### 1. Description Of The Plan

The following description of Churchill Center and School for Learning Disabilities 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a 403(b) defined contribution plan established by Churchill Center and School for Learning Disabilities (the Employer) under Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

TIAA is the recordkeeper and issuer for the fixed and variable annuity contracts and pooled separate account. TIAA, FSB, a federal savings association, is the custodian for the registered investment companies. CREF is the issuer for the variable annuity accounts.

#### Participation

Substantially all employees of the Employer are immediately eligible to make deferral contributions upon hire. Participants are eligible to share in the Employer matching contributions upon completing one year of service.

#### Contributions

Participants are allowed to make pretax and Roth contributions. Participants are required to make mandatory contributions of 6% of their eligible compensation. Participants may elect to make additional contributions above 6% at their discretion. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who attain age 50 during the Plan year, may elect to make catch-up contributions. Participants who completed 15 years of service with a qualified organization may also make special catch-up contributions, as defined in the Plan Document. Participants may also make contributions representing distributions from other qualified plans (rollover).

The Employer is required to make matching contributions of 100% of participant mandatory deferral contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Employer matching contributions and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Notes Receivable From Participants**

A participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's vested account balance and bear interest at a reasonable rate of interest. Loans are for a period not to exceed five years, or not to exceed a reasonable time for the purchase of a primary residence. Loans are repaid, including principal and interest, outside of the payroll process.

#### **Vesting**

All contributions and earnings thereon are fully vested and nonforfeitable at all times.

#### **Investment Options**

Upon enrollment in the Plan, participants may direct their contributions and Employer contributions in a variety of investment options.

#### **Payment Of Benefits**

Participant's account and earnings thereon are distributed upon retirement, death, disability, or other termination of employment. Benefit payments in excess of \$1,000 may be distributed as a lump-sum, partial payments, purchase of annuity contracts, or a series of equal payments over a period of time until fully distributed.

#### **In-Service Withdrawals**

Active participants who reach age 59-½ may withdraw all or part of their account resulting from elective deferral contributions. Participants who experience a qualifying financial hardship may withdraw all or part of their vested account resulting from all contributions. Hardship withdrawals will be approved only if they conform to the Plan provisions and established IRS safe harbors.

**Administrative Expenses**

The Employer pays significant administrative expenses of the Plan. Each participant will pay certain administrative expenses based on the percentage of assets held in their investment accounts. The expenses are netted against earnings and are included in investment income on the statement of changes in net assets available for benefits.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

Investments, other than fully benefit-responsive investment contracts, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in certain TIAA Traditional Annuity Accounts and the TIAA Stable Value Fund are fully benefit-responsive investment contracts and are reported at contract value in the statement of net assets available for benefits.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized gains (losses) and unrealized appreciation (depreciation).

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Investment Information**

The following is a summary of the Plan's asset information as of May 31, 2025 and 2024, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by TIAA and CREF, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from TIAA and CREF that the information provided to the Plan Administrator related to the following information is complete and accurate.

#### 4. Fair Value Measurements

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Guaranteed Investment Contracts**

Valued at fair value by TIAA by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

**Pooled Separate Account**

Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by TIAA, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

**Variable Annuity Contracts**

All accounts are valued at NAV based on the value of the underlying assets. The NAV, as provided by TIAA, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

**Variable Annuity Accounts**

Valued at the daily closing price as reported by CREF. The accounts held by the Plan publish their daily NAV, transact at that price and are deemed to be actively traded.

**Registered Investment Companies**

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**TIAA Traditional Annuity Accounts**

The TIAA Traditional Annuity Accounts (the Accounts) are fully benefit responsive, fixed-dollar annuities offered by TIAA, an insurance company. The Accounts are maintained in the TIAA general account. Contributions to the Accounts purchase contractual or guaranteed amounts of future benefits for the participants and are secured by the general assets of TIAA. The Accounts are reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers, if any, less any withdrawals and transfers, if any.

The Accounts provide a guarantee of principal, a guaranteed minimum interest rate between 1% and 3% and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year”, which begins each March 1. Additional interest is not guaranteed for future years. The crediting rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liquidity.

**TIAA Stable Value Fund**

TIAA Stable Value Fund (the Fund) is a fully benefit-responsive investment contract offered through TIAA. Contributions are deposited into a non-unitized separate account. The contract provides a guaranteed minimum rate of interest of between 1% and 3%. Although the liability to provide contract guarantees and accumulations is backed by the assets in the separate account, any amount to be credited above the minimum guaranteed rate is determined by TIAA. Contract holders and Plan participants do not participate in, and do not receive the earnings of, the assets in the separate account.

Declared crediting rates are reviewed and may be reset every six months (on January 1 and July 1). The Fund is reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any.

Management has the ability to terminate the Plan's interest in the Fund at any time. Upon termination, the Plan will receive contract value in, at most, two years. If the two-year payout applies, a discontinuance fee will be assessed, which has the effect of reducing the interest credited during the two-year period by, at most, seventy-five basis points.

**6. Income Tax Status**

The Plan adopted the TIAA volume submitter 403(b) plan, for which a favorable opinion letter was issued to TIAA by the IRS dated August 7, 2017. The Plan itself has not received a determination letter. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time subject to the provisions of ERISA. Participants will remain 100% vested in their accounts.

**8. Party In Interest Transactions**

Certain Plan investments are issued and managed by TIAA and CREF. In addition, certain participants have outstanding loans as of May 31, 2025 and 2024. These transactions qualify as allowable party in interest transactions.

**9. Risks And Uncertainties**

The Plan invests in various investment securities, which in general are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
